DV homicides often claim the lives of children and family members as well (Everytown Research & Policy, 2023). As of August 17, 2024, there have been 57 DV homicides in NC. Over 75% of these homicides involved a firearm (NCCADV, 2024).</p> <p>Proper implementation of DV firearm protections saves lives. A 2018 study found a 13% reduction in DV gun homicide in states like NC that restrict firearm possession by people with active DVPOs (Zeoli et al. 2018). Repeal of the pistol-permitting system means that background checks that would have flagged a DVPO or disqualifying criminal history are no longer required for private sales in NC and creates a means for DV offenders to keep and purchase new firearms that can be used against their partner.</p>

Historically, victim service models have emphasized outreach/intervention services tailored for women that are female-centric. While women do make up the largest reported percentage of victims of trauma, according to the CDC, 1 in 7 men age 18+ in the US have been the victim of severe physical violence by an intimate partner in their lifetime, while 1 in 10 men have experienced rape, physical violence, and/or stalking by an intimate partner. REACH's current statistics show that males make up approximately 10% of the overall number of victims seeking our services; we know based on national statistics that the number of male victims in our community is higher; our job is to eliminate the barriers that prevent those victims from seeking services. This project would work to do just that by eliminating barriers for male victims through outreach, training, and intervention. The projects intersectional framework would address societal norms that contribute to misinformation and stereotypes, provide training for system providers who intersect with male victims, would be gender inclusive, and would provide specialized outreach that is relevant to meeting men where they are.

Children identified as victims of maltreatment with trauma symptoms, and mental health treatment by highly specialized therapists will be the #next step# to begin the healing process. Children need trauma-focused mental health interventions to address complex sequelae of symptoms caused from thoughts and behaviors that commonly occur when children have been sexually abused. The vast majority of rural counties within our catchment area do not have therapists with expertise in trauma models to effectively treat abused children, their non-offending caregivers, and family members. In addition, caregivers need a high degree of support, psycho-education, and advocacy to ensure children complete their complete course of trauma treatment which often requires six to eight months of weekly sessions. Without intervention and treatment, these children often become adult victims of domestic violence, perpetuating the cycle. This project's primary purpose is to help child victims/witnesses and non-offending caregivers heal from trauma, and to end the inter-generational cycle of violence and abuse by employing evidence-based, trauma-informed therapeutic best practices (PCIT and TF-CBT). The Ashe CAC will allow families to receive services in a convenient location that will result in more families receiving the services they need. Work has already been done to speed the opening of the new CAC. A rent-free building has been identified to house the CAC. This will save the program over \$20,000 per year. Given the prevalence of other languages and cultures in our community, along with the growing LatinX population, Safe Alliance is dedicated to making its services known and accessible. Accessibility policies are currently embedded within each program. We offer interpretation services, provide all printed forms in Spanish, have audio versions of our website available in 6 languages, and staff 8 bilingual positions across the agency. We plan to expand these policies through our Language Access Plan. We will continue hiring bilingual staff (primarily Spanish-speaking) in direct service roles to work with LEP clients and expand outreach efforts in immigrant/LatinX communities. Victims experience many barriers to accessing services, and may not know all the options available. The Family Justice Center model was created to address these issues. The core of the model is strengthening communication and collaboration to improve the victim experience. This model allows for a coordinated response between a multi-disciplinary system in order to identify gaps, avoid duplication, and focus on new initiatives to meet the needs of the community. Project funds will be used to offer services that increases access, safety, and build resiliency. NC has a population of 68,000 women veterans and is ranked 6th in the nation for population. Since the 2019 GEMS award, WVSS has provided program services to more than 150 active-duty and veteran clients. These services included: Crisis Intervention/Transportation, Emergency Selter, and appropriate referrals. Although strides are being made, there is an urgency for identifying those veteran female victims that require safety and making them aware that WVSS can help in crisis. There is a concern that too many of these victims fall through the cracks by not having access to the right resources to have their unique needs addressed; that often bring a history of military abuse. As widespread as the media coverage is, knowledge of our underserved population remains at less than 1% and 0.5 % of agencies surveyed by our Coalitions in NC. It is imperative that WVSS continue its presence among the various organizations and agencies in NC. Since this time, Southmountain Children and Family Services has opened, and now operates 11 CACs across North Carolina. Due to the reduction in VOCA funds, many critical services provided at 6 of our CACs will be lost. Further, due to Covid-19, we have reduced opportunities for fund-raising to support CAC operations. Mental Health Therapists, Medical Providers, and Family Advocates are all extremely critical to the operation of the CACs. Mental health services are desperately needed. Children who suffered from abuse often experience mental health disorders and life altering symptoms related to the abuse. During the 2020-2021 year, at the 6 CACs, a total of 1177 child victims of crime were served, an average of 196 at each CAC. Mental Health Therapists provided 2892 individual therapy sessions, an average of 482 sessions annually at each CAC. Without these funds, these families will be denied the mental health services they desperately need. The Family Advocates are also critical staff at the 6 CACs. Our Family Advocates provided 5690 advocacy services across the 6 CACs during 2020-2021. This is an average of 948 services provided annually at each CAC. These services include support to families through the investigation and

Short term therapy will focus on increased coping skills for improved daily functioning. Longer term therapy will address serious problems often manifested after unresolved sexual trauma, such as PTSD. All therapy will utilize evidence-based modalities such as Cognitive Behavioral Therapy and Eye Movement Desensitization Reprocessing (EMDR). Barriers to successful treatment will also be addressed by offering transportation assistance, telehealth/virtual sessions, and scheduling appointments outside of normal business hours when necessary. To demonstrate the positive impact of these services, throughout the last two years, over 90% of clients receiving therapy at the RCC experienced a significant decrease in PTSD symptoms and 100% indicated that they were satisfied with the services they received. Currently, Friend to Friend offers victims free core crisis intervention services, such as: a 24/7-crisis-line, 34 bed emergency shelter as well as a three bedroom, high-trauma shelter, court advocacy, case management, client outreach services, information and referral to evidence-based mental health services, medical accompaniment, ER advocacy, and language and translation services. We are centrally located near downtown Asheville and provide a confidential and welcoming space at our Counseling Center. Our services are available to all residents of the western counties of North Carolina. We currently operate from a hybrid model and our Therapists are providing counseling sessions both in person and via telehealth platforms as needed or preferred by clients. General benefits of mental health counseling include improved relationships, better overall health, and job retention. Accessible counseling can also prevent mental health issues from turning into a crisis, thereby reducing utilization of more costly services such as mobile crisis, emergency department visits, and inpatient care. According to a 2019 memorandum by the US Department of Health and Human Services, being victimized by an intimate partner increases a person's risk for depression, PTSD, substance use disorders, eating disorders, and suicidality. The surveys/focus group results will be institutionalized in our strategic plan and in the design for our next emergency shelter, for which land has been purchased and planning is underway. Shelter expansion is critical since we can currently meet less than half the demand. 41% of survivors sheltered are people of color (compared to 11% of the county population). Since our shelter serves survivors with the highest homicide risks and lowest resources, people of color are overrepresented due to disparities in our community related to victimization rates, poverty, health and housing. Helpmate invests in recruiting, training and retaining staff members adept at helping survivors navigate systemic issues. Based on strong feedback from survivors, we intend to hire a counselor who is African American. A recent counseling intern who was African American was regularly personally requested and served 50% more Black survivors than any of our other 3 counselors. We will provide specialized services that are multilingual and culturally informed. We have English-Spanish bilingual staff in each of our service settings (shelter, Famil

In Watauga, prior to the pandemic, OASIS has partnered with the County administration to create a #den# within the courthouse that would be available for use by community partners in support of survivors attending court. Over the past two years, OASIS has partnered with the Clerk of Court, Judges, Magistrates and District Attorney#s office for remote hearings for domestic violence protective orders and the implementation e-Filing of applications. OASIS will continue to build on relationships in each court house to foster support for clients as they navigate the judicial system. Partnering with children and youth serving agencies in Avery and Watauga counties- Children#s Council of Watauga County, Inc., Blue Ridge Partnership for Children and WAMY Community Action, OASIS can provide specialized support for families in the shelter and transitional housing program. Partner agencies will provide individualized education and support for clients to increase knowledge about the impact of domestic violence on children and protective factors for children, such as nurturing and attachment, parental resilience, and social connections for both parents and children. Kiran#s vision is to bring a change in the way South Asian Community views and responds to domestic and sexual violence. Kiran#s values lie in understanding diversity, violence prevention, empowerment, promoting healthy and non-violent relationships, commitment to social change, professionalism and equity. There are approximately 97 DV agencies and shelters located throughout NC. Though there are main stream Domestic violence and Sexual Assault agencies in every county, they are often not equipped to provide culturally specific services. Although domestic violence and sexual assault occurs in all societies, the added layers of cultural barriers make it even harder for the South Asian clients to feel heard and understood.
