COMMENTS: State Forest Addition. Property proposed for acquisition abuts DuPont State Forest and is a habitat of the state endangered green salamander. This site includes and will provide protection for fifty five acres of the Stone Mountain/Rocky Ridge Significant Natural Heritage Area. Funding provided by the Natural Heritage Trust Fund (\$186,800) and a private donation (\$186,800).

GRANTOR: Capital Facilities Foundation, Inc.

GRANTEE: State of NC, University of North Carolina at Greensboro

LOCATION: 1116 West Lee Street, Greensboro, Guilford County

AREA: $\pm 26,136$ sq. ft. or ± 0.60 acre improved with a building containing $\pm 12,916$ sq. ft.

constructed in 1925

UNIT COST: \$8.50 sq. ft. – land

\$6.04 sq. ft. – improvements

CONSIDERATION: \$300,000

COMMENTS: Campus Expansion. Property proposed for acquisition is adjacent to existing State owned land along W. Lee Street. In accordance with the master plan, the university plans to construct a tunnel from W. Lee Street to their main campus as part of the Central Gateway Corridor. The Central Gateway Corridor is a new Student Housing Mixed-Use Village being developed by the University's Capital Facilities Foundation on the south side of W. Lee Street. Acquisition of this site will accommodate construction of the tunnel which will provide safe access for students. The improvements will be severed by the Department of Administration, State Surplus Property. Funding provided by Campus Trust Funds from Auxiliary Enterprises.

GRANTOR: Thomas L. Osteen and Haywood L. Brown

GRANTEE: State of NC, University of North Carolina School of the Arts

LOCATION: 1800 Chapel Street, Winston-Salem, Forsyth County

AREA: $\pm 17,859.6$ sq. ft. or ± 0.41 acre improved with a $\pm 1,136$ sq. ft. frame house and a 459 sq.

ft. guest house/storage building, built in 1910

UNIT COST: \$2.80 sq. ft. - land

\$34.48 sq. ft. – improvements

CONSIDERATION: \$105,000

COMMENTS: Campus Expansion. Property proposed for acquisition is contiguous to campus and is needed for expansion in accordance with the master plan. The site will be utilized for future expansion including a new residence hall. The improvements will be severed by the Department of Administration, State Surplus Property. Funding for this acquisition will be provided by General Housing Funds.

ITEM 6

Land Exchange. The Department of Transportation (DOT) requests approval of a land exchange between the State and the City of Raleigh (City). The DOT is planning to construct a new office building on the northern portion of the DOT's Poole Road complex currently accessible through Winslow Ridge Drive on the west. The State proposes to convey to the City a 0.7307 acre parcel (tax value \$40,104) adjacent to the City's future Sunnybrook Neighborhood Park. In exchange, the City will convey a 0.7307 acre parcel (tax value \$64,295) to the State which will allow the DOT to build a drive connecting State owned property to Sungate Boulevard on the north.
