Pursuant to N.C.G.S. 143B-602(7), prior to any notification of proposed grant awards to state agencies for use in pursuing the objectives of the Governor's Crime Commission outlined in this section, the Secretary shall report to the Senate and House of Representatives Appropriations Committees for review of the proposed grant awards.
