RE: Assaults on Detention Personnel

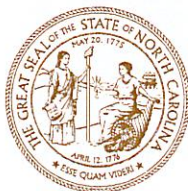
DATE: March 25, 2026

Pursuant to N.C.G.S. 14-258.7, the Department of Adult Correction shall report the following to the chairs of the Joint Legislative Oversight Committee on Justice and Public Safety each year:

- (1) The number of incidents of any violation of this Article, G.S. 14-34.5(b), 14-34.7(b), or 14-34.7(c)(2) involving an employee or contractor of a detention facility operated by the State.
- (2) The nature of the resolution of every incident of any violation of this Article, G.S. 14-34.5(b), 14-34.7(b), or 14-34.7(c)(2) involving an employee or contractor of a detention facility operated by the State.

During calendar year 2025, there were no violations of G.S. 14-34.5(b) and no violations of 14-34.7(b) involving an employee or contractor working in a detention facility operated by the state. There were 232 violations of G.S. 14-34.7(c)(2). Out of the 232 violations, 7 offenders were convicted, while 20 charges are still pending. The Department of Adult Corrections continues to monitor these incidents and to take appropriate action to ensure the utmost safety of our employees, individuals in our custody, and all who enter our facilities.
