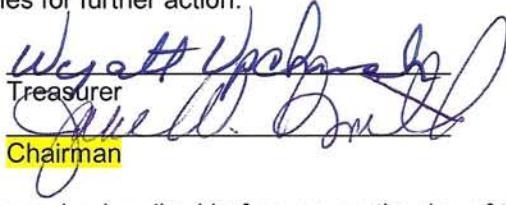

§ 158-8.3. Creation of Southeastern North Carolina Regional Economic Development Commission.

(a) There is created the Southeastern North Carolina Regional Economic Development Commission to serve Bladen, Brunswick, Columbus, Cumberland, Hoke, New Hanover, Pender, Richmond, Robeson, Sampson, and Scotland Counties, and any other county assigned to the Commission by the Department of Commerce as authorized by law. The Commission shall be located administratively in the Department of Commerce but shall exercise its statutory powers and duties independently of the Department of Commerce. Funds appropriated for the Commission by the General Assembly shall be disbursed directly to the Commission at the beginning of each fiscal year.

- (b) The Commission shall consist of 15 members appointed as follows:
- (1) Three members shall be appointed by the Governor;
 - (2) Two members shall be appointed by the Lieutenant Governor;
 - (3) Five members shall be appointed by the General Assembly upon the recommendation of the Speaker of the House of Representatives in accordance with G.S. 120-121; and
 - (4) Five members shall be appointed by the General Assembly upon the recommendation of the President Pro Tempore of the Senate in accordance with G.S. 120-121.

(c) The appointing authority shall designate two of the initial appointees pursuant to subdivision (b)(1) of this section, one of the initial appointees pursuant to subdivision (b)(2) of this section, two of the initial appointees pursuant to subdivision (b)(3) of this section, and two of the initial appointees pursuant to subdivision (b)(4) of this section to serve for terms ending June 30, 1995; the remainder of the initial appointees shall serve for terms ending June 30, 1997. Their successors shall serve for four-year terms ending on June 30 quadrennially thereafter.

Any appointment to fill a vacancy on the Commission shall be for the balance of the unexpired term. Vacancies in appointments made by the General Assembly shall be filled in accordance with G.S. 120-122.

(c1) The initial meeting shall be called by the Secretary of the Department of Commerce.

(d) Members of the Commission who are State employees shall receive travel expenses as provided in G.S. 138-6. Other Commission members shall receive per diem of one hundred dollars (\$100.00) a day for each day of service when the Commission meets and shall be reimbursed for travel and subsistence as provided in G.S. 138-5. The Commission may adopt policies authorizing additional per diem of one hundred dollars (\$100.00) a day for non-State employee members' additional days of service including Commission subcommittee meetings or other Commission activities, plus reimbursement for related travel and subsistence as provided in G.S. 138-5.

(e) In addition to the powers and duties granted to economic development commissions in this Article, the Southeastern North Carolina Regional Economic Development Commission shall:

- (1) Survey southeastern North Carolina and determine the assets, liabilities, and resources that the region contributes to the economic development process;
- (2) Develop and evaluate alternatives for southeastern North Carolina economic development;
- (3) Develop a preferred economic development plan for the region and establish strategies for implementing the plan; and
- (4) Coordinate activities with and enter into contracts with any nonprofit corporation created to assist the Commission in carrying out its powers and duties.
- (5) Repealed by Session Laws 1999-237, s. 16.5(c).

- \$45,000 was expended for industry project commitments that materialized.

The Budget for FY 2010-2011 is \$1,038,022. The revenues consists of \$623,842 from the North Carolina General Assembly, \$66,931 from the Southeastern Partnership, Inc. for administrative purposes to offset budget cuts, and a fund balance appropriation of \$197,115. The 2010-2011 Marketing Plan will continue to focus on specific targeting industries and targeted geographic areas. We will remain focused on pursuing opportunities that will put us face-to-face with prospective clients, consultants, and real-estate professionals. Our website will continue to be a vital marketing tool, and we will continue to serve as the advocate for economic development in the region and in the State of North Carolina.

North Carolina's Southeast acknowledges and accepts both the need for and the benefits and advantages of the strategic alignment contemplated by Subsection (3). And, like our sister economic development partnerships throughout the state, we work hard at it.

This goal is continuously achieved and ensured through the programs and activities of the North Carolina Partnership for Economic Development. NCPED is a nonprofit 501 (c) (3) consortium Consisting of the North Carolina Department of Commerce (NCDOC) and all seven regional economic development partnerships. Operationally, NCPED functions as an information-sharing and best practices clearinghouse for economic development professionals and private sector volunteers throughout the state.

NCPED's guiding principle is “statewide consistency; regional flexibility,” an approach that permits each region to market and promote its own local and unique business assets and advantages, but also ensures that North Carolina's powerful, consistent, and compelling economic development message is communicated and reinforced throughout the United States and around the world. While the primary and legislatively-mandated function and responsibility of each regional partnership is to develop and execute a regional marketing plan and program of work that fits that particular region's needs, when it comes to marketing the State of North Carolina itself, the seven regions without hesitation look to and depend upon NCDOC for leadership and direction.

- The Chairman of a partnership is elected as chairman of NCPED
- Presidents meet monthly with NCDOC representatives
- Regional partnership Chairs meet quarterly, with NCDOC Secretary and senior staff
- Research and IT officers meet frequently; the EDIS project is an on-going example of collaboration and cooperation
- Marketing Council meets bi-monthly

With these systems and procedures in place, it was easy for the seven regional partnerships to align their marketing and economic development strategies to NCDOC's Economic Development Marketing Plan. North Carolina's Southeast is an active participant in the collaboration, planning, and execution of the following activities that coincide with the NCDOC's marketing efforts that are applicable to southeastern North Carolina.

I. Work-Product Development

- a. Continued to work jointly with the Friends of NC Marketing Council and Dept. of Commerce Marketing in industry sectors in which we overlap.
- b. **Warehouse/Distribution** – NCSE worked collaboratively with the Dept. of Commerce and the NC Ports to recruit warehouse/distribution industries – this included joint participation in developing marketing materials, attending trade shows, and conducting client handling;

Agri-Business – NCSE worked collaboratively with the Dept. of Commerce and the Department of Agriculture to recruit food processing industries – this included joint participation in developing marketing materials, attending trade shows, and conducting client handling;

Building Products – NCSE worked with the Dept. of Commerce and other organizations to advance this industry sector. North Carolina's Southeast and the Dept. of Commerce jointly worked to identify potential buildings and sites that would meet the location requirements of this sector.

- c. **Client/Project Handling** – North Carolina's Southeast has an excellent relationship with the Dept. of Commerce. Client/Project Handling procedure is as follows: once we have a client that would like to visit Southeastern North Carolina, we contact the North Carolina Department of Commerce Regional Representative and he coordinates the visit with the client. The North Carolina Department of Commerce Regional Representative handled all the clients (1 generated) that located in the region during FY 2010-2011. Management's Discussion and Analysis

As management of the Southeastern North Carolina Regional Economic Development Commission, we offer readers of the Commission's statements this narrative overview and analysis of the Commission's financial performance during the fiscal year ended June 30, 2011. Please read in conjunction with the Commission's financial statements, which follow this section.

Financial Highlights

- The Commission's marketing initiatives identified more than 116 new leads for our region, and 95 prospects who are considering the region for a project.
- There were 48 client visits to the region, resulting in one announcement creating 342 jobs.
- Contribution commitments received totaled \$52,500.

Overview of the Financial Statements

The audited financial statements of the Commission consist of the following:

- Management's Discussion and Analysis
- Independent Auditor's Report
- Basic Financial Statements
- Notes to Financial Statements

Required Financial Statements

The basic financial statements of the Commission report information of the Commission using accounting methods similar to those used by private sector companies. These statements offer short- and long-term financial information about its activities. The statement of net assets includes all of the Commission's assets and liabilities and provides information about the nature and amounts of investments in resources (assets) and the obligations to Commission creditors (liabilities). It also provides the basis for evaluating the capital structure of the Commission and assessing the liquidity and financial flexibility of the Commission.

All of the current year's revenues and expenses are accounted for in the statement of revenues, expenses, and changes in fund net assets. This statement measures the success of the Commission's operations over the past year and can be used to determine whether the Commission has successfully recovered all of its costs through its public and private support, profitability and credit worthiness.

The final required financial statement is the statement of cash flows. The statement reports cash receipts, cash payments, and net changes in cash resulting from operations, investing, and financing activities and provides answers to such questions as where did cash come from, what was cash used for, and what was the change in the cash balance during the reporting period.

Management's Discussion and Analysis (continued)

Financial Analysis of the Commission

One of the most important questions asked about the Commission's finances is "Is the Commission as a whole better off or worse off as a result of this year's activities?" The statement of net assets and the statement of revenues, expenses, and changes in fund net assets report information about the Commission's activities in a way that will help answer this question. These two statements report the net assets of the Commission and the changes in them. One can think of the Commission's net assets – the difference between assets and liabilities – as one way to measure financial health or financial position. Over time, increases or decreases in the Commission's net assets are one indicator of whether its financial health is improving or deteriorating. However, one will need to consider other non-financial factors such as changes in economic conditions and new or changed government legislation.

Net Assets

To begin our analysis, a summary of the Commission's statement of net assets is presented.

Note that net assets decreased during the year. This decrease represents the degree to which the Commission expanded its initiatives to promote industry growth in the local region.

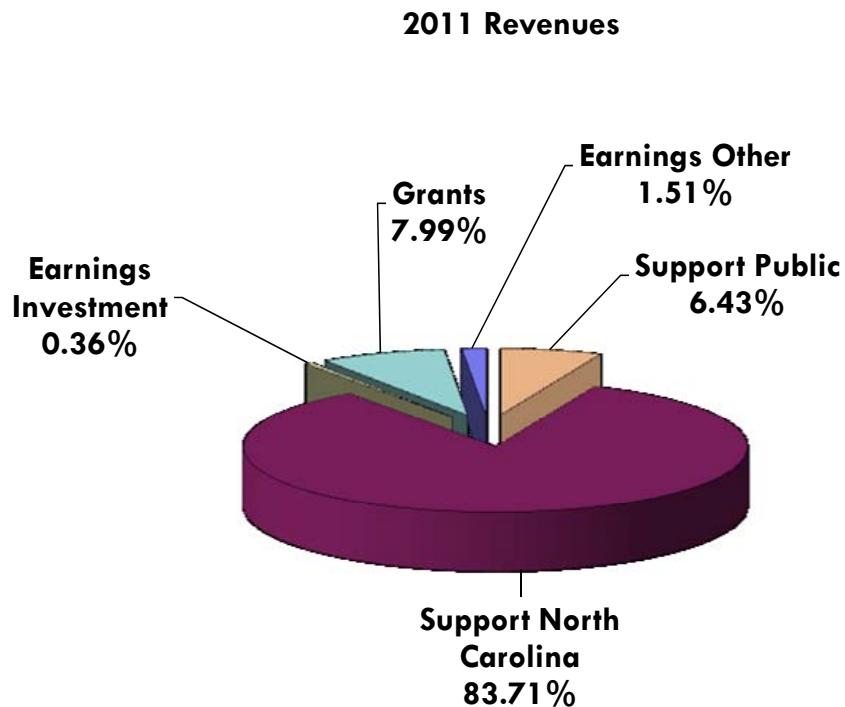

While the statement of net assets shows the change in financial position of net assets, the statement of revenues, expenses, and changes in fund net assets provides answers as to the nature and source of these changes. As seen above, a change in net assets of \$87,230 was the source of the decrease in net assets in 2011.

The Commission's operating revenues increased by \$36,794 to \$813,909 in 2011 largely due to increases in grant revenue. Operating expenses increased by \$169,253.

Due to the deterioration of the local economy, higher unemployment rates, and an increase in industry closings, the Board anticipates an increase in private support to help support the mission of attracting industry to the local region. However, due to the budget shortfalls of the North Carolina General Assembly the Board anticipates a decrease in support from the State of North Carolina.

I. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Organization and Purpose

The Southeastern North Carolina Regional Economic Development Commission is a legally separate nonprofit organization created by North Carolina General Statute 158-8.3. The Southeastern North Carolina Regional Economic Development Commission was created to serve Bladen, Brunswick, Columbus, Cumberland, Hoke, New Hanover, Pender, Richmond, Robeson, Sampson, and Scotland Counties. The North Carolina General Assembly may amend the Commission, from time to time, with the addition or deletion of counties. It is the mission of the Commission to expand economic opportunities, reduce unemployment and underemployment, and improve the quality of life for citizens of the region that is served by the Commission.

B. Financial Reporting Entity

The Southeastern North Carolina Regional Economic Development Commission is an integral part of the State's reporting entity and is included as a component unit in the State of North Carolina's *Comprehensive Annual Financial Report* (CAFR).

Component units are legally separate entities for which the State and/or Commission is financially accountable. Accountability is defined as the State's and/or Commission's substantive appointment of a majority of the component unit's governing board. Furthermore, to be financially accountable, the State and/or Commission must be able to impose its will upon the component units or there must be a possibility that the component unit may provide specific benefits to, or impose specific financial burdens on, the State and/or Commission. Financial accountability also exists when an organization is fiscally dependent upon the State and/or Commission.

As required by General Statute 158-8.3, the Commission shall consist of fifteen members. Three members shall be appointed by the Governor, two members by the Lieutenant Governor, five members by the General Assembly upon the recommendation of the Speaker of the House of Representatives and five members by the General Assembly upon the recommendation of the President Pro Tempore of the Senate. The State provides significant operating revenues to the Southeastern North Carolina Regional Economic Development Commission creating a benefit/burden relationship. Because of the State's appointment of the board and the benefit/burden relationship, the Southeastern North Carolina Regional Economic Development Commission is a component unit of the State of North Carolina and the Southeastern North Carolina Regional Economic Development Commission's financial statements are included in the State's CAFR.

The accompanying financial statements present the Commission and its component units, entities for which the Commission is considered to be financially accountable. Blended component units, although legally separate entities, are, in substance, part of the Commission's operations.

1. Blended Component Units

a. The Southeastern Partnership, Inc.

The Southeastern Partnership, Inc. is a legally separate non-profit organization created on December 9, 1994, to assist the Southeastern North Carolina Regional Economic Development Commission in carrying out its powers and duties. A seven member Board comprised of Commissioners of Southeastern North Carolina Regional Economic Development Commission governs the Partnership. Three members are the current officers of the Commission, two members are appointed by the Chairman of the Commission, and two members are elected by the Commission. The Commission can significantly influence the programs, projects, activities, and level of services of the Partnership. In addition, The Southeastern Partnership, Inc.'s services directly and indirectly benefit the Southeastern North Carolina Regional Economic Development Commission creating a benefit/burden relationship. Because of the Commission's appointment/influence of the board and the benefit/burden relationship, The Southeastern Partnership, Inc. is a blended component unit of the Southeastern North Carolina Regional Economic Development Commission and is reported as an enterprise fund.

b. The Southeastern Partnership II, Inc.

The Southeastern Partnership II, Inc. is a legally separate non-profit organization created on May 23, 1996, to assist the Southeastern North Carolina Regional Economic Development Commission in carrying out its powers and duties. A seven member Board comprised of Commissioners of Southeastern North Carolina Regional Economic Development Commission governs the Partnership. Three members are the current officers of the Commission, two members are appointed by the Chairman of the Commission, and two members are elected by the Commission. The Commission can significantly influence the programs, projects, activities, and level of services of the Partnership. In addition, The Southeastern Partnership II, Inc.'s services directly and indirectly benefit the Southeastern North Carolina Regional Economic Development Commission creating a benefit/burden relationship. Because of the Commission's appointment/influence of the board and the benefit/burden relationship, The Southeastern Partnership II, Inc. is a blended component unit of the Southeastern North Carolina Regional Economic Development Commission and is reported as an enterprise fund.

C. Basis of Presentation

The accompanying financial statements of Southeastern North Carolina Regional Economic Development Commission financial reporting entity have been prepared in conformity with generally accepted accounting principles in the United States of America ("GAAP"), as prescribed by the Governmental Accounting Standards Board (GASB), which consist of GASB Statements and Interpretations, as well as American Institute of Certified Public Accountants (AICPA) and Financial Accounting Standards Board (FASB) pronouncements specifically made applicable to state and local governmental entities by GASB Statements and Interpretations. The Governmental Accounting Standards Board (GASB) establishes standards of financial accounting and reporting for state and local governments. The Partnership also applies Statements and Interpretations of the Financial Accounting Standards Board (FASB) issued on or before November 30, 1989, Accounting Principles Board Opinions, and Accounting Research Bulletins, unless those pronouncements conflict with or contradict GASB pronouncements.

D. Major Enterprise Funds

Major individual enterprise funds are reported as separate columns in the financial statements. The Commission reports the following major proprietary funds:

The *Southeastern North Carolina Regional Economic Development Commission* is the Commission's operating fund.

The *Southeastern Partnership* accounts for the activities of The Southeastern Partnership, Inc., a blended component unit of the Commission.

The *Southeastern Partnership II* accounts for the activities of The Southeastern Partnership II, Inc., a blended component unit of the Commission.

E. Basis of Accounting

The accompanying financial statements of Southeastern North Carolina Regional Economic Development Commission have been prepared on the accrual basis of accounting.

F. Capital Assets

Capital assets, which include property, plant, and equipment, are reported in the business-type activities columns in the financial statements. Capital assets are defined by the Commission as assets with an initial, individual cost of more than \$5,000 and an estimated useful life in excess of two years. Such assets are recorded at historical cost.

The costs of normal maintenance and repairs that do not add to the value of the asset or materially extend assets lives are not capitalized.

Property, plant, and equipment of the Commission, as well as the component units, are depreciated using the straight line method over the following estimated useful lives:

G. Cash and Cash Equivalents

For purposes of the statement of cash flows, Southeastern North Carolina Regional Economic Development Commission considers all highly liquid investments with a maturity of three months or less when purchased to be cash equivalents.

H. Public and Private Support

Southeastern North Carolina Regional Economic Development Commission's primary sources of funding are from the State of North Carolina based on appropriations from the North Carolina General Assembly and private contributions. These funds are recorded as revenue when received.

I. Accrued Vacation Leave

The Southeastern North Carolina Regional Economic Development Commission's policy is to record the cost of vacation leave when earned, and such leave is fully vested. The policy provides for accumulated vacation at a rate of 5/6 day per month. After six months an employee earns one week of vacation. On January 1 of each year an employee earns 10 vacation days (two weeks) plus one floating personal day assuming six months or more of service. Upon completion of 3 years of service an employee earns 15 days (three weeks) the following January 1. Upon completion of 6 years of service an employee earns 20 days (four weeks) the following January 1. Accrued vacation leave for any full-time employee may be accumulated to a maximum total of 165 hours, equivalent to 22 work days. If the employee separates from service, payment for accumulated leave shall not exceed 165 hours. On June 30th of each year, an employee's existing accrued leave balance of 165 hours or less can be carried into the next fiscal year beginning July 1st. The director must approve all requests from staff for use of leave. As of June 30, 2011 the component units of Southeastern North Carolina Regional Economic Development Commission neither have vacation leave policies nor employees.

J. Accrued Sick Leave

The Southeastern North Carolina Regional Economic Development Commission's policy is to record the cost of sick leave when earned, if vested, otherwise, when taken and paid. The policy provides for an accumulation of sick leave at a rate of 1 day per month up to a maximum of 90 days. As of June 30, 2011 the component units of Southeastern North Carolina Regional Economic Development Commission neither have sick leave policies nor employees.

II. CONCENTRATIONS OF CREDIT RISK

The Southeastern North Carolina Regional Economic Development Commission maintains cash balances at one financial institution located in North Carolina. The accounts at this institution are insured by the Federal Deposit Insurance Corporation up to \$250,000. At June 30, 2011, the Commission's uninsured cash balances total \$23,996 and the component units totaled \$1,376.

III. INTERGOVERNMENTAL RECEIVABLE

Intergovernmental receivables at June 30, 2011 are comprised of the following:

IV. GRANTS PAYABLE

Grants awarded but unpaid at year end are reported as liabilities. The Southeastern Partnership, Inc., a component unit of the Southeastern North Carolina Regional Economic Development Commission, has authorized grants totaling \$60,000 contingent upon the recipients obtaining industry to locate in their area. The contingent grant will be considered awarded when the contingency requirement is met.

V. INCOME TAXES

The Southeastern Partnership, Inc. is exempt from federal income taxes under Section 501(c)(6) of the Internal Revenue Code. However, income from certain activities not directly related to the Partnership's tax-exempt purpose is subject to taxation as unrelated business income.

The Southeastern Partnership II, Inc. is exempt from federal income taxes under Section 501(c)(3) of the Internal Revenue Code. However, income from certain activities not directly related to the Partnership's tax-exempt purpose is subject to taxation as unrelated business income.

EXECUTIVE SUMMARY

As the nation's economy regains its footing, North Carolina's Southeast (NCSE) will highlight affordability, accessibility and ready infrastructure to forge sustainable job creation, business development and industrial investment across its 11-county region. The region's value proposition will complement its recognizable brand, honed through more than 15 years of consistent marketing and regional leadership. The region will move forward through collaboration by local economic developers, private allies and government leaders at the municipal, county, state and federal levels.

Since engaging in its first project in 1996, the Commission has worked to facilitate the arrival of 103 new companies to Southeastern North Carolina, along with 8,275 new jobs and \$903,275,000 in industrial investment.

The Southeast's long-range vision for regional development remains anchored by an economic cluster-based marketing analysis initiated in the early 2000s. This analysis identified an initial set of regional cluster targets that included advanced textiles, distribution and logistics, metalworking, boatbuilding and marine trades, consumer food and agri-industries, and building materials. In June 2006, in the wake of recommendations by the Base Realignment and Closure Commission (BRAC), the target list was revised to include defense and homeland security contractors and businesses that could be recruited in the wake of expansion at Fort Bragg. Biotechnology is also now included as a regional cluster target, given North Carolina's global leadership in the cluster, the region's fertile croplands and abundant waterways, and the presence in Greater Wilmington of life science Contract Research Organizations (CROs). The region has also established alternative energy as a target cluster, based on its vast agricultural economy and multi-modal transportation assets.

NCSE remains tactically reliant on the application of innovative promotional techniques, advanced technology tools, the latest economic intelligence, and clear and concise marketing communications. NCSE's Marketing Plan for 2010-2011 reflects a project-centered drive toward job growth and industrial investment that, through both rising and falling economic cycles, has always represented the region's clearest path toward success. Increased movement toward high-tech, web-based marketing will allow NCSE to effectively develop new industrial product, foster partnerships, and conduct more broad ranging marketing activities.

Embracing the opportunities emerging from a rapidly transforming global economic landscape, NCSE will embark on several key initiatives to its leadership posture and economic transformation agenda within the region. NCSE has taken a proactive stance in focusing resources on growing and emerging industry sectors as many traditional targeted sectors have slowed in response to the economic downturn. Additionally, NCSE will have more focus on attracting global companies and conducting lead generation through existing industry.

Several key initiatives that NCSE will explore include:

- **International Marketing** – As a participant in the North Carolina Marketing Council, a unit of the North Carolina Partnership for Economic Development comprising the marketing professionals from the N.C. Department of Commerce and seven regional partnerships, NCSE is now involved in Global Location Link, a direct marketing campaign targeting European companies for direct foreign investment opportunities in North Carolina. Inside the region, emerging global economic realities are spurring opportunities for distribution and logistics, and manufacturing. North Carolina's Southeast will also be exploring international opportunities with

companies in South America and Europe that may have interest in considering the southeast region for investment.

- **Regional Workforce Analysis** – The Southeast has secured funding to conduct an extensive analysis of the region's labor assets pursuant to a strategy of aligning workforce resources and skills sets with the region's most promising industry clusters. Enhancement of the region's workforce is critical to competing successfully in the global economy.
- **BizBoost** – Officials of the N.C. Small Business & Technology Development Center (SBTDC) are working with NCSE on successfully executing "BizBoost," a federally driven outreach effort aimed at supporting the survival and success of locally owned small companies in the region (100 or fewer employers). The program is now running statewide, with collaboration coming from all seven regional partnerships and the N.C. Department of Commerce.
- **Tapping Federal Resources** – Regional officials will continue their ongoing efforts to apply for federal resources for long-term economic advancement programs such as global marketing, export promotion, cluster development, workforce development, and market research.
- **Engagement with the BRAC Regional Task Force** – NCSE will continue to collaborate with the BRAC RTF initiative in marketing the BRAC region to defense and homeland security contractors that want to be located on or near Ft. Bragg. Major economic and population growth is taking place with the relocation of U.S. Forces Command and the U.S. Army Reserve Command from Ft. McPherson, GA, to Ft. Bragg. NCSE co0llaborated with BRAC on developing a marketing plan that is now being implemented.
- **Evaluation of Aerospace as Targeted Industry Cluster** – The arrival of Spirit AeroSystems to the Global TransPark and Boeing Corp. to North Charleston, along with the longtime presence of GE Aircraft Engines in Wilmington and key aviation assets of the U.S. Army at Fort Bragg, has led Southeast leaders to analyze the viability of aerospace operations as a potential target industry cluster for the region. NCSE will complete an analysis of this sector in the region and plan a marketing initiative to target companies in this sector
- **Social Media** – The recent development of social networking tools such as LinkedIn, YouTube and Twitter are revolutionizing many aspects of the marketing industry. Southeast officials will explore the viability of such social media tools as effective avenues to market the region and cultivate clients and consultants. Any such strategy would augment, not replace, existing marketing programs.
- **Renewable Energy** – The opening of Clean Burn Fuels' \$100 million ethanol facility in Hoke County, along with alternative energy projects and operations in Robeson, Sampson and Scotland counties, is ample evidence of the region's potential position as a destination for firms engaged in solar, bio-fuels and, potentially, wind power. Greater Wilmington's success with GE Nuclear Energy's operations is also testimony to the Southeast's attractiveness for alternative energy companies. Regional economic development leaders will continue in honing a vision for maximizing the economic potential of these and other facilities. NCSE is partnering with UNC-Pembroke, the Lumber River COG, the NC Rural Center, and other organizations on a major grant to develop the renewable energy sector in the region.

- **Highway 17 Heritage Tourism Designation** – NCSE is partnering with North Carolina’s Northeast and North Carolina’s Eastern Region to pursue a federal heritage tourism designation for the Highway 17 corridor that runs the length of eastern North Carolina. This designation, if awarded, would build a plan for tourism development along the corridor. The Golden Leaf Foundation has awarded \$125,000 to further this initiative.
- **Global Integration Initiative** — With support from members of the region’s Congressional delegation, the Southeast is seeking \$1 million in federal funding for a four-year program designed to market the region internationally, inventory global economic assets in the Southeast and regionally promote agribusiness commodities and other products for export to foreign buyers.

NCSE MISSION STATEMENT

Provide strong economic development leadership in southeastern North Carolina through innovative marketing and collaborative regional initiatives that will create new jobs, generate capital investment, and secure new business locations.

FACILITATING REGIONAL DEVELOPMENT

Bringing sustainable economic advancement to Southeastern North Carolina requires short-term, intermediate and long-range strategies for promoting and enhancing the region’s unique natural, human, infrastructural and institutional assets.

In 2010-11, NCSE will work with industry clients, consultants and prospects to provide as seamlessly as possible a full array of site-selection resources in a manner that is professional, credible and efficient. The organization’s work in client handling and project management will be done in close collaboration with local economic development leaders and representatives of the North Carolina Department of Commerce, as well as other state, county and municipal officials. Collaborative efforts will also closely involve contacts with private allies and community college and university educators, as client needs dictate.

During the coming five years, NCSE will support strategic economic development initiatives with regional significance. Such initiatives include efforts to establish new infrastructure, align the region’s workforce with the labor needs of the region’s target industry clusters, and design and launch regional marketing and outreach programs that will expand the Southeast’s client portfolio and project activity.

Over the next decade, NCSE will closely monitor the achievement of the organization’s internal goals and objectives set annually by its board of directors and Technical Advisory Group (TAG), making necessary changes and adjustments to its tactics, tools, strategies and programs. As part of the Uniform Performance Measurements established by all seven of North Carolina’s regional partnerships and commissions, NCSE will track a standard set of regional macro-economic indicators in an effort to link regional development goals to the region’s overall economic health.

TARGETED INDUSTRY SECTORS

The constant honing of marketplace targets is a central task of any marketing organization. NCSE targets the following industry sectors:

Building Products

Southeastern North Carolina has a large number of building product manufacturers and distributors. The region is an ideal location for these companies due to overall population and business growth in the region. The Fayetteville and Wilmington areas are two of the fastest growing areas in North Carolina. Wood products have always been a strong industry sector in the region, and there are over 75 wood products companies located here, making products such as wallboard, trusses, doors, cabinets, lumber, and panels. The Port of Wilmington allows for excellent access for importing and exporting of wood and other raw materials.

Advanced Textiles

Southeastern North Carolina has a long and productive history in the textile industry. Over the past decade, a shift from traditional weaving and sewing textiles to advanced and technical non-weaving textiles has occurred. Advanced and performance textiles are more automated and provide a variety of products in the region, including military uniforms and equipment, synthetic fibers, environmental protection products, industrial and automotive filters, and clothing. As a leading state in textile manufacturing, North Carolina has a number of excellent resource organizations to assist companies in this industry sector.

Distribution & Logistics

Southeastern North Carolina is one of the most competitive regions in the United States and the world in which to do business. It has a growing population of nearly 1.1 million people and a diverse industry base of more than 30 Fortune 500 companies. The region's geographic location midway on the east coast provides excellent distribution access and logistics efficiencies for companies engaged in manufacturing, assembly, and retail distribution. The region boasts a three-tiered, interlinked distribution model: 1) At-Port location offers buildings and sites within 20 miles of the Port of Wilmington. 2) Interstate corridors offer inland locations along three interstates – I-40, I-95, and I-74. 3) The region offers close proximity to key regional markets, including Charlotte, NC, Raleigh, NC, Columbia, SC, and Atlanta, GA. NCSE is supportive of the completion of the feasibility study of a deeper water access port in Brunswick County. Studies and projection show this port will be critical to ensure North Carolina's strength in the global economy in the future.

Boatbuilding and Marine Trades

Southeastern North Carolina is an excellent location for boatbuilding and marine companies. The region has a proud history of craftsmanship in boat construction and possesses a skilled workforce in this industry sector. The region's natural proximity to the Atlantic coast, and the many beaches, waterways, intra-coastal waterway, lakes, and rivers provide a ready market and a great location for construction and testing. North Carolina's Industry Boating Services organization provides technical assistance and helps companies match up to potential suppliers and customers.

Metalworking

Southeastern North Carolina has a cluster of metal product manufacturing companies that make a range of products, including steel coils, attic fans, aluminum fencing, grills, steel packing straps, metal buildings, pipe fittings, cranes, and nails. Overall, North Carolina has over 150,000 people employed in metalworking industries. Community colleges in the region offer customized worker and classroom training in welding and metal fabrication and technology. Machining technology and robotics programs are also available as well.

Food Processing and Agri-Industry

Southeastern North Carolina has more than 20,000 people employed with food processing companies. Examples of products made/grown here include pork, poultry, sauces, food/drink ingredients, value-added sweet potato products, peanuts, soybean oil, grapes, tobacco, and barbecue. The region has several of the top farm income producing counties in the nation. The region has long been known for its productive land and innovative agricultural companies and farms. Wineries and vineyards are a growth sector in the region, due to the area's fertile loamy soils that are ideal for grapes, as well as blueberries. North Carolina annually exports more than \$2 billion of agricultural products – transportation access is made easy by the Port at Wilmington and interstate highways.

Military Contractors

Southeastern North Carolina has a long and proud heritage with the presence of military installations in the region. Ft. Bragg, located near Fayetteville, is one of the nation's largest and most important ARMY installations. Ft. Bragg hosts the 82nd Airborne Division and also the U. S. ARMY Special Operations Command, and Pope Air Force Base is located adjacent to Ft. Bragg. By 2011, U.S. ARMY Forces Command (FORSCOM) and the ARMY Reserve Command (USARC) will be fully relocated to Ft. Bragg as part of the BRAC (BASE Realignment and Closure Commission). These moves will bring thousands of new personnel and contractors to the region. The southeast region has a number of excellent resources to assist military contractor companies that have interest in the region, including the Military Business Center, BRAC Regional Task Force, and the Defense and Security Accelerator.

Biotechnology

Southeastern North Carolina contains excellent opportunities for emerging and established biotechnology companies. North Carolina has tremendous resources and assets within this industry sector. Wilmington has one of the largest clusters of research contract organizations (CRO) in the state and nation. Additionally, the University of North Carolina at Wilmington is developing a \$30 Million marine biotechnology research center to take advantage of the region's proximity to the coast. Agricultural biotech research is growing due to the region's strong agricultural base and network of universities and community colleges engaged in biotech research and business assistance through Bio-accelerators. The North Carolina Biotechnology Center has a regional office to lead development in this sector.

NCSE PROJECT MANAGEMENT POLICY

North Carolina's Southeast adheres to a collaborative, client-centered approach to managing business development projects through its marketing program. We work closely with the NC Department of

Commerce in the Fayetteville regional office and the Raleigh statewide office. DOC participation is critical to securing state-level technical and policy support for projects, as well as financial incentives and in-kind assistance necessary for project closure.

Local economic development professionals are central to the region's project management strategy, spearheading client contact with county and municipal leaders, local utility contacts, and community college and university officials. NCSE staff coordinates regionally-based allies and experts whose participation is necessary to the success of specific projects. NCSE personnel, DOC representatives and local EDC staff coordinate all activities surrounding the client visits, ensuring such visits maximize the clients' time and align with project needs. NCSE provides additional project assistance through research and technical services and leadership support, assistance that is made available upon request by local economic developers or DOC marketing representatives.

CONCLUSION

North Carolina's Southeast will continue to focus on short, intermediate and long-term economic development strategies aimed at sustainable job creation and industrial investment. Its regional leadership position also requires NCSE maintains a visible, vocal role in fostering high-quality industrial product and advocating for policies designed to keep the region's business environment competitive on a global basis.

Southeast officials will work closely with public and private allies and partners in marketing the region and its communities through sound economic intelligence, electronic and printed promotional materials, national and international outreach, sound project management practices and seamless client handling procedures. Regional strategies for quality job and business growth remain based on a targeted industry approach that has been in place since 2004. As national, state and global economies return to positive growth in the coming years, such strategies and tactics – executed in concert with activities of local, state and allied economic developers – represent the region's most promising avenue to sustainable prosperity.

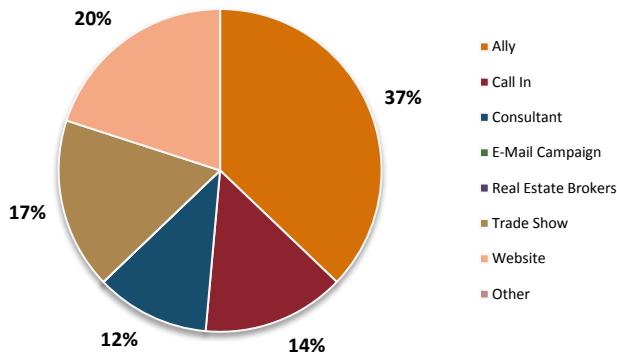

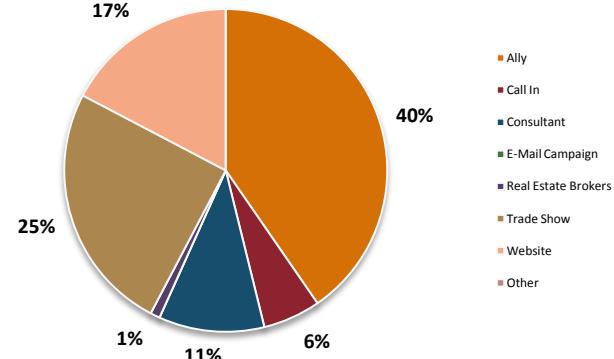

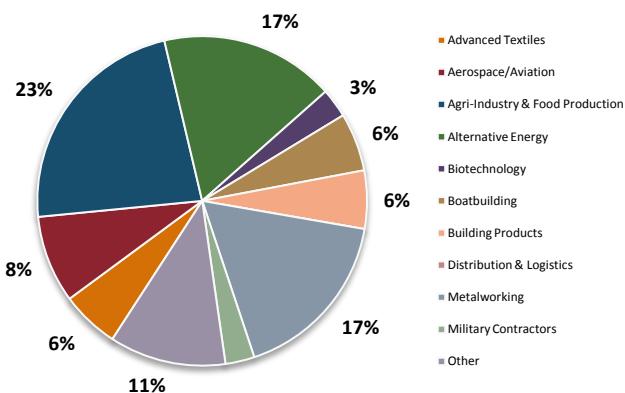
Q4 Leads generated by source- Total 35



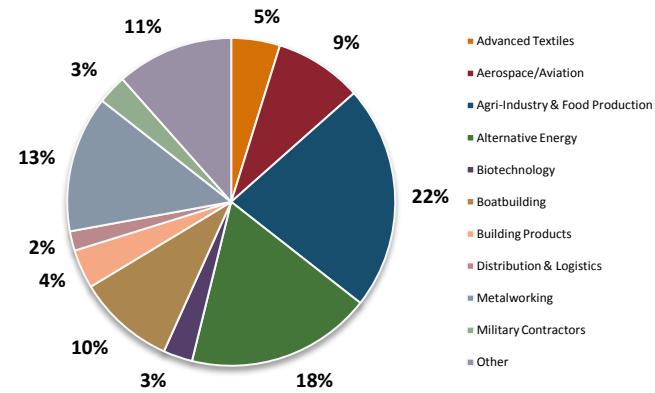
YTD Leads generated by source- Total 116

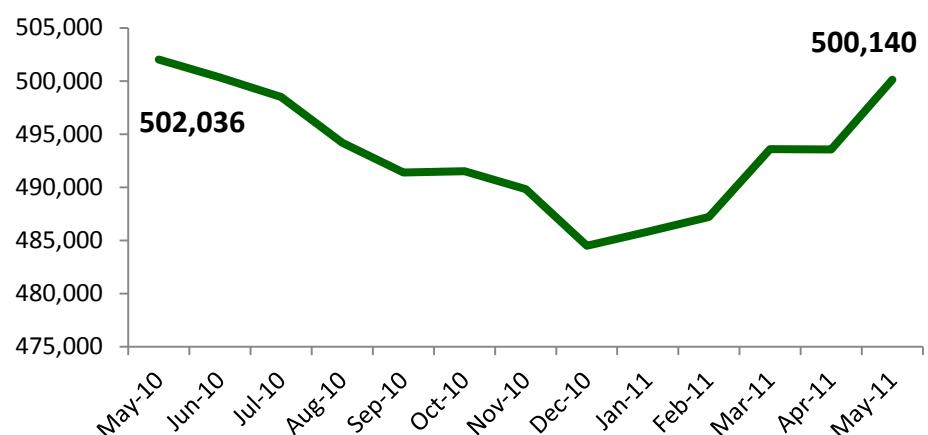

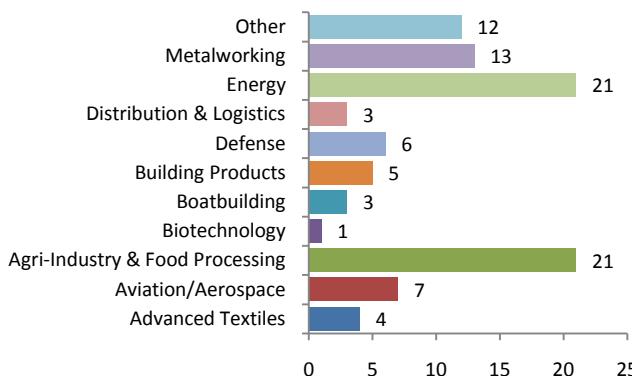

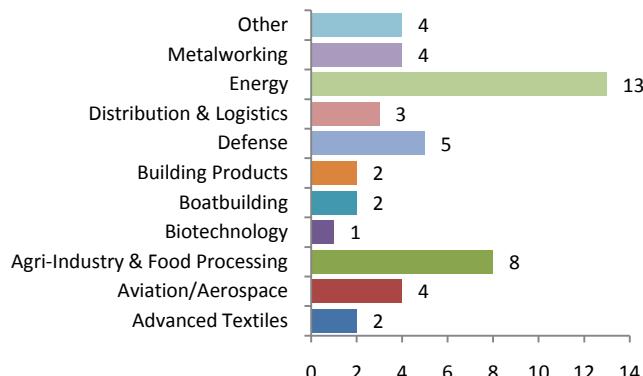

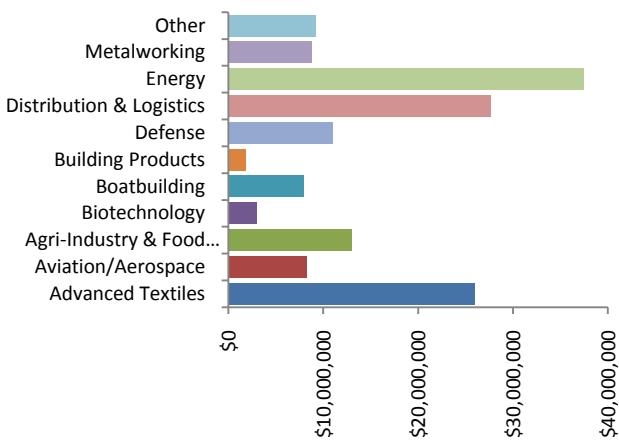
Projects by Industry Sector



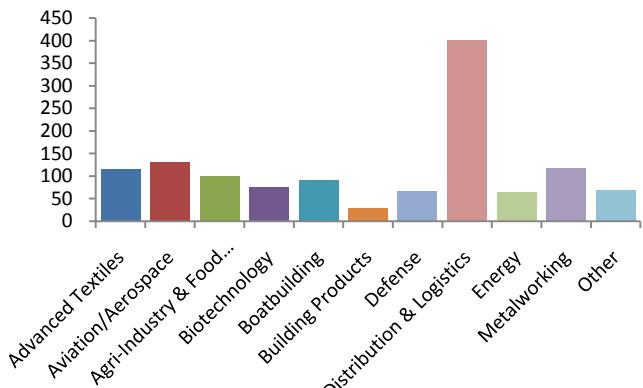
Visits by Industry Sector



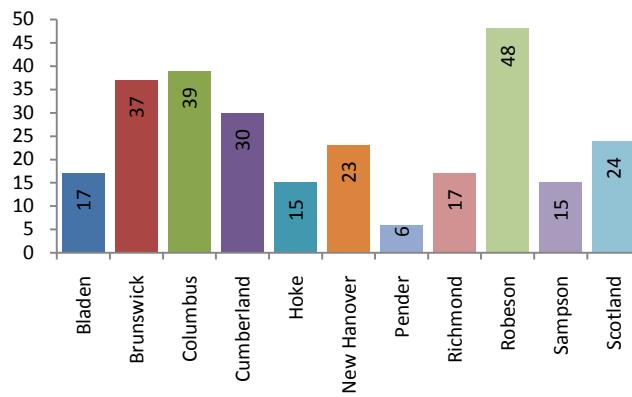
Average Project Investment by Industry Sector



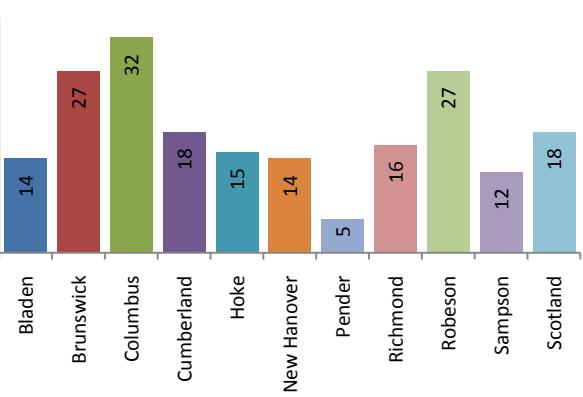
Average Project Employment by Industry Sector

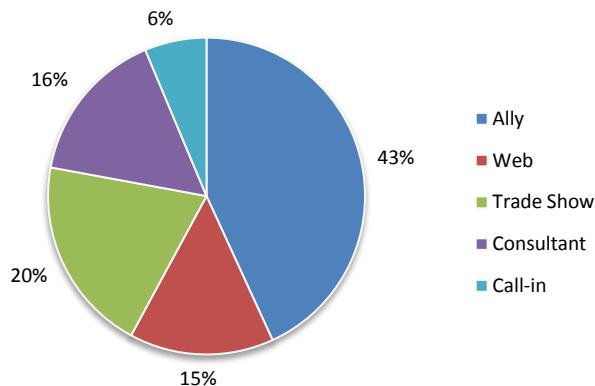

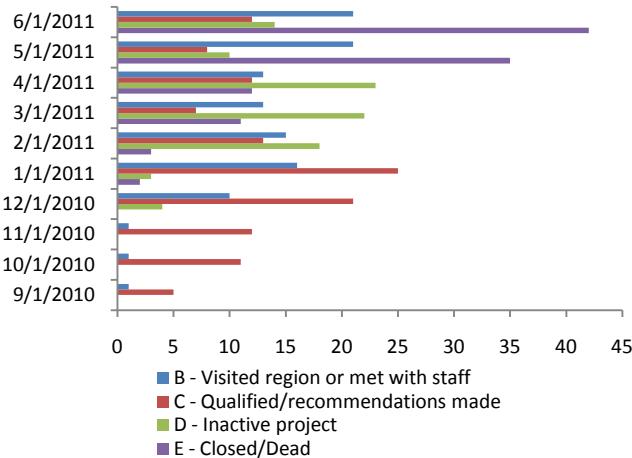

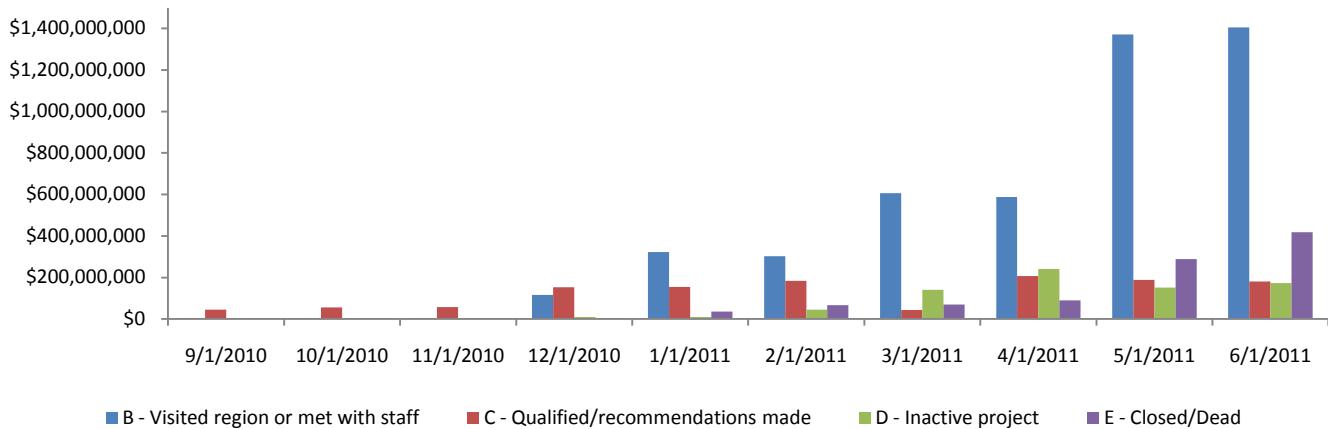
Projects by Source



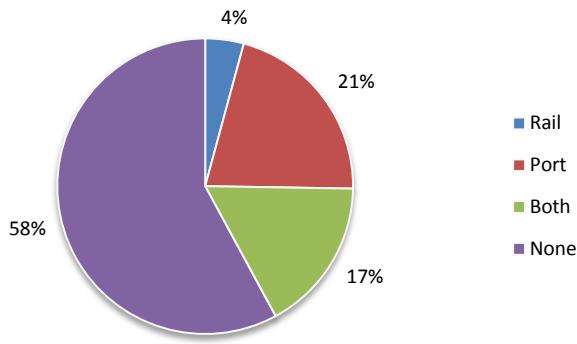
Project Status by Month



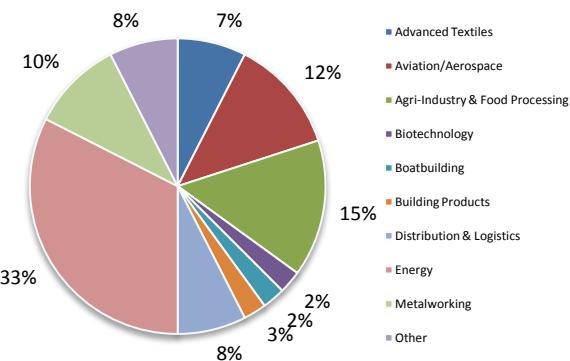
Investment Dollars per Status by Month

2010-2011 Results and Accomplishments

The past year was a challenging year for the regional economy in southeastern North Carolina, and recovery from the 'Great Recession' has been a slow process in the region, as in other areas. However, job growth improved and more companies expressed serious interest in the region than what we experienced in the 18-24 months prior to this year. As the national economy continues to improve, we anticipate that more companies will make affirmative site location decisions regarding the region. *North Carolina's Southeast (NCSE) worked harder and smarter in the past year in developing, leading and assisting innovative marketing strategies and regional initiatives that enhanced economic development efforts. NCSE is a performance based organization dedicated to achieving results that positively impact the economic landscape of the region. Our results for the past year are briefly highlighted in this document.*

Marketing Results

Leads and Projects – Our marketing program generated 116 industry leads and 48 individual company visits/meetings. Steven Roberts Desserts announced a 342 employee operation in Robeson County. The number of generated visits to the region was the strongest in NCSE's history. Leads and projects were generated from more than 10 different industry sectors. Trade Shows & Consultant Missions – NCSE attended and led teams for FABTECH, Miami Boat Show, International Bakery Exposition, International Biomass Conference, Logistics 2011, AUSA, Southeast Biomass Conference, and a site consultants' forum.

Marketing Missions – NCSE conducted marketing missions to meet with prospective companies within targeted industry clusters in Pennsylvania, Colorado, Florida, Georgia, California, and Washington.

Collaboration w/ Dept. of Commerce – NCSE hosted the state development staff with the Department of Commerce at NCSE for presentations by every county in the region. NCSE also continued collaborative partnerships on multiple projects with Commerce and with Friends of NC marketing events.

TAG Planning Meeting – NCSE hosted all local developers and allies for the annual TAG planning meeting to collaboratively discuss ideas and strategies for economic development in the region.

Regional Initiatives & Collaboration Results

Regional Workforce Analysis – NCSE initiated this year-long analysis with Research Technology Strategies, K-12 career technical education, the community colleges, and the three public universities to evaluate the strengths and weaknesses of the region's workforce.

Aerospace Industry Marketing – NCSE facilitated a collaborative marketing initiative with the Fayetteville/Cumberland County Chamber of Commerce and Wilmington Industrial Development to target the aerospace industry sector.

Southeast Biotechnology Advisory Committee – NCSE agreed to chair this collaborative committee of universities, community colleges, and the private sector, which was formed to create economic growth in this sector. NCSE also participates in the Ag-Biotech Action Team to further market the region.

Fort Bragg Regional Alliance Marketing to Defense Firms – NCSE assisted the Alliance in drafting a marketing plan for the 13 county alliance region to target defense firms to the region.

At-Port Distribution & Logistics Marketing – NCSE continued marketing and development of at-port industrial sites near the Wilmington Port and for opportunities in the entire region, in conjunction with the NC Ports, counties, and allies.

Research & Technology Results

Analysis of aerospace & aviation industry sector – NCSE engaged a consultant to conduct an analysis of the strengths and weaknesses of the aerospace and aviation sector in the region, which led to marketing of companies in this sector.

Developed new website – NCSE began developing a more aggressive website design for marketing. Currently, about 25% of leads come through the website. Completion will be in fall, 2011.

State of Region Report – NCSE compiled the first annual State of the Region economic indicators report to begin looking at economic trends in the region. This will be unveiled at the annual meeting.

Sales Force Project Management System Reporting – NCSE completed the first full year on the Sales Force project management system, which will allow extensive lead and project tracking and reporting, supporting a more research and data driven marketing program.

Regional Profile – NCSE compiled the annual profile of economic assets in the region with the assistance of the three regional public universities.

Hired Marketing Research Developer position – NCSE hired this position to handle the critical needs for economic development research for the marketing program.

Updated regional GIS map – NCSE updated the regional GIS map for the region, which highlights infrastructure assets, such as highways, railroads, port, electric lines, etc.

Grant Projects & Funding Results

Economic Development Administration (\$100,000) – NCSE secured this funding for the regional workforce analysis.

NC Workforce Commission (\$60,000) – NCSE secured this funding for the regional workforce analysis.

Biofuels Center of NC (\$50,000) – NCSE secured this funding for the industrial site woody biomass analysis in the region.

NC Rural Center (\$10,000) – this funded an entrepreneurship business competition through the community college small business centers in the region

Biz Boost (\$60,000) – NCSE secured this funding to partner with the Small Business Technology Development Center to market this program to assist small businesses during the economic downturn.

Golden Leaf Foundation (\$125,000) – this funding was awarded to NCSE, NC's Eastern Region, and NC's Northeast to develop a national heritage tourism area in eastern North Carolina. NC's Northeast is acting as the fiscal agent.

Private Fundraising Methodology Study – NCSE completed this study to help the NCSE Board evaluate the feasibility of NCSE conducting a regional private fundraising initiative to supplement the current private fundraising it conducts.
