Dear President Pro-Tempore Berger and Speaker Tillis:

Pursuant to Section 10.60(e) of Session Law 2011-145, all changes to the budgeted allocations to the Block Grants administered by the Department of Health and Human Services must be approved by the Office of State Budget and Management (OSBM) and OSBM shall consult with the Joint Legislative Commission on Governmental Operations prior to implementing the changes. In accordance with the law, OSBM is notifying the Commission that the Division of Child Development and Early Education (DCDEE) has identified a need to realign funds from the subsidized child care services allocation in order to make a final payment for a prior year contract that was approved as part of Session Law 2010-31.

Section 10.37.(a) of Session Law 2010-31 directed the use of \$547,600 of the Child Care and Development Fund (CCDF) Block Grant to support a services support contract. The contract was effective for State fiscal year 2010-11 but the final payment for that contract was not paid until State fiscal year 2011-12. A realignment of funds is needed to ensure that the final payment is properly budgeted and paid for with federal dollars.

OSBM approves of this realignment of funds within the CCDF Block Grant and intends to implement this change after fulfilling the consultation requirement.
