RE: Legislative Report on Federal Grant Matching Funds
(Section 18.2 of Session Law 2011- 145)

DATE: August 17, 2012

Section 18.2 of Session Law 2011-145, House Bill 200 requires the Department to report to the Legislature prior to using funds to provide the state match needed to receive federal grant funds. Pursuant to Section 18.2, the Department reports the need to expend \$185,993.45 of the \$1,200,000 available to provide the state match for the following grant awards for the 2012-13 fiscal year.

Division of Adult Correction Alcoholism and Chemical Dependency Programs Section

Grant Title: 2010 Residential Substance Abuse Treatment (RSAT). This additional funding from the North Carolina Governor's Crime Commission from the 2010 award will fund a long term (6 to 12 month) treatment program for adult male offenders in minimum custody. The program is located at the Dan River Prison Work Farm in Yanceyville, North Carolina and is available to qualifying male inmates statewide. Seven (7) receipt supported time-limited positions are funded with this award. **The additional funding is \$478,437.33 with a federal award of \$358,828.00 and a state match of \$119,609.33.**

Grant Title: 2012-DPS/DOC- Aftercare and Reintegration for Substance Abuse at Swannanoa. This award from the North Carolina Governor's Crime Commission will provide continuation substance abuse treatment for female offenders that have completed longer term substance abuse treatment services while incarcerated. This is a one year grant with a scheduled start date of July 1, 2012. **The total project is \$109,467.24 with a federal award of \$82,100.43 and a state match of \$27,366.81.**

Grant Title: 2012-DPS/DOC- Specialized Substance Abuse Treatment for Incarcerated DWI Offenders. This award from the North Carolina Governor's Crime Commission will provide specialized substance abuse treatment services for inmates convicted for driving while impaired (DWI). This is a one year grant with a scheduled start date of July 1, 2012. **The total project is \$113,568.84 with a federal award of \$85,176.63 and a state match of \$28,392.21.**
