EXECUTIVE SUMMARY

The N.C. General Assembly created the Inactive Hazardous Sites Program in the Department of Environment and Natural Resources' (DENR) Division of Waste Management (DWM) to identify, investigate and cleanup properties contaminated with hazardous substances. The program also manages the assessment and cleanup of old landfill sites that have environmental contamination. The landfill sites addressed through the program are those that never met modern landfill standards designed to prevent contamination. This report satisfies the requirement, set out in G.S. 130A-310.10, for an annual report to the General Assembly. ¹

The report describes activities at voluntary remedial action sites, priority cases, orphan site actions, imminent hazard abatement and National Priorities List sites. DWM has electronically compiled information on the contaminant type and environmental media known or believed to be affected at each site only for the Priority List sites in the Inactive Hazardous Sites Inventory. That information continues to be included in this legislative report. Almost without exception, the "amount" of waste is unknown since there is rarely a record of the amount released. Generally, a complete site evaluation has to be completed before it is possible to reasonably estimate the volume of waste.

A table with the location of old landfills in the inventory (organized by county) is available on the DWM website.² These sites are being handled as prescribed in Session Law 2007-550.

Since the program started in 1987, 3,071 chemical spill or disposal sites and old, unlined dumps or landfills (pre-regulatory) have been cataloged. Of this number, 2,606 still require work to address public health or environmental hazards.

Of the 2,606 remaining open cases, 676 are old, unlined landfills that predate solid and hazardous waste permitting laws. Half of the proceeds of a statewide solid waste disposal tax are directed by statute to the Inactive Hazardous Sites Cleanup Fund to address contamination at these pre-regulatory landfills. DWM has documented that 86 percent of these landfills have residences, schools, day care centers, churches, parks or drinking water sources on or within 1,000 feet of the landfill or have explosive levels of methane present. Seven old landfill sites were screened in FY2011-12; of those, two new sites were added to the Inactive Hazardous Sites program catalog. DWM has established contracts with private firms to assess and remediate the pre-regulatory landfill sites.

Revenue from the solid waste disposal tax can be used only to address landfill sites; very limited funds are available to assess and remediate other chemical waste sites where the owner lacks the financial resources or where the person responsible for the contamination is unknown. At the end of FY 2011-12, the unobligated cash balance in the Inactive Hazardous Sites Cleanup Fund

(IHSCF) was \$0. DWM has estimated the cost of addressing the currently identified highest priority orphan hazardous sites at \$161,195,790.

With the assistance of the Attorney General's Office, the program has recovered funds for assessment and remediation through bankruptcy claims for several sites over the years. In FY2011-12, \$20,205 was recovered from General Motors for one site and \$121,889 from Spectrum Dyed Yarns for one site. Additional proceeds in the amount of \$33,500 were received from the Pillowtex bankruptcy proceeding for two sites. These new monies go into special trust funds, since the payments can only be used in accordance with the bankruptcy settlement agreements.

Session Law 2011-186 authorized a new approach to remediating contaminated groundwater. The bill allows use of alternate risk-based groundwater remediation standards for cleanup at certain industrial properties. This remediation approach is only available on sites where the owner can show that contamination has not migrated off the property and will not in the future. DENR has received many inquiries about the new law and has been advised by several parties that remedial action proposals are in the works employing this new provision. An application fee is required for review of a risk-based cleanup plan under this program. While some partial applications have been submitted, applications fees have not yet been received. Future reports will include information on receipt and expenditure of funds as required by law.

General Assembly) and conducting training events.

I. THE INACTIVE HAZARDOUS SITES INVENTORY AND THE INACTIVE HAZARDOUS WASTE SITES PRIORITY LIST

The Division of Waste Management's (DWM) Inactive Hazardous Sites Branch implements the Inactive Hazardous Sites Response Act of 1987 (IHSRA). The IHSRA requires DENR to maintain a catalog of inactive hazardous substance or waste disposal sites. The program has cataloged 2,395 chemical spill sites and 676 old unlined landfills. Of these, 465 sites now have all work completed and are assigned "No Further Action" status. Fifteen completed all work and were assigned "No Further Action" status in FY2011-12. Table 2, on page 3, provides a list of those sites. Table 1, on page 2, provides a list of sites added to that inventory in FY2011-12. A total of 36 new sites were added this past fiscal year and two sites had to be reopened due to new information on contamination.

N.C.G.S. 130A-310.2 requires DWM to prioritize sites cataloged in the Inactive Hazardous Sites Inventory based on the threat to public health and the environment. Sites are first cataloged in the "Evaluations Pending" category of the Inactive Hazardous Sites Inventory until DWM ranks the site based on rules found in 15A NCAC 13C .0200. Once ranked, sites are transferred to the Inactive Hazardous Waste Sites Priority List. The priority list is provided in an appendix to this report organized in order of the threat to public health and the environment. The entire inventory of both ranked and unranked sites can be provided upon request.

II. SITES THAT MAY OR ARE KNOWN TO REQUIRE USE OF THE INACTIVE HAZARDOUS SITES CLEANUP FUND

Purpose of the Fund

The Inactive Hazardous Sites Cleanup Fund is used to: (1) address imminent hazard sites; (2) pay for assessment and cleanup when responsible parties do not comply with orders to clean up sites; (3) pay for assessment and cleanup of sites without financially-viable responsible parties (orphan sites); and (4) pay for preparation of a notice of Inactive Hazardous Substance or Waste Disposal Site if the owner does not comply with orders to record a notice. When a financially viable responsible party exists, the state must attempt to recover its expenditures from the responsible party.

The Inactive Hazardous Waste Sites Priority List helps determine priorities for cleanup. Responsible parties for top priority sites are encouraged to voluntarily clean up their sites. When a responsible party does not comply with a request and subsequent order to clean up a site, the state must perform the cleanup using the Inactive Hazardous Sites Cleanup Fund. The demand for state funds to conduct site cleanups depends on two factors: (1) how often responsible parties refuse to comply with orders to conduct cleanup and (2) the number of sites that lack financially viable responsible parties.

The statute requires that the program report the list of sites known to require funds and the list of sites suspected to require funds for cleanup. Determining whether a responsible party exists (and thus, whether state funds will be needed for assessment and cleanup) is often a complex and lengthy process. It is also difficult to keep this information updated as owners and operators of the facilities change over time. To avoid the need to update the information several times, DWM performs responsible party research when a site is next in priority for action.

Orphan Chemical Sites

The Inactive Hazardous Sites Cleanup Fund was used to address several sites this year. A summary of the work is provided in Table 3.

DENR has also recovered some funds to address specific sites through bankruptcy claims. The following summarizes work activities in FY 2011-12 using bankruptcy funds:

- **Chemtura Corporation** A total of \$3.75 million was recovered for cleanup of the Crompton and Knowles site in Lowell and the Leesona site in Burlington. Work is pending.
- **CMC** -- \$925,000 recovered for assessment and cleanup of the Elkin site. Remedial action implemented in FY10-11. Conducting periodic monitoring of groundwater. Funds in the amount of \$284,984 remain for monitoring.
- **CMI** \$1.25 million, \$750,000 and \$100,000 have been recovered for three CMI sites. These funds have been used to conduct assessment/remediation at three CMI sites in Elkin. \$312,207, \$63,294, and \$32,759 remain, respectively, for each site. Assessment/cleanup activities are ongoing.
- **GM** \$20,205 recovered in FY2011-12 for the GM Training Center site in Charlotte. Action pending.
- Lyondell A total of \$3,709,423 in two payments and liquidated stock to address four sites: two Cherokee Resources sites in Charlotte, SCM Proctor-Silex in Mount Airy, and SCM Proctor-Silex in Southern Pines. Appropriate distribution of expenditures is being evaluated across these sites based on risk posed and feasibility of remedies.
- Mark IV A total of \$42,738 was recovered for three Dayco Inc sites in Haywood County. Work is pending.
- **Pillowtex** A total of \$243,700 has been recovered to address the Fieldcrest Mills site in Spencer and the Cannon Mills site in Kannapolis. DENR is evaluating where best to spend funds at these two sites.
- SCM \$5.3 million was obtained to address the SCM site in Charlotte. The funds are held in a private trust fund. The trustee contracts the work at DENR's direction. Work is ongoing.
- **Spectrum Dyed Yarns** \$121,889 recovered for the Kings Mountain site in FY2011-12. Action pending.
- **Texfi Inc**. A total of \$941,215 in funds recovered that is being used to remove sources of contamination at the Fayetteville property. A total of \$164,109 remains. Work is continuing.

Pre-Regulatory Landfills

Session Law 2007- 550 established a statewide tax on solid waste disposal, half of which goes to address the hazards posed by landfills that predate federal and state rules on solid waste disposal. The provisions of the bill that relate to the assessment and abatement of contamination at these pre-regulatory landfills went into effect in July 2008. The Division of Waste Management received the first proceeds of the tax in February 2009.

DWM has cataloged a total of 676 unpermitted, unlined landfills. Initial work at each site involved confirming the location, determining the current use of the property, and identifying the use of surrounding property (for example, residential or commercial) to help prioritize the sites for action. That work has been completed. The division then established contracts for contaminant assessment and mitigation of the sites. The division also provides review and approval of assessment work being conducted by local governments and reimburses the cost of that work from the tax proceeds.

In FY 2011-12, DWM completed first phase remedial investigations at 14 sites. That work involves updating information on location of water supply wells, streams, structures and other potential exposure routes, and conducting assessment needed to determine the perimeter of the waste. DWM completed the second phase of assessment (delineation of the extent of the contamination on the site) at five sites. An additional 10 first phase investigations, 45 contaminant delineation investigations, and five remedial designs were underway in FY 2011-12. The program also sampled 168 private water supply wells on or near unpermitted landfills and provided alternate water supplies to seven homes with high levels of contamination. Seven new sites were screened for program qualification. Of those, two were added to the program catalog.

Cleanup Funds Needed

Currently 271 sites that are being used for residential purposes have contaminated water supply wells or have a drinking water source located within one-quarter mile of the site and lack no known financially viable responsible party to pay for abatement. Of this number, 245 are higher priorities due to the site's location on residential property or the detection of contaminants in a water supply well. An additional 44 lower-priority orphaned sites have also been identified. The total number of orphan sites, though, is unknown. Determining whether a responsible party exists (and thus, whether state funds will be needed for assessment and cleanup) is often a complex and lengthy process. It is also difficult to keep this information updated as owners and operators of the facilities change over time. To avoid the need to update the information several times, DWM performs responsible party research when a site is next in priority for action.

Orphan site work can include assessment only, small-to-large soil and waste cleanup, water line installation or larger groundwater restoration projects. An average cost-per-site was determined by first calculating the average cost for orphan soil cleanup actions conducted by DWM's Inactive Hazardous Sites Branch and averaging that figure with an average site cleanup cost for several state programs, published by the Association of State and Territorial Solid Waste Management Officials, adjusting for inflation. That figure comes to \$657,942 per site. The total cost for cleanup is estimated to be \$161,195,790 for 245 highest priority orphan sites. For all of the 315 orphan sites identified thus far, the total comes to \$207,251,739.

As of July 1, 2011, the balance of the Inactive Hazardous Sites Cleanup Fund was \$539,772. Of this, \$164,109 consists of bankruptcy proceeds dedicated to conducting contaminant source remediation at the Texfi-Fayetteville site. The remaining \$375,163 is currently obligated in contracts for assessment and cleanup of contaminated sites. A total of \$425,243 in income from all sources was deposited in the fund in FY2011-12. The level of funding required to address the currently identified higher priority sites without responsible parties clearly points out that the Inactive Hazardous Sites Cleanup Fund is underfunded to address inactive hazardous sites remediation across the state.

III. NATIONAL PRIORITIES LIST SITES REQUIRING A STATE COST SHARE

National Priorities List (NPL) sites are those hazardous substance or waste disposal sites that are priorities for cleanup under the federal Comprehensive Environmental Response, Compensation and Liability Act (CERCLA), more commonly known as Superfund. These are sites identified by the U.S. EPA as high priorities for environmental cleanup because of the nature of the contamination and actual or potential threat to human health and the environment. North Carolina has 37 NPL sites.

The NPL includes both sites with financially-viable responsible parties and orphan sites. Cleanup costs are financed either by responsible parties or by a federal trust fund with a state cost share. When the federal trust fund is used, CERCLA requires North Carolina to pay 10 percent of the cleanup cost plus 100 percent of the cost to operate and maintain the remediation system.

Table 4 provides a list of the North Carolina NPL sites and the following information for each site: location, investigation/cleanup status, estimated costs and projected start dates for cleanup. Part I of Table 4, found on page 11, includes those sites where the Federal Trust Fund/North Carolina cost share is required. A summary of North Carolina's cost-share obligations is provided at the end of this part. Part II of Table 4, found on page 13, includes the status of responsible party-funded cleanups.

IV. RESPONSIBLE PARTY VOLUNTARY SITE REMEDIAL ACTION

When the Inactive Hazardous Sites Branch requests a person responsible for contamination at a priority site take action to address it, most agree to voluntarily conduct a cleanup. Some responsible parties and owners initiate an approved assessment and/or remedial action on their own. Due to the number of voluntary remediation projects and very limited staff resources, the General Assembly authorized DENR to privatize oversight of voluntary remediation activities at lower-priority sites. DWM continues to provide oversight for assessment and remediation at sites that present more severe public health threats or other concerns.

The privatized portion of the voluntary cleanup program is called the Registered Environmental Consultant (REC) Program. Under this program, a responsible party hires a private consultant to conduct the site assessment and cleanup and to certify that those activities comply with regulations. The REC certification replaces state oversight of the assessment and cleanup. For a firm to qualify as a REC, it must meet certain qualifications. The state audits a number of the REC projects each year to ensure program integrity. DWM has the authority to sanction an REC where necessary. State staff auditors are funded through fees collected from the voluntary participants.

A current list of the 189 sites where assessments and cleanups are underway in accordance with an administrative agreement with the state is provided in Table 5 on the following page. These are a mixture of REC-directed and DENR-directed actions. Table 6, found on page 20, is a list of additional DENR-directed responsible party assessment and cleanup actions not under administrative agreements.

Their location, a site description, status and funding source are also provided.

Additional Funds from Bankruptcy Proceedings

With the assistance of the Attorney General's Office, DWM has recovered funds for assessment and remediation of sites through bankruptcy proceedings. Payments out of a bankruptcy proceeding must go into a special trust account to be used only for the specific sites identified in the bankruptcy settlement agreement. Others are held in private escrow accounts. Funds recovered through bankruptcy proceedings in FY2011-12 include the following: GM -- \$20,205 for one site Spectrum Dyed Yarns -- \$121,889 for one site Pillowtex --An additional \$33,700 recovered this year. Total of \$243,700 recovered for two sites.

Previous bankruptcy claims where funds remain and work is pending include: **Gilbert & Bennett--**\$87,912 for one site. **SCM** -- \$5.3 million for the SCM Corp site in Charlotte. **CMC--**\$925,000 for one site. \$284,984 remains. **CMI** -- \$1.25 million, \$750,000 and \$100,000 recovered for three CMI sites. \$321,207, \$63,294 and \$32,759 remain, respectively, in each account. **Safety-Kleen** -- \$654 has been deposited in the Inactive Hazardous Sites Cleanup Fund. **Chemtura** -- \$3.75 million for two sites **Lyondell** -- \$3,709,423 for four sites **Mark IV** -- \$42,738 for three sites.
