The purpose of Funding Opportunity Announcement (FOA) CDC-RFA-DP-1218PHF12 is to increase the number of women screened for breast and cervical cancer screenings by approximately 50,000 to provide high quality screening with tracking and follow-up including patient navigation to low income, uninsured, and under-insured women. The NC Breast and Cervical Cancer Control Program (BCCCP) anticipates screening an additional 1,500 with funding from this FOA. Currently, BCCCP is reaching approximately 8% of the eligible women in NC. This funding will allow BCCCP to target areas and regions, throughout the state, who are in great need of these services.

The primary target population of this initiative is people of color who have tested positive but are unaware of their status, and those with confirmed HIV diagnoses who have never been engaged in care, have refused referral to care, or have dropped out of care.
