JUSTIFICATION FOR REQUEST:

The Department of Commerce requests to deviate due to the return of state funds for grants previously administered by the Rural Economic Development Center (REDC). This request is to amend the initial request for this purpose that was submitted to the Joint Legislative Commission on Governmental Operations on October 1, 2013.

The initial request submitted to the Committee on October 1, 2013 was as follows:

As of August 31, 2013 the balance remaining in state funded grants currently obligated that will be administered by the newly created Rural Economic Development Division housed in the Department of Commerce is \$75,063,025; funds for administration of the grant programs upon return to the state is \$3,753,151 (5% of grant obligations); total overexpenditure - \$78,816,176.

The revised request to deviate for this same purpose included in this request increases the amount of state funded grants currently obligated to be returned to the state by \$6,051,491 and increases the funds for administration of the grants programs upon return to the state by \$302,598.

The revised request submitted to the Committee on October 4, 2013 is as follows:

As of August 31, 2013 the balance remaining in state funded grants currently obligated that will be administered by the newly created Rural Economic Development Division housed in the Department of Commerce is \$81,114,973; funds for administration of the grant programs upon return to the state is \$4,055,749 (5% of grant obligations); total overexpenditure - \$85,170,722.

The rural economic development grants and initiatives provide rural communities with funds to spur business activities, create jobs and invest in North Carolina's rural communities. Projects include expansion or development of water, sewer, broadband, and natural gas; and the reuse and restoration of vacant buildings.
