GRANTOR: Haywood F. Rankin, Katherine B. Rankin, and Catawba Land

Conservancy

GRANTEE: State of NC, Department of Agriculture and Consumer Services, Plant

**Conservation Program** 

LOCATION: Redlair Lane, Gastonia, Gaston County

AREA:  $\pm 737$  acres (subject to survey)

UNIT COST: \$2,900/ acre

CONSIDERATION: \$2,137,300 (subject to survey)

COMMENTS: Plant Conservation Preserve. This site contains plant species identified on both the State and Federal threatened and/or endangered plant species lists. Acquisition of this property will provide protection for the Big Leaf Magnolia and the Schweinitz's Sunflower consistent with the Plant Conservation Program's mission. Funding for this acquisition is provided by a grant from the Natural Heritage Trust Fund.

The acquisition will be subject to restrictions requiring the property to be used for conservation purposes compatible with base buffer requirements and to protect highly significant habitat for the federally endangered Red Cockaded Woodpecker. Funding for this acquisition is provided from the Natural Heritage Trust Fund.
