§ 158-8.3. Creation of Southeastern North Carolina Regional Economic Development Commission.

(a) There is created the Southeastern North Carolina Regional Economic Development Commission to serve Bladen, Brunswick, Columbus, Cumberland, Hoke, New Hanover, Pender, Richmond, Robeson, Sampson, and Scotland Counties, and any other county assigned to the Commission by the Department of Commerce as authorized by law. The Commission shall be located administratively in the Department of Commerce but shall exercise its statutory powers and duties independently of the Department of Commerce. Funds appropriated for the Commission by the General Assembly shall be disbursed directly to the Commission at the beginning of each fiscal year.

- (b) The Commission shall consist of 15 members appointed as follows:
- (1) Three members shall be appointed by the Governor;
 - (2) Two members shall be appointed by the Lieutenant Governor;
 - (3) Five members shall be appointed by the General Assembly upon the recommendation of the Speaker of the House of Representatives in accordance with G.S. 120-121; and
 - (4) Five members shall be appointed by the General Assembly upon the recommendation of the President Pro Tempore of the Senate in accordance with G.S. 120-121.

(c) The appointing authority shall designate two of the initial appointees pursuant to subdivision (b)(1) of this section, one of the initial appointees pursuant to subdivision (b)(2) of this section, two of the initial appointees pursuant to subdivision (b)(3) of this section, and two of the initial appointees pursuant to subdivision (b)(4) of this section to serve for terms ending June 30, 1995; the remainder of the initial appointees shall serve for terms ending June 30, 1997. Their successors shall serve for four-year terms ending on June 30 quadrennially thereafter.

Any appointment to fill a vacancy on the Commission shall be for the balance of the unexpired term. Vacancies in appointments made by the General Assembly shall be filled in accordance with G.S. 120-122.

(c1) The initial meeting shall be called by the Secretary of the Department of Commerce.

(d) Members of the Commission who are State employees shall receive travel expenses as provided in G.S. 138-6. Other Commission members shall receive per diem of one hundred dollars (\$100.00) a day for each day of service when the Commission meets and shall be reimbursed for travel and subsistence as provided in G.S. 138-5. The Commission may adopt policies authorizing additional per diem of one hundred dollars (\$100.00) a day for non-State employee members' additional days of service including Commission subcommittee meetings or other Commission activities, plus reimbursement for related travel and subsistence as provided in G.S. 138-5.

(e) In addition to the powers and duties granted to economic development commissions in this Article, the Southeastern North Carolina Regional Economic Development Commission shall:

- (1) Survey southeastern North Carolina and determine the assets, liabilities, and resources that the region contributes to the economic development process;
- (2) Develop and evaluate alternatives for southeastern North Carolina economic development;
- (3) Develop a preferred economic development plan for the region and establish strategies for implementing the plan; and
- (4) Coordinate activities with and enter into contracts with any nonprofit corporation created to assist the Commission in carrying out its powers and duties.
- (5) Repealed by Session Laws 1999-237, s. 16.5(c).

- \$0 was expended for industry project commitments that materialized.

The Budget for FY 2011-2012 is \$955,814. The revenues consist of \$581,969 from the North Carolina General Assembly, \$36,074 from the Southeastern Partnership II, Inc. for administrative purposes to offset budget cuts, and a fund balance appropriation of \$273,995. The 2011-2012 Marketing Plan will continue to focus on specific targeting industries and targeted geographic areas. We will remain focused on pursuing opportunities that will put us face-to-face with prospective clients, consultants, and real-estate professionals. Our website will continue to be a vital marketing tool, and we will continue to serve as the advocate for economic development in the region and in the State of North Carolina.

North Carolina's Southeast acknowledges and accepts both the need for and the benefits and advantages of the strategic alignment contemplated by Subsection (3). And, like our sister economic development partnerships throughout the state, we work hard at it.

This goal is continuously achieved and ensured through the programs and activities of the North Carolina Partnership for Economic Development. NCPED is a nonprofit 501 (c) (3) consortium Consisting of the North Carolina Department of Commerce (NCDOC) and all seven regional economic development partnerships. Operationally, NCPED functions as an information-sharing and best practices clearinghouse for economic development professionals and private sector volunteers throughout the state.

NCPED's guiding principle is “statewide consistency; regional flexibility,” an approach that permits each region to market and promote its own local and unique business assets and advantages, but also ensures that North Carolina's powerful, consistent, and compelling economic development message is communicated and reinforced throughout the United States and around the world. While the primary and legislatively-mandated function and responsibility of each regional partnership is to develop and execute a regional marketing plan and program of work that fits that particular region's needs, when it comes to marketing the State of North Carolina itself, the seven regions without hesitation look to and depend upon NCDOC for leadership and direction.

- The Chairman of a partnership is elected as chairman of NCPED
- Presidents meet monthly with NCDOC representatives
- Regional partnership Chairs meet quarterly, with NCDOC Secretary and senior staff
- Research and IT officers meet frequently; the EDIS project is an on-going example of collaboration and cooperation
- Marketing Council meets bi-monthly

With these systems and procedures in place, it was easy for the seven regional partnerships to align their marketing and economic development strategies to NCDOC's Economic Development Marketing Plan. North Carolina's Southeast is an active participant in the collaboration, planning, and execution of the following activities that coincide with the NCDOC's marketing efforts that are applicable to southeastern North Carolina.

I. Work-Product Development

- a. Continued to work jointly with the Friends of NC Marketing Council and Dept. of Commerce Marketing in industry sectors in which we overlap.
- b. **Warehouse/Distribution** – NCSE worked collaboratively with the Dept. of Commerce and the NC Ports to recruit warehouse/distribution industries – this included joint participation in developing marketing materials, attending trade shows, and conducting client handling;

Agri-Business – NCSE worked collaboratively with the Dept. of Commerce and the Department of Agriculture to recruit food processing industries – this included joint participation in developing marketing materials, attending trade shows, and conducting client handling;

Building Products – NCSE worked with the Dept. of Commerce and other organizations to advance this industry sector. North Carolina's Southeast and the Dept. of Commerce jointly worked to identify potential buildings and sites that would meet the location requirements of this sector.

- c. **Client/Project Handling** – North Carolina's Southeast has an excellent relationship with the Dept. of Commerce. Client/Project Handling procedure is as follows: once we have a client that would like to visit Southeastern North Carolina, we contact the North Carolina Department of Commerce Regional Representative and he coordinates the visit with the client. The North Carolina Department of Commerce Regional Representative handled all the clients (3 generated) that located in the region during FY 2011-2012. Management's Discussion and Analysis

As management of the Southeastern North Carolina Regional Economic Development Commission, we offer readers of the Commission's statements this narrative overview and analysis of the Commission's financial performance during the fiscal year ended June 30, 2012. Please read in conjunction with the Commission's financial statements, which follow this section.

Financial Highlights

- Contribution commitments received totaled \$124,500.

Overview of the Financial Statements

The audited financial statements of the Commission consist of the following:

- Management's Discussion and Analysis
- Independent Auditor's Report
- Basic Financial Statements
- Notes to Financial Statements

Required Financial Statements

The basic financial statements of the Commission report information of the Commission using accounting methods similar to those used by private sector companies. These statements offer short- and long-term financial information about its activities. The statement of net assets includes all of the Commission's assets and liabilities and provides information about the nature and amounts of investments in resources (assets) and the obligations to Commission creditors (liabilities). It also provides the basis for evaluating the capital structure of the Commission and assessing the liquidity and financial flexibility of the Commission.

All of the current year's revenues and expenses are accounted for in the statement of revenues, expenses, and changes in fund net assets. This statement measures the success of the Commission's operations over the past year and can be used to determine whether the Commission has successfully recovered all of its costs through its public and private support, profitability and credit worthiness.

The final required financial statement is the statement of cash flows. The statement reports cash receipts, cash payments, and net changes in cash resulting from operations, investing, and financing activities and provides answers to such questions as where did cash come from, what was cash used for, and what was the change in the cash balance during the reporting period.

Management's Discussion and Analysis (continued)

Financial Analysis of the Commission

One of the most important questions asked about the Commission's finances is "Is the Commission as a whole better off or worse off as a result of this year's activities?" The statement of net assets and the statement of revenues, expenses, and changes in fund net assets report information about the Commission's activities in a way that will help answer this question. These two statements report the net assets of the Commission and the changes in them. One can think of the Commission's net assets – the difference between assets and liabilities – as one way to measure financial health or financial position. Over time, increases or decreases in the Commission's net assets are one indicator of whether its financial health is improving or deteriorating. However, one will need to consider other non-financial factors such as changes in economic conditions and new or changed government legislation.

Net Assets

To begin our analysis, a summary of the Commission's statement of net assets is presented.

Note that net assets decreased during the year. This decrease represents the degree to which the Commission expanded it's initiatives to promote industry growth in the local region.

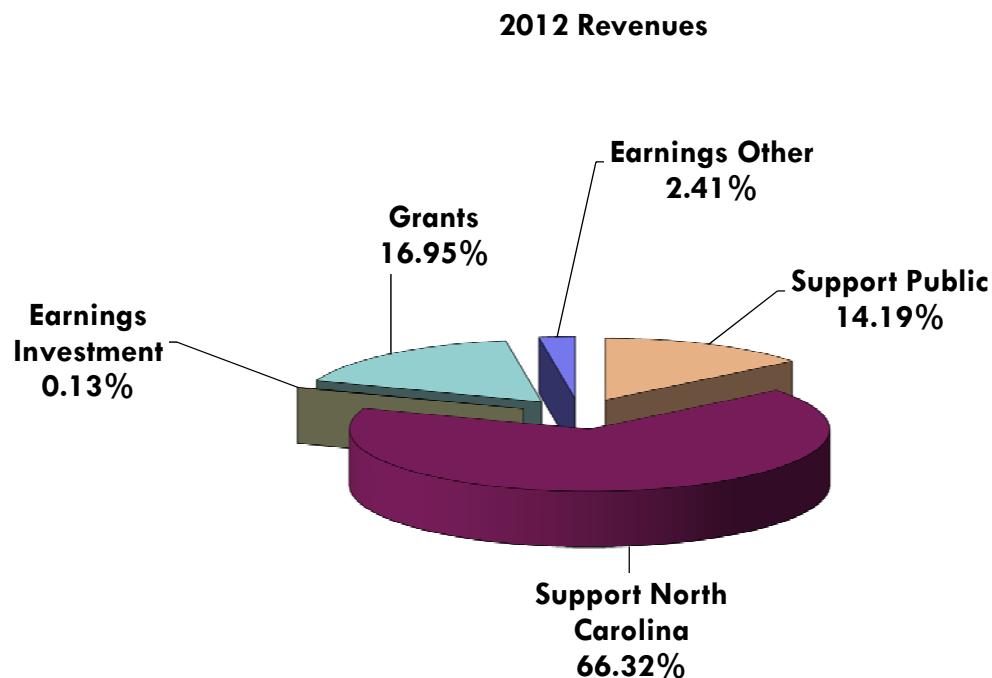

While the statement of net assets shows the change in financial position of net assets, the statement of revenues, expenses, and changes in fund net assets provides answers as to the nature and source of these changes. As seen above, a change in net assets of \$146,130 was the source of the decrease in net assets in 2012.

The Commission's operating revenues increased by \$62,417 to \$876,326 in 2012 largely due to increases in grant revenue. Operating expenses increased by \$113,126.

We have audited the accompanying basic financial statements of Southeastern North Carolina Regional Economic Development Commission, a component unit of the State of North Carolina, as of and for the year ended June 30, 2012, as listed in the table of contents. Those standards require that we plan and perform the audit to obtain reasonable assurance about whether the basic financial statements are free of material misstatement. The financial statements of The Southeastern Partnership, Inc. and The Southeastern Partnership II, Inc. were not audited in accordance with *Government Auditing Standards*. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the basic financial statements. An audit also includes assessing the accounting principles used and significant estimates made by management, as well as evaluating the overall basic financial statement presentation. The Schedule of Expenditures of State Awards is presented for purposes of additional analysis and is not a required part of the basic financial statements. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the basic financial statements. The accompanying Schedule of Expenditures of State Awards is presented as for purposes of additional analysis as required by U.S. Office of Management and Budget Circular A-133, *Audits of States, Local Governments, and Non-Profit Organizations*, and is also not a required part of the basic financial statements. The Schedule of Expenditures of State Awards have been subjected to the auditing procedures applied in the audit of the basic financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the basic financial statements or to the basic financial statements themselves, and other additional procedures in accordance with auditing standards generally accepted in the United States of America. In our opinion, the Schedule of Expenditures of State Awards is stated in all material respects in relation to the basic financial statements as a whole.

I. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Organization and Purpose

The Southeastern North Carolina Regional Economic Development Commission is a legally separate nonprofit organization created by North Carolina General Statute 158-8.3. The Southeastern North Carolina Regional Economic Development Commission was created to serve Bladen, Brunswick, Columbus, Cumberland, Hoke, New Hanover, Pender, Richmond, Robeson, Sampson, and Scotland Counties. The North Carolina General Assembly may amend the Commission, from time to time, with the addition or deletion of counties. It is the mission of the Commission to expand economic opportunities, reduce unemployment and underemployment, and improve the quality of life for citizens of the region that is served by the Commission.

B. Financial Reporting Entity

The Southeastern North Carolina Regional Economic Development Commission is an integral part of the State's reporting entity and is included as a component unit in the State of North Carolina's *Comprehensive Annual Financial Report* (CAFR).

Component units are legally separate entities for which the State and/or Commission is financially accountable. Accountability is defined as the State's and/or Commission's substantive appointment of a majority of the component unit's governing board. Furthermore, to be financially accountable, the State and/or Commission must be able to impose its will upon the component units or there must be a possibility that the component unit may provide specific benefits to, or impose specific financial burdens on, the State and/or Commission. Financial accountability also exists when an organization is fiscally dependent upon the State and/or Commission.

As required by General Statute 158-8.3, the Commission shall consist of fifteen members. Three members shall be appointed by the Governor, two members by the Lieutenant Governor, five members by the General Assembly upon the recommendation of the Speaker of the House of Representatives and five members by the General Assembly upon the recommendation of the President Pro Tempore of the Senate. The State provides significant operating revenues to the Southeastern North Carolina Regional Economic Development Commission creating a benefit/burden relationship. Because of the State's appointment of the board and the benefit/burden relationship, the Southeastern North Carolina Regional Economic Development Commission is a component unit of the State of North Carolina and the Southeastern North Carolina Regional Economic Development Commission's financial statements are included in the State's CAFR.

The accompanying financial statements present the Commission and its component units, entities for which the Commission is considered to be financially accountable. Blended component units, although legally separate entities, are, in substance, part of the Commission's operations.

1. Blended Component Units

a. The Southeastern Partnership, Inc.

The Southeastern Partnership, Inc. is a legally separate non-profit organization created on December 9, 1994, to assist the Southeastern North Carolina Regional Economic Development Commission in carrying out its powers and duties. A seven member Board comprised of Commissioners of Southeastern North Carolina Regional Economic Development Commission governs the Partnership. Three members are the current officers of the Commission, two members are appointed by the Chairman of the Commission, and two members are elected by the Commission. The Commission can significantly influence the programs, projects, activities, and level of services of the Partnership. In addition, The Southeastern Partnership, Inc.'s services directly and indirectly benefit the Southeastern North Carolina Regional Economic Development Commission creating a benefit/burden relationship. Because of the Commission's appointment/influence of the board and the benefit/burden relationship, The Southeastern Partnership, Inc. is a blended component unit of the Southeastern North Carolina Regional Economic Development Commission and is reported as an enterprise fund.

b. The Southeastern Partnership II, Inc.

The Southeastern Partnership II, Inc. is a legally separate non-profit organization created on May 23, 1996, to assist the Southeastern North Carolina Regional Economic Development Commission in carrying out its powers and duties. A seven member Board comprised of Commissioners of Southeastern North Carolina Regional Economic Development Commission governs the Partnership. Three members are the current officers of the Commission, two members are appointed by the Chairman of the Commission, and two members are elected by the Commission. The Commission can significantly influence the programs, projects, activities, and level of services of the Partnership. In addition, The Southeastern Partnership II, Inc.'s services directly and indirectly benefit the Southeastern North Carolina Regional Economic Development Commission creating a benefit/burden relationship. Because of the Commission's appointment/influence of the board and the benefit/burden relationship, The Southeastern Partnership II, Inc. is a blended component unit of the Southeastern North Carolina Regional Economic Development Commission and is reported as an enterprise fund.

C. Basis of Presentation

The accompanying financial statements of Southeastern North Carolina Regional Economic Development Commission financial reporting entity have been prepared in conformity with generally accepted accounting principles in the United States of America ("GAAP"), as prescribed by the Governmental Accounting Standards Board (GASB), which consist of GASB Statements and Interpretations, as well as American Institute of Certified Public Accountants (AICPA) and Financial Accounting Standards Board (FASB) pronouncements specifically made applicable to state and local governmental entities by GASB Statements and Interpretations. The Governmental Accounting Standards Board (GASB) establishes standards of financial accounting and reporting for state and local governments. The Partnership also applies Statements and Interpretations of the Financial Accounting Standards Board (FASB) issued on or before November 30, 1989, Accounting Principles Board Opinions, and Accounting Research Bulletins, unless those pronouncements conflict with or contradict GASB pronouncements.

D. Major Enterprise Funds

Major individual enterprise funds are reported as separate columns in the financial statements. The Commission reports the following major proprietary funds:

The *Southeastern North Carolina Regional Economic Development Commission* is the Commission's operating fund.

The *Southeastern Partnership* accounts for the activities of The Southeastern Partnership, Inc., a blended component unit of the Commission.

The *Southeastern Partnership II* accounts for the activities of The Southeastern Partnership II, Inc., a blended component unit of the Commission.

E. Basis of Accounting

The accompanying financial statements of Southeastern North Carolina Regional Economic Development Commission have been prepared on the accrual basis of accounting.

F. Capital Assets

Capital assets, which include property, plant, and equipment, are reported in the business-type activities columns in the financial statements. Capital assets are defined by the Commission as assets with an initial, individual cost of more than \$5,000 and an estimated useful life in excess of two years. Such assets are recorded at historical cost.

The costs of normal maintenance and repairs that do not add to the value of the asset or materially extend assets lives are not capitalized.

Property, plant, and equipment of the Commission, as well as the component units, are depreciated using the straight line method over the following estimated useful lives:

G. Cash and Cash Equivalents

For purposes of the statement of cash flows, Southeastern North Carolina Regional Economic Development Commission considers all highly liquid investments with a maturity of three months or less when purchased to be cash equivalents.

H. Public and Private Support

Southeastern North Carolina Regional Economic Development Commission's primary sources of funding are from the State of North Carolina based on appropriations from the North Carolina General Assembly and private contributions. These funds are recorded as revenue when received.

I. Accrued Vacation Leave

The Southeastern North Carolina Regional Economic Development Commission's policy is to record the cost of vacation leave when earned, and such leave is fully vested. The policy provides for accumulated vacation at a rate of 5/6 day per month. After six months an employee earns one week of vacation. On January 1 of each year an employee earns 10 vacation days (two weeks) plus one floating personal day assuming six months or more of service. Upon completion of 3 years of service an employee earns 15 days (three weeks) the following January 1. Upon completion of 6 years of service an employee earns 20 days (four weeks) the following January 1. Accrued vacation leave for any full-time employee may be accumulated to a maximum total of 165 hours, equivalent to 22 work days. If the employee separates from service, payment for accumulated leave shall not exceed 165 hours. On June 30th of each year, an employee's existing accrued leave balance of 165 hours or less can be carried into the next fiscal year beginning July 1st. The director must approve all requests from staff for use of leave. As of June 30, 2012 the component units of Southeastern North Carolina Regional Economic Development Commission neither have vacation leave policies nor employees.

J. Accrued Sick Leave

The Southeastern North Carolina Regional Economic Development Commission's policy is to record the cost of sick leave when earned, if vested, otherwise, when taken and paid. The policy provides for an accumulation of sick leave at a rate of 1 day per month up to a maximum of 90 days. As of June 30, 2012 the component units of Southeastern North Carolina Regional Economic Development Commission neither have sick leave policies nor employees.

II. CONCENTRATIONS OF CREDIT RISK

The Southeastern North Carolina Regional Economic Development Commission maintains cash balances at one financial institution located in North Carolina. The accounts at this institution are insured by the Federal Deposit Insurance Corporation up to \$250,000. At June 30, 2012, both the Commission's and the component units' cash balances were all insured.

IV. INCOME TAXES

The Southeastern Partnership, Inc. is exempt from federal income taxes under Section 501(c)(6) of the Internal Revenue Code. However, income from certain activities not directly related to the Partnership's tax-exempt purpose is subject to taxation as unrelated business income.

The Southeastern Partnership II, Inc. is exempt from federal income taxes under Section 501(c)(3) of the Internal Revenue Code. However, income from certain activities not directly related to the Partnership's tax-exempt purpose is subject to taxation as unrelated business income.

EXECUTIVE SUMMARY

The Southeast Region ranks among the most competitive regions in the United States and in which to do business. Its population of over 1.1 million people includes several of North Carolina's fastest-growing counties, and the region's diverse industry base now counts over 30 *Fortune 500* companies.

As global business begins adjusting to economic uncertainties, North Carolina's Southeast (NCSE) will focus the attention of business leaders and site consultants on the 11-county region's affordability, accessibility and ready infrastructure. The region's value proposition will continue to result in sustainable job creation, business development and industrial investment. NCSE will work with local, state and regional development allies and partners to maximize resources to implement a marketing strategy across the region.

The Southeast's cluster-based marketing vision continues to guide regional strategy on industry targets such as advanced textiles, distribution and logistics, food processing and agri-business, and metalworking. Regional marketing and promotional programs will continue to focus on target cluster segments positioned for above-average growth and profitability as global and national economies sustain their rebound. Advanced manufacturing (including aerospace and aviation operations), distribution and logistics, military- and government-contracting businesses, and agriculture-based food and energy industries remain appealing short- and long-term targets -- with opportunities reaching into every Southeast community and affecting businesses of every size, scope and function.

Most recently, the arrival of aerospace and aviation industry leaders to nearby regions in the Carolinas has positioned the Southeast for recruitment of other major companies and suppliers in this cluster. The energy sector is quickly gaining traction in the region, a trend that credits the Southeast's location, terrain, workforce assets, multi-modal transportation networks and natural resources.

Several key initiatives that NCSE will explore include:

- **Regional Workforce Analysis** – The Southeast has launched an extensive analysis of the region’s workforce assets to align workforce resources and skill-sets with the emerging needs of the region’s most promising businesses. The study, undertaken in collaboration with analysts at Regional Technology Strategies (RTS), will be complete by the end of 2011, with findings immediately being folded into regional marketing and strategic planning programs.
- **Existing Industry Success** –NCSE concluded a very successful project with the N.C. Small Business & Technology Development Center (SBTDC) in December, 2010. Through “BizBoost,” the two entities and the N.C. Department of Commerce worked together to assist small businesses in the region with technical assistance to sustain and grow their businesses.
- **Relationship-Building with Federal Partners** – Regional officials will continue their ongoing efforts to draw federal expertise, leadership support and financial resources into regional economic development strategies. NCSE will seek to maximize its close working relationships with the offices of its Congressional and U.S. Senate delegations, as well as key government contacts in the Executive Branch (e.g., U.S. Departments of Agriculture, Commerce and Defense).
- **Engagement with Fort Bragg Regional Alliance** – As major personnel, dependents and supporting businesses arrive at Fort Bragg as part of the relocation of U.S. Forces Command and the U.S. Army Reserve Command from Fort McPherson, GA, NCSE will maintain its partnership with the Fort Bragg Regional Alliance (formerly the BRAC RTF) in highlighting opportunities for defense and homeland security contractors seeking location on or near Ft. Bragg. NCSE assisted the Alliance to develop a marketing plan, which led to the hiring of an economic developer who will market the region to defense contractors.
- **Aerospace Emerges as an Industry Cluster** – NCSE began implementing recommendations from a consulting study that identified regional opportunities in aviation and aerospace. The study was spurred by the recent arrival of Spirit AeroSystems to the Global TransPark, HondaJet in Greensboro and Boeing Corp. to North Charleston. The nearby presence of these three companies will complement assets inside the region such as GE Aircraft Engines in Wilmington and military aviation operations at Fort Bragg. NCSE has begun aggressively targeting industries in this sector and has completed a recruiting mission with aerospace companies to promote the southeast region as a location for operations.
- **Energy** – Strong project activity in recent years provides ample evidence of the region’s attractive position as a destination for firms engaged in traditional energy, biomass, solar, bio-fuels and, potentially, wind power. Wilmington’s success with GE Nuclear Energy’s operations is also testimony to the Southeast’s attractiveness for alternative energy companies. NCSE will continue to work

closely with utilities, agricultural leaders and counterparts in neighboring regions to leverage the Southeast's unique geographic assets in creating sustainable jobs in this cluster.

- **Highway 17 Heritage Tourism Designation** – NCSE will continue its close partnerships with North Carolina's Northeast (NCNE) and North Carolina's Eastern Region (NCER) in pursuing a federal heritage tourism designation for the Highway 17 corridor spanning eastern North Carolina. The initiative is coordinating the work of Raleigh-based Hanbury Preservation Consulting in building an inventory of heritage tourism assets across the 40-county super-region.
- **Evaluation of a Regional Loan Fund** – NCSE will continue evaluating the viability of creating a regional loan fund program that would provide additional avenues of financing for businesses and industries in the region. The fund could be used as a financing tool by companies to secure other needed sources of capital.
- **Implementation of a Private Fundraising Initiative** – NCSE has completed a private fundraising methodology study that outlines different approaches to raising funds for the organization. NCSE has traditionally raised private funds through its non-profit organizations from a small number of investors, but has never carried out a full, public campaign. Additional funding is needed to replace funds due to state budget cuts and to augment current and future operations and marketing.
- **Social Media** – The recent development of social networking tools such as LinkedIn, YouTube and Twitter are revolutionizing many aspects of the marketing industry. NCSE will implement relevant social media tools as effective avenues to market the region and disseminate information to clients and consultants. The strategy will augment existing marketing programs, not replace them.

NCSE MISSION STATEMENT

Provide strong regional economic development leadership in southeastern North Carolina through innovative marketing and collaborative regional initiatives that will create new jobs, generate capital investment, and secure new business locations.

FACILITATING REGIONAL DEVELOPMENT

Cultivating sustainable economic opportunities in Southeastern North Carolina requires strategies for promoting and enhancing the region's assets.

NCSE recognizes that a diverse assortment of participants is needed in order to effectively address regional development objectives. The organization will work to cultivate and maintain mutually constructive relationships with public and private allies and partners that include banks, utilities, railroads, industrial realtors, engineering and construction firms, education and training providers, philanthropic organizations and government agencies at the state, local and multi-county levels. NCSE will support strategic regional development initiatives with transformative economic significance. These efforts will be undertaken collaboratively with regional and statewide allies and partners. Such initiatives include efforts to construct new infrastructure, fine-tune linkages between the region's workforce and the human resource needs of leading clusters, and develop and launch regional marketing and outreach programs designed to boost the quality and quantity of NCSE's project portfolio and client-base.

TRACKING SUCCESS

NCSE will closely monitor the achievement of the organization's internal goals and objectives set annually by its board of directors and Technical Advisory Group (TAG), making necessary changes and adjustments to its tactics, tools, strategies and programs. NCSE tracks a standard set of regional macro-economic indicators in an effort to link regional development goals to the region's overall economic health. Prior to the start of the new fiscal year, NCSE will introduce a State of the Region report detailing key indicators that illustrate the overall economic health of the region.

Each year, the Southeast's Technical Advisory Group (TAG) holds a two-day planning meeting wherein the region's economic development professionals formulate a list of quantifiable goals. The list typically includes lead-generation, site recommendations, announcements, capital investment and other targets. Annual goals drive specific tools and activities NCSE deploys as part of its marketing strategies and regional development vision. Quantifiable objectives also form the basis of assessing the Commission's overall performance. The Commission consults with the TAG on an on-going basis in re-assessing strategies. In instances where Commission results exceed expectations, regional economic development leaders may similarly consider elevating marketing goals and objectives.

- 4) Lead, facilitate, or assist key regional initiatives that impact economic development in the region.
- 5) Boost the effectiveness of marketing communication through adoption of the latest technology tools.
- 6) Develop and integrate accurate, actionable economic intelligence into marketing programs

TARGETED INDUSTRY SECTORS

The constant honing of marketplace targets is a central task of any marketing organization. NCSE targets the following industry sectors:

Aviation and Aerospace

The region's newest target industry cluster has developed in the wake of the arrival of key industry leaders elsewhere in the Carolinas. Relevant industry assets also exist inside the Southeast Region, including the longtime presence in Wilmington of GE's Aircraft Engine unit, which employs approximately 800, as well as two passenger airports, numerous general aviation airports without controlled airspace, a workforce associated with area military bases and significant supplies of metal-workers across the region. Regional strategies for this sector stem from a comprehensive regional assessment completed in early 2011.

Advanced Textiles

Southeastern North Carolina has a long and productive history in the textile industry. Over the past decade, a shift from traditional weaving and sewing textiles to advanced and technical non-woven textiles has occurred. Advanced and performance textiles are more automated and provide a variety of products in the region, including military uniforms and equipment, synthetic fibers, environmental protection products, industrial and automotive filters, and clothing. As a leading state in textile manufacturing, North

Carolina has a number of resource organizations to assist companies in this industry sector.

Energy

America's transition toward renewable forms of energy sources has major consequences for Southeastern North Carolina. Wilmington is the global headquarters for GE's Nuclear Energy unit, which has embarked upon plans to develop next-generation energy production technologies based on the latest nuclear research. The Southeast's global accessibility and supportive local governments also are competitive advantages for alternative energy companies, as is its proximity to potential military and government buyers of "Green" fuels.

Distribution & Logistics

The NCSE region's east coast location provides excellent distribution access and logistics efficiencies for companies engaged in manufacturing, assembly and retail distribution. The region boasts a three-tiered, interlinked distribution model: 1) at-port opportunities; 2) operations sited farther inland along the I-40, I-95 and I-74 corridors; and 3) sites in the region that leverage close proximity to key consumer population centers such as Charlotte, Raleigh, Columbia and Atlanta.

Defense Contractors

Southeastern North Carolina's heritage as a center for military operations serves as an important economic engine. Ft. Bragg, the longtime home of the 82nd Airborne Division and the U. S. ARMY Special Operations Command, is now also the headquarters of U.S. ARMY Forces Command (FORSCOM) and the ARMY Reserve Command (USARC) with their completion of relocating this year to Ft. Bragg as part of the BRAC (BASE Realignment and Closure Commission) initiative. These moves are bringing a significant number of new personnel, dependents and contractors to the region. The Southeast Region has a number of resources to assist military contractor companies that have interest in the region, including the Military Business Center, BRAC Regional Task Force, and the Defense and Security Technology Accelerator.

Metalworking

Southeastern North Carolina has a cluster of metal product manufacturing companies that make a range of products including steel coils, attic fans, aluminum fencing, grills, steel packing straps, metal buildings, pipe fittings, cranes, and nails. Overall, North Carolina has over 150,000 people employed in metalworking industries. Community colleges in the region offer customized worker and classroom training in welding and metal fabrication and technology. Machining technology and robotics programs are also available. A growing metalworking cluster in the region also complements job-creation opportunities in the Southeast's emerging aerospace/aviation cluster.

Building Products

Southeastern North Carolina has a large number of building product manufacturers and distributors. The region is an ideal location for these companies due to overall population and business growth in the region. The Fayetteville and Wilmington areas are two of the fastest growing areas in North Carolina. Wood products have always been a strong industry sector in the region, and there are over 75 wood products companies located here, making products such as wallboard, trusses, doors, cabinets, lumber, and panels. The Port of Wilmington allows for excellent access for importing and exporting of wood and other raw materials.

Food Processing and Agri-Industry

Southeastern North Carolina has more than 20,000 people employed with food processing companies. Examples of products made/grown here include pork, poultry, sauces, food/drink ingredients, sweet potato products, peanuts, soybean oil, grapes, tobacco, and barbecue. The region has several of the top farm income producing counties in the nation. Wineries and vineyards are a growth sector in the region, due to the area's loamy soils that are ideal for grapes, as well as blueberries. North Carolina annually exports more than \$2 billion of agricultural products – transportation access is made easy by the Port of Wilmington and interstate highways.

Boatbuilding and Marine Trades

Southeastern North Carolina is an excellent location for boatbuilding and marine companies. The region has a history of craftsmanship in boat construction and possesses a skilled workforce in this industry sector. The region's natural proximity to the Atlantic coast, and the many beaches, waterways, intra-coastal waterway, lakes, and rivers provide a ready market and location for construction and testing. North Carolina's Industry Boating Services organization provides technical assistance and helps companies match up to potential suppliers and customers. Several segments of the economically sensitive cluster (i.e., after-parts and repair services) are poised to benefit from recent consumer trends.

Biotechnology

Southeastern North Carolina contains excellent opportunities for emerging and established biotechnology companies. Wilmington has one of the largest clusters of research contract organizations (CRO) in the state and nation. Additionally, the University of North Carolina at Wilmington is developing a \$30 million marine biotechnology research center. Agricultural biotech research and neutraceuticals are growing due to the region's strong agricultural base and network of universities and community colleges engaged in biotech research and business assistance through Bio-accelerators. The North Carolina Biotechnology Center has a regional office to lead development in this sector.

NCSE PROJECT MANAGEMENT POLICY

North Carolina's Southeast adheres to a collaborative, client-centered approach to managing business development projects through its marketing program. NCSE works closely with the NC Department of Commerce in the Fayetteville regional office and the statewide Raleigh office. DOC participation is critical to securing state-level technical

and policy support for projects, as well as financial incentives and in-kind assistance necessary for project closure.

Local economic development professionals are central to the region's project management strategy, spearheading client contact with county and municipal leaders, local utility contacts, and community college and university officials. NCSE staff coordinates regionally-based allies and experts whose participation is necessary to the success of specific projects. NCSE personnel, DOC representatives and local EDC staff coordinate all activities surrounding the client visits, ensuring such visits maximize the clients' time and align with project needs. NCSE provides additional project assistance through research and technical services and leadership support, assistance that is made available upon request by local economic developers or DOC marketing representatives.

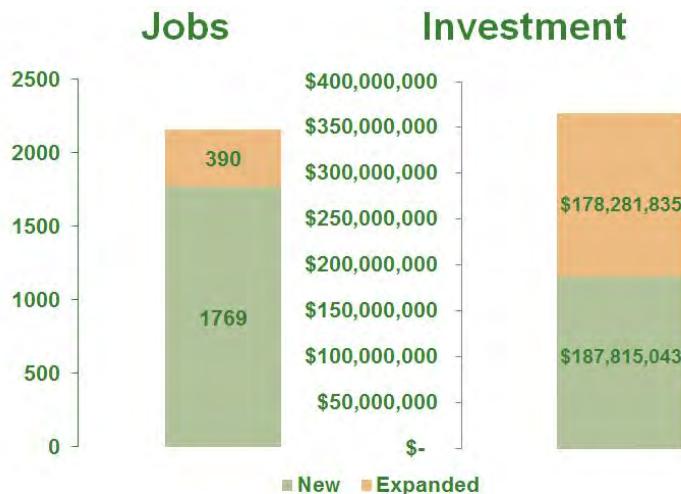
Marketing Activity Pipeline FY 2011-12

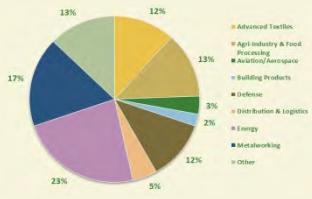

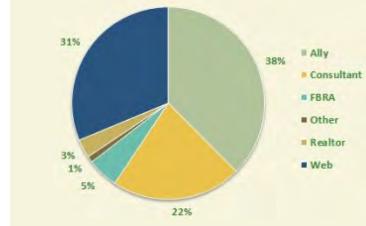

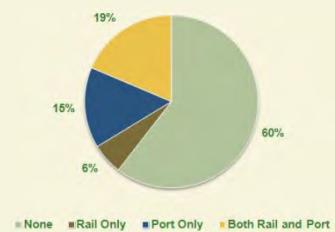

2011-2012 Results and Accomplishments

North Carolina's Southeast (NCSE) worked very proactively in the past year in developing, leading and assisting innovative marketing strategies and regional initiatives that advanced economic development efforts in the southeast region. NCSE is a performance based organization dedicated to achieving results that positively impact the economic landscape of the region. **Our results for the past year are briefly highlighted in this document.**

Marketing Results

Leads and Projects – Our marketing program generated 96 industry leads and 48 individual company visits/meetings by companies to consider the region for a location. Several companies announced locations in the region, beginning as leads generated by the NCSE marketing program. Eighty (80) recommendations of our 11 counties were made to companies. The number of generated visits to the region was one of the strongest in NCSE's history. Leads and projects were generated from more than 10 different industry sectors. Details on leads and projects are included further in this document.

Trade Shows & Consultant Missions – NCSE attended and led teams at several industry trade shows and site consultant events: FABTECH (metalworking sector), International Biomass Conference (Energy Sector), Logistics 2011 (Distribution & Logistics), AUSA (Defense Sector), Southeast Biomass Conference, and a site consultants' forum.

Marketing Missions – NCSE conducted marketing missions to meet with prospective companies within targeted industry clusters in New York, California, New Jersey, Florida and Pennsylvania.

Collaboration w/ Dept. of Commerce – NCSE hosted the state development staff with the Department of Commerce at NCSE for presentations by every county in the region. NCSE also continued collaborative partnerships on multiple projects with Commerce and with Friends of NC marketing events.

TAG (Technical Advisory Group) Planning Meeting – NCSE hosted all local developers and allies for the annual TAG planning meeting to collaboratively discuss ideas and strategies for economic development in the region.

Regional Initiatives & Collaboration Results

Regional Workforce Analysis – NCSE continued work on the regional workforce analysis with Research Technology Strategies, K-12 career technical education, the community colleges, and the three public universities to evaluate the strengths and weaknesses of the region's workforce. Several public forums were held with leaders in the region for input; interviews and surveys were done with businesses and industries in the region for their perspective and ideas. The final report will be released in September, 2012.

Aerospace Industry Marketing – NCSE facilitated a collaborative marketing initiative with the Fayetteville/Cumberland County Chamber of Commerce and Wilmington Industrial Development to target the aerospace industry sector.

Southeast Biotechnology Advisory Committee – NCSE chairs this collaborative committee of universities, community colleges, and the private sector, which was formed to create economic growth in this sector. NCSE also participates in the Ag-Biotech Action Team to further market the region.

Fort Bragg Regional Alliance (FBRA) Marketing to Defense Firms – At the request of the FBRA, NCSE and the Research Triangle Regional Partnership are contracting with FBRA to conduct economic development marketing for the FBRA region. This includes marketing the region to defense contractors and enhancing the region's assets for this sector.

At-Port Distribution & Logistics Marketing – NCSE continued marketing and development of at-port industrial sites near the Wilmington Port and for opportunities in the entire region, in conjunction with the NC Ports, counties, and allies. Several companies considered locations in the Greater Wilmington area as part of the At-Port model marketing.

Strategic Planning – NCSE began developing a three year strategic plan for economic development in region, for 2013-2016.

International Marketing Analysis – NCSE initiated an analysis of foreign based companies in the southeast region and the development of planning for more aggressive marketing to foreign firms to the southeast region. This report will be completed in fall, 2012.

Research Results

Completion of new website – NCSE developed and implemented a more aggressive website design for marketing. This year, 31% of leads came through the website.

State of Region Report – NCSE compiled the first annual State of the Region economic indicators report to begin looking at economic trends and indicators in the region. The second annual report will be released in October, 2012.

Quarterly Performance Report – NCSE developed a new performance report that will be distributed to several hundred stakeholders on a quarterly basis. This report shows marketing lead statistics and relevant information that occurred in the past quarter of activity.

Regional Profile – NCSE compiled the annual profile of economic assets in the region with the assistance of the three regional public universities, Fayetteville State University, UNC Pembroke, and UNC Wilmington.

Hired intern with UNCW – NCSE hired an intern to help do the international marketing analysis.

Introduction of IMPLAN – developed and introduced IMPLAN to conduct economic impact analysis for industry projects in the region. This tool will provide local officials with a better understanding of a company's economic impact to a county or area within the region and state.

Grant Projects & Funding Results

Biofuels Center of NC (\$50,000) – NCSE secured this funding for the industrial site woody biomass analysis in the region. The project was completed and NCSE is currently marketing these sites to biofuels companies.

Fort Bragg Regional Alliance Marketing Partnership – under this contract, NCSE will be allocated \$52,000 to conduct marketing for the FBRA region for FY 2012-2013.

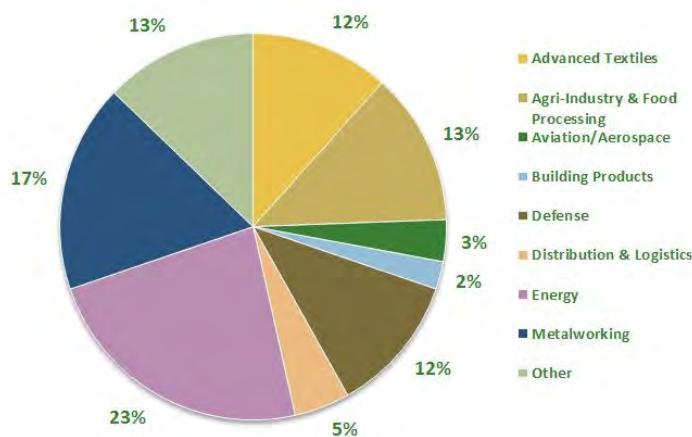

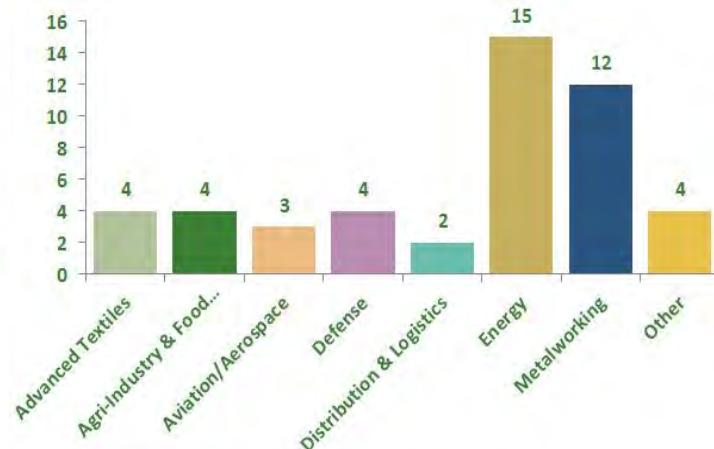


Fiscal Year 2011-2012

Projects by Industry Sector



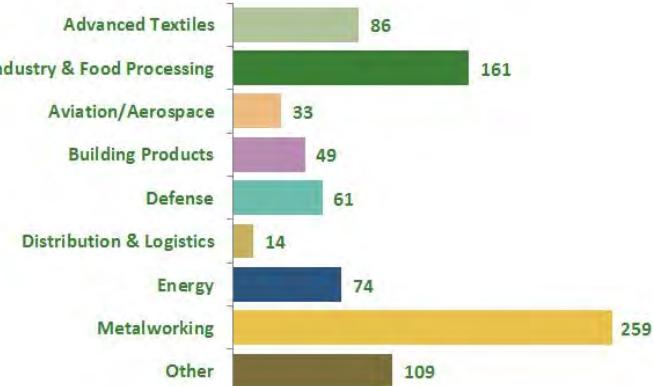
Visits by Industry Sector



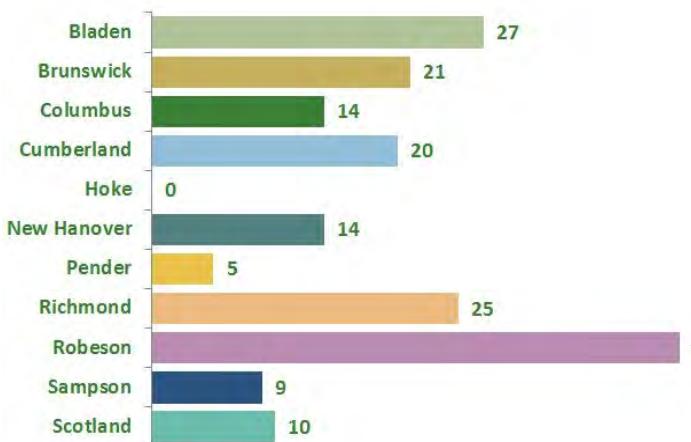
Average Project Investment by Industry



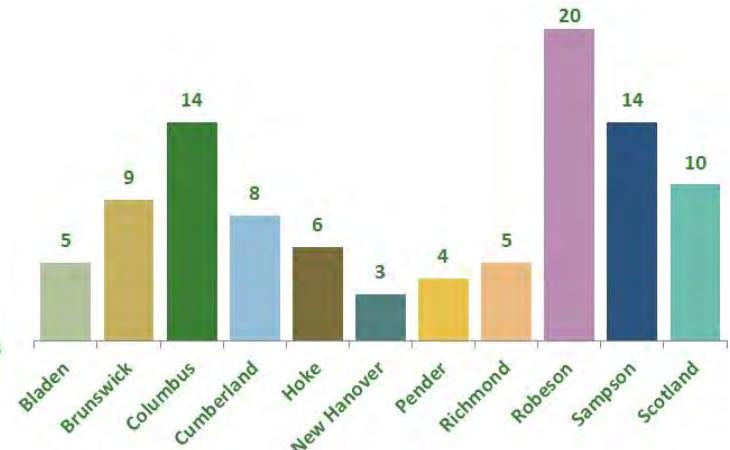
Average Project Employment by Industry

Site Recommendations by County



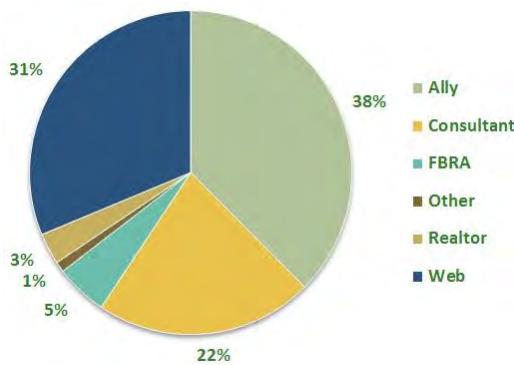

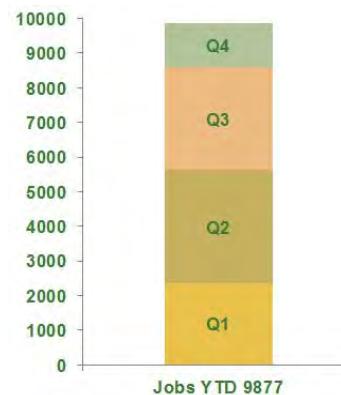

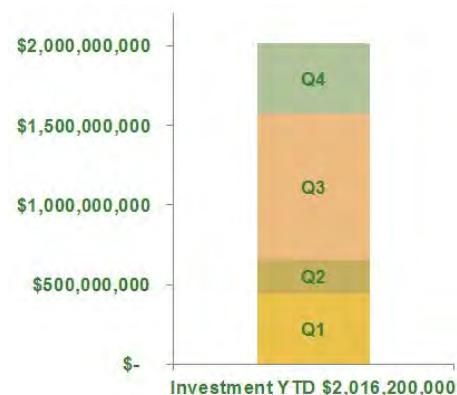

Potential Employment



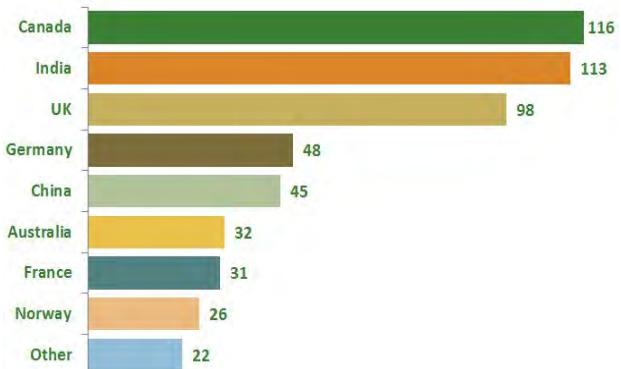

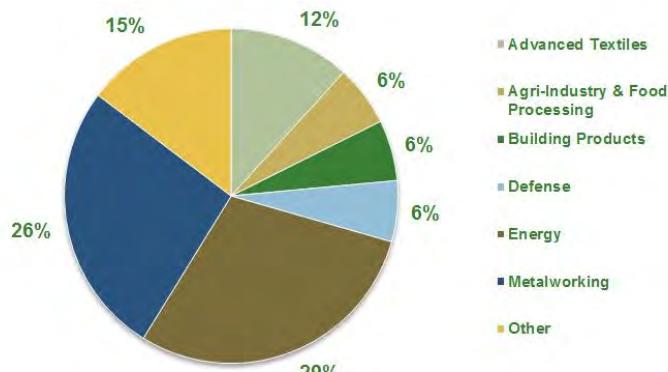

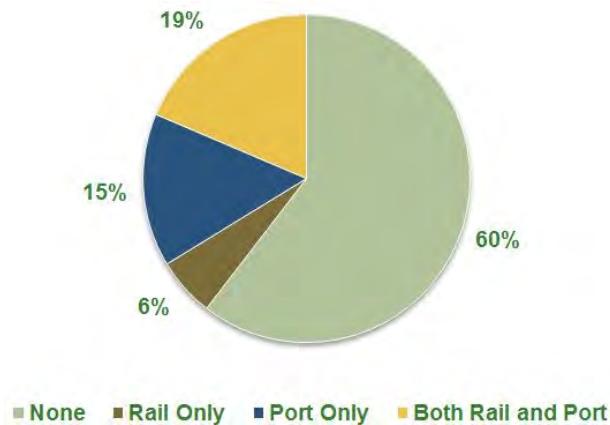
