The property will be managed as a working forest for production of forest products to support the forest management program and enhancement of the Research Stations Division.

COMMENTS: Property proposed for acquisition will be established as a forest management property within the Research Stations Division. It will be utilized for research and demonstration to support forest management practices in western North Carolina. The property will be managed as a working forest for production of forest products to support the forest management program and enhancement of the Research Stations Division.

COMMENTS: Property proposed for acquisition is for inclusion in Yellow Mountain State Natural Area. Acquisition of this property provides protection of natural and scenic resources and water quality in Yellow Mountain State Natural Area. The property will be acquired subject to restrictions in accordance with the Nature Preserves Act. Funding for this acquisition is provided by the Federal Land and Water Conservation Fund (\$200,000), and using special indebtedness (COPs) authorized in Session Law 2007-323, to be repaid by the Parks and Recreation Trust Fund (\$500,030).

CONSIDERATION: \$115,500 (subject to survey)

COMMENTS: Property proposed for acquisition is needed to provide fishing and boating access to the Roanoke River on the ± 40 mile section of the river between the Edwards Ferry Access Area near Scotland Neck and the Hamilton Access Area in Martin County. In the event construction for the boating access has not commenced within eighteen (18) months from the date of conveyance to the State or if construction is not completed within twenty-four (24) months from the date of conveyance, the grantor reserves the right to repurchase the property for \$115,500. Funding for this acquisition will be provided by boat registration and /or fishing license fees.

COMMENTS: Property proposed for acquisition will be utilized as additional parking at the WRC's Sunset Beach Fishing and Boating Access Area. In the event the property is needed for a future transportation project, the property will revert back to the Department of Transportation at no cost.

Acquisition of this property will provide protection for important wildlife habitat and provide hunting and other wildlife recreational opportunities. Funding for this acquisition is provided by the US Fish and Wildlife Service, State Wildlife Grant Program.
