COMMISSION HISTORY 2013

Background

North Carolina's share of the Master Settlement Agreement (MSA) was divided into three different parts. Under the terms of the consent decree in North Carolina, 50% of the funds are directed to a non-profit corporation, Golden LEAF, to be used for economic development in tobacco-dependent communities. By statute the remaining 50% is equally divided between two state Commissions. The Health and Wellness Trust Fund Commission utilizes their portion for health-related needs (HWTFC). The final portion is allocated to the North Carolina Tobacco Trust Fund Commission (TTFC). With the passage of the 2011 budget, the TTFC now receives funding via non-reoccurring appropriations and the HWTFC is no longer in existence.

The TTFC was created on August 2, 2000 with the approval of House Bill 1431. The purpose of the Commission is to assist tobacco farmers, former tobacco quota holders, persons engaged in tobacco-related businesses, individuals displaced from tobacco-related employment, and tobacco product component businesses in this State due to the adverse effects of the MSA. Funds can be disbursed through **compensatory programs** and **qualified agricultural programs**.

Membership is made up of 18 people, six appointed by the Governor, six by the Speaker of the House and six by the President Pro Tem of the Senate. The board met for the first time February 15, 2001 at which the members were given their charges and sworn in.

Since November 1, 2012

The TTFC has met **four times** this past year. During these meetings, board members awarded grant funds, received grantee updates and took action on grant amendment requests.

In 2013, a total of **50** grant applications were received requesting over **\$9.9** million in funding. After a very detailed review process, the TTFC approved grants totaling **\$1,735,500** for **12** projects. The diversion of funds, to balance the state budget and other non-statutory projects, prevented the board from addressing many more of these worthy applications.

Even with the limitation of funds, the TTFC is very proud of the investments made this past year to help people in North Carolina continue to move forward. Below are examples of positive impacts in just a few of our ongoing projects.

- A new cattle marketing facility in Duplin County serving the southeast region generated over \$1 million in cattle sales in less than 6 months.
- Vance County will open a new farmers market in late 2013 that will serve farmers there and in surrounding counties.
- 24 community colleges across the state provided tuition and supply assistance through "Project Skill-UP" to over 1,000 students who are training for new careers.
- Agricultural education programs at 32 high schools received grants of up to \$5,000 to improve their facilities, implement new curriculums, construct greenhouses and purchase much-needed supplies.
- New grants were awarded to 12 applicants for projects such as major marketing campaigns for local food products, new farmers markets, cost-share grants to farmers and more!

Even as we transition from an unprecedented recession, new enterprises are continuing to take hold, new markets are being developed, and new job opportunities are being provided. These contributions, detailed throughout this report, illustrate the passion of North Carolinians to restore prosperity to former tobacco-dependent communities and businesses. Agriculture is still a key industry in the state driving an important economic engine in the rural areas. Our state leaders have shown their ability to address current challenges and future opportunities by providing financial resources through our program that will pay dividends for years to come. The project funded a marketing cost share program for farmers, farmer groups and farmer tail-gate markets in 23 western North Carolina counties. The cost share funds were utilized as a direct one-to-one match for marketing and promotional materials. Over 2,300 farmers were supported by the project either through cost-share assistance or through their membership in farmers markets. Over \$140,000 was leveraged by farmers against the same amount of cost-share. Farmers reported that the decreased marketing costs have increased profits and the additional marketing tools have generated more sales. Nearly 90% plan to continue their own marketing as a result of their experiences in the project.

Grant Amount: \$220,000

Funds are leveraging an \$820,000 grant from the US Department of Commerce for a permanent revolving loan fund. The fund encourages banks to make loans to businesses targeting agriculture and advanced manufacturing, particularly small companies developing new value added products at the Kannapolis research campus. Loans will be for fixed assets and must create jobs, and are subordinated to other creditors providing an additional \$1,000,000 in loans. Companies will be linked to worker training services to upgrade workforce skills.

Grant has provided 2-year scholarships and internships to 14 students in NCSU's Agricultural Institute. Students who were first in their family to attend college received priority. Goals encourage higher education, enable enhanced agriculture career opportunities, and create long term economic benefits to students' local communities. Students have paid for their own room, board, and expenses. Seven students completed their two years of school and secured jobs and/or gone back to work on their family farm, with one still pursuing an advanced degree.

Through this project an evidence-based food safety training program for NC Farmers' Markets operators and vendors was established and evaluated for efficiency. This program was built specifically for the actual practices of vendors by assessing the current food safety practices across the state. The program is based on best available risk-reduction practices, provides practical solutions to food safety issues and helps create a food safety culture within farmers markets. Observations and data were collected from the 32 test farmers markets. The safety curriculum was developed and training sessions for agricultural agents were implemented. The curriculum is available for all agents and markets in the state.

Social media, personal appearances, educational materials, TV appearances and more have all combined to provide current and fun information about NC produce. The project generated over 65 million media impressions.

This project has continued and enhanced the "Got to be NC" marketing program to assist producers, farmers and value-added food companies in growing sales with retail, food service and specialty food companies. The goal is to sustain and open new markets for food producers across the state. This will enhance the ability of traditional tobacco operations to shift to other consumable product production, and provide growth opportunities for value-added companies.

STATUS: Various marketing campaigns are underway and/or completed with restaurants, grocers and distributors. National specialty food shows in Washington DC and other in-state locations have been held. Stores have utilized displays, signs, ads and promotional events. These efforts have combined with media impressions to reach 22 million customers/consumers. Sales increases of 20% and up have been reported and over 500 farm and food producers have been directly served.

This project provided cost share assistance to 65 former quota holders and/or current tobacco farmers. The projects assisted with installing Best Management Practices that prevented sediment, nutrients, or other pollutants from entering streams within the boundaries of their farms. Typical BMPs included cropland conversion to grass, grassed waterways, field borders, and similar practices. Over 1,300 acres were impacted and \$92,000 leveraged from farmers.

The grant supported Blue Ridge Food Ventures as it offered marketing and product development assistance to food producers. The facility offers equipment for further processing of various food products including fresh produce. The first annual "Big Tasty" event was a competition for food companies to win marketing assistance and exposure of the facility's vendors and their products was increased greatly. The facility marketed its Winter Sun Farms community-supported ag program and increased to over 300 subscribers. Over 6.5 tons of produce was purchased and processed from area farmers in 2013 for the 2014 season. The value of all products (produced in the facility) for the year was over \$1.8 million. Food producers created 110 permanent jobs and sustained over 360.

Its primary purpose is to assist the Coastal Carolina Cattle Alliance with marketing truckloads of cattle. These groups will help educate landowners on how forests can be used to enhance land values and estate planning. The project educated farmers in western NC about the cost-savings and advantages of alternative energy. Cost-share assistance of up to 40% or \$8,000 was allowed for 12 qualified applicants. All projects installed solar equipment to generate power for the home and farm and in some cases, was net metered so that power could be "sold" to the grid. Over the next 25 years, the projects are expected to generate nearly \$400,000 in savings. All projects are monitored through a web-based system. Over \$250,000 was leveraged by farmers.

The NC Future Farmers of America office offered a competitive grant program to the state's high schools. Studies have shown that schools with healthy FFA chapters average higher graduation rates and students are trained in leadership and agricultural skills. A total of 32 grants were awarded to schools across the state to improve their agricultural education programs. Projects included improved greenhouses, small animal livestock equipment, improved equipment facilities and mobile learning labs. Over 2,800 students were impacted.

The project is training veterinarians, livestock producers and extension agents on how to add value to heifer calves raised on beef cattle operations. Specific technology in regards to weaning, vaccinations, and physical characteristics of "quality assured" heifers will mean better calves demanding a higher price at market. Various workshops and one-on-one training sessions will educate a large number of people across the state. The program is based on a model in Missouri that has shown QA heifers demand higher prices.

The Spotted Wing Drosophilia (SWD) is an invasive pest that attacks ripe small fruit crops. The species has begun making its way across the state and NCSU researchers are studying ways to combat the insect and reduce crop loss. NC joined with 14 other states to set up nearly 300 monitoring sites. The research found that raspberries were prone to higher infestations. Preventive measures will help reduce chemical usage and increase profits on other small fruit crops.

Farmers must battle a variety of nematode species which can bring extensive damage to crops. The Agronomics Lab obtained new equipment which quickly and effectively identifies specific nematodes so that more direct/effective treatment can be applied by farmers. Producers will not waste money on unnecessary treatments and test results will help in proper chemical usage. 200 tobacco farmers provided tissue samples and received recommendations on crop rotation and chemical usage. Five unique nematode species were identified (including a new one not usually found in NC.) Farmers will benefit from faster analysis and better recommendations which will ultimately save money.

CONFRONTING OUR CHALLENGES AND STRIVING FOR SUCCESS

The NC Tobacco Trust Fund Commission is privileged to be represented by an 18-member board, represented by farmers and industry professionals from all regions of North Carolina. This group of men and women has worked to support many areas of agriculture, because they know from their own experiences the challenges faced by today's farmers.

During its existence, the Commission has seen over \$380 million in promised Master Settlement Agreement funds diverted to other causes. In spite of an ever-increasing need for these funds by the agricultural industry and communities, our board has still been able to support a variety of worthwhile projects, even with the limited funds available. In many cases, our funds are leveraged with additional funding partners or even loans, in order to see projects to completion.

With our low overhead and administration expenses (which are less than 17% of our total budget), the Commission is a very lean operating agency. In addition, we feel that our financial oversight, project management and reporting practices ensure that the work and accomplishments of our projects are carried out effectively and efficiently.

AN OVERVIEW

The NC Tobacco Trust Fund Commission administers funding and oversees grant projects across the state. Since its creation in 2000, the agency has awarded grant funds to 200 projects. The various government agencies, non-profits and universities have implemented projects which encourage crop diversification, job creation, reducing expenses while increasing farm income, and economic development. Within these programs, several have implemented initiatives that distribute smaller grant funds or cost-share opportunities to thousands of farmers.

PROJECT PROFILES

Several of our active and completed projects are featured. They were selected to represent a variety of regions and to show how NCTTFC grant funds are impacting farmers all over the state. From individual farmers to facilities impacting thousands of producers, these grants are truly creating and sustaining jobs, generating new ideas and putting more money into farmer's pockets.

HOW ARE GRANTS CHOSEN?

The NCTTFC accepts applications during a specified application period. A group of industry professionals and the Commission's board members review all applications. NCTTFC staff members conduct site visits during the review process. A fair and specific scoring process is used to evaluate the applicants and they are scored and ranked according to how the project will possibly meet the goals and objectives of the NCTTFC's mission.

ACCOUNTABILITY

Grantees are required to:

- File quarterly reports with project updates
- Provide receipts and proof of purchases with all financial requests
- Provide documentation on progress through photos, printed materials, etc.
- Work with NCTTFC staff on site visits to monitor progress
- Produce final reports, summarizing the success, goals met and impacts

IMPACTS

Projects must report and document how their projects impact agriculture and local communities. Impact measurements include acres impacted/protected, current/former tobacco farmers served, educational training, jobs created/sustained, volume of product sold and more.

AGRICULTURAL PRODUCTS MARKETING INITIATIVE



The "Got to Be NC" marketing program was launched in 2005 in an effort to enhance and expand the NCDA&CS flagship program, "Goodness Grows in North Carolina." The campaign touts the wide variety of fresh and processed food products available from NC farmers, fishermen and food companies. The grant has implemented promotional campaigns



with major grocery stores, restaurants, specialty food stores and foodservice distributors by leveraging cost-share funds to promote NC food products. Many NC food producers and companies have gained additional shelf space and market-share. Commodity groups have

leveraged grant funds to increase their promotional activities.



NC Specialty Food Products have been featured at the National US Fancy Foods Show and at the 10-day Charlotte Christmas Show. Thousands of wholesale buyers and consumers purchased a variety of NC products!

THE RESULTS SO FAR....

- -Over 11 million consumers reached by store promotions, ads and trade shows!
- -Over 600 food companies and/or producers have been assisted!
- -Food companies report sales increases of 20% and up!
- -Over 900 million media impressions to consumers!

Harvest Time Foods, Inc., makers of "Anne's Old Fashion Dumplings" reported increased shelf space and distribution in several key grocery chains. As a result, the company has expanded its equipment line in order to keep up with the demand for its products!





The NC Department of Agriculture & Consumer Services received a three-year, \$875,000 NC Tobacco Trust Fund Commission grant in 2010. The funds are used for cooperative advertising costs, consumer marketing and to help off-set industry trade show rental space for NC food companies. Every single grocery store and foodservice distributor in the state has participated in some way in the campaign!

RISK MITIGATION MEASURES PROJECT





In 2009, the Environmental Protection Agency (EPA) released Re-registration Eligibility Decisions (REDs) that have had a major impact on production practices for NC crops, including strawberries, tobacco, peanuts and more. These new safety measures are intended to reduce the exposure to fumigation chemicals and increase protection to farmers, workers and the public. NC farmers and their

employees strive to apply chemicals safely and effectively and these new regulations have increased costs, paperwork and time in order to implement. Experts from several agencies with support from several NC commodity associations joined to help farmers understand these regulations and reduce their expenses. This grant offered education

sessions, cost-share help for Personal Protection Equipment (PPE) and training. Fumigant handlers must be medically cleared, fit-tested annually for respirators, understand label regulations, maintain extensive records and receive training on safety equipment usage. In addition the EPA requires buffer zones around treated fields so farmers must be trained on how to inform landowners/businesses about fields. The partner agencies have reached out to as many NC farmers as possible.



THE FAST FACTS:

- -NC is the ONLY state to offer extensive training and services to farmers that address the new EPA regulations
- -Over 2,900 farmers have been served through educational efforts
- -Over 750 farmers have been professionally fit-tested
- -Farmers have saved over \$108,000 in equipment costs

In 2010, East Carolina University received a \$184,542, two–year grant to administer the program. The completion and success of that grant helped secure another grant in 2012 for \$125,000. The partnership with the NC Agromedicine Institute at East Carolina University, the NC Department of Agriculture & Consumer Services and NC State University, has efficiently addressed farmer concerns about the EPA regulations. The project worked closely with the EPA to reduce label restrictions and lessen regulations on farmers.



FARME NOVATIVE

WNC AGOPTIONS & TOBACCO COMMUNITIES REINVESTMENT FUND

For several years, the NCTTFC has supported efforts to help current/former tobacco farmers launch new ideas for their operations. Both WNC AgOptions (currently overseen by WNC Communities) and TCRF (administered by RAFI) offer programs for which farmers can receive cost-share funds that are used to implement projects that generate new income for the farm.

Farmers submit applications, undergo reviews, develop business plans and provide detailed reports on their success. The projects also serve as demonstrations for other farmers so that the tools and knowledge gained can be shared with others.



Gerald and Elaine Fryar of Guilford County used grant funds to help finish off their converted dairy barn which serves as a wedding and event facility. The barn supplements their farming income by hosting 25-30 weddings/receptions per year!



David Hughes, a farmer in Mitchell County has diversified away from tobacco to Kinnebec potatoes — a crop that features yields that are normally double that in other parts of the country. Hughes has expanded sales to produce stands and to consumers.

Farmer Zane Sells of Forsyth County obtained a grant to renovate and add onto an existing shelter. The added space allows more room for storage of his fruits and vegetables that supply his CSA program.

THE RESULTS SO FAR....

- -Over 1,000 farmers assisted since inception!
- -The projects have impacted every county in the state!
- -Cost share amounts have ranged from \$3,000 to \$10,000 for farmers and up to \$30,000 for farmer cooperatives.
- -Over \$3 million leveraged with farmers!



AGRICULTURAL EDUCATION IMPROVEMENT

The mission of Agricultural Education in NC is "to prepare students for successful careers and a lifetime of informed choices in the global agriculture, food, fiber, and natural resources systems." Over 46,000 students take part in Ag-Ed programs in NC with nearly 20,000 enrolled in FFA. The funds were used for a variety of projects designed to enhance their agricultural education programs. Schools utilized the funds during the 2012-13 school year. Projects ranged from new lab equipment to greenhouse improvements to livestock handling equipment. Other schools installed new machine

shop equipment, improved landscaping at farmers markets or installed irrigation systems or fencing. Student involvement was a key factor in the success.



THE RESULIS

-34 schools utilized nearly \$170,000 to
improve their programs.



SPONSORED PROJECT

The NC FFA state office received a \$180,540 grant during the NC Tobacco Trust Fund Commission's 2011 grant cycle. During 2012, over 50 schools applied to receive grants of up to \$5,000 for agricultural education improvement projects. A total of 34 grants were awarded across the state. All of the projects will be sustained past the grant period and will continue to enhance the education of the participating students.



APPALACHIAN GROWN: COST-SHARE FOR FARMERS

"Appalachian Grown" is a branding program that serves
Western North Carolina farmers, farmer groups, and tailgate markets.
Appalachian Grown labeling helps distinguish local farm products and is used to represent food and agricultural products grown by certified Appalachian farms. The three-year grant project provided cost-share funds of up to 50% of marketing expenses for farmers and markets to promote/advertise their products and businesses. A variety of media, printed items and other materials were utilized. The project served farmers located within the 23 western-most counties of NC.

Mitchell County potato growers used ASAP cost share assistance to unify their branding and save money on bags for delivery. They benefitted from this cost share assistance by realizing a \$0.20-0.30 savings per bag. Potatoes were sold in local Ingles Supermarkets.

Rita Stepp of Stepp Farms Hillcrest Orchard in Henderson County says "it has been a blessing" to be a part of ASAP's cost share grant program. Cost share funds were used for a revised website and for a billboard on a high traffic portion of Hwy 64. The website averages over 12,000 hits a month. Many new customers have learned about the farm from the new marketing outreach.





THE RESULTS ...

- Over 2,366 farms with over 51,000 acres impacted
- 180 current or former tobacco workers assisted
- 99% of recipients reported the cost-share had a positive effect on their sales.



ASAP received a three-year, \$168,450 grant during the NC Tobacco Trust Fund Commission's 2010 grant cycle. This program required a 1:1 in-kind or cash match from participating farms. Matching funds helped farm businesses purchase Appalachian Grown marketing materials, including product labels, banners, ad placements and billboards. This direct support helped farmers conduct additional advertising and marketing activities that would have been otherwise cost prohibitive.

PROJECT SKILL-UP

"Project Skill-Up" is a one-of-a-kind program that targets students who have a "connection" to the tobacco industry. Currently, 24 community colleges, located in counties affected by changes in the tobacco industry, offer the project. Qualifying students receive financial assistance for tuition, books and/or supplies for general and continuing education courses. The objective is to prepare the students for new careers and high demand jobs. Students and/or their family members must have their tobacco connection through farming, manufacturing or some other tobacco-related industry. The result has been an inexpensive job training program that has

THE RESULTS SO FAR....

-Over 10,000 students have been assisted!

-Average training cost per student is \$240!

-In 2012 over 800 students obtained new employment!

-The project impacts over 50 counties!

From K. Montgomery, Piedmont Community College: "...I lost my job as a Purchasing Agent in '08 due to the economy and subsequent decrease in construction. The CLT class will help to further hone skills I have already developed in logistics, as well as develop new skills through the CLT certification. This will allow

The NC Community College System Office has received funding for Project Skill-Up since 2005. The project received \$375,000 during the 2012 grant cycle for the 2013 school year. Over 75% of the funding is utilized for student assistance with the rest for faculty, class supplies

The "Buy Local" movement has gained a lot of momentum over the last several years. This growth has encouraged innovative projects designed to make local produce and meat products more readily available. The NCTTFC has partnered with several counties and farm groups to support marketing, equipment and operations in order to sell more products and keep farmers in business.



What began as an idea to help small organic farmers in 2007 has grown into a thriving cooperative in northwestern NC.

NEW RIVER ORGANIC GROWERS utilized a NCTTFC grant to hire a marketing/ salesperson, purchase supplies and secure a delivery truck. Since its small start, the group now boasts 65 farmers with projected annual sales of \$375,000 in produce and meats. Customers include restaurants and country clubs.

Located in a renovated warehouse in Burnsville, one can find a new produce aggregation center known as TRACTOR. Cooperative Extension agents in three counties have worked with area farmers to grow and sell local produce directly to grocery stores such as Ingles Supermarkets and Lowes Foods. A NCTTFC grant was secured for a refrigerated delivery truck. Farmers are trained in safe food handling and are encouraged to diversify to meet the needs of the stores. The operation is less than a year old and is already making deliveries of bibb lettuce and more!

Fresh, pasture-raised pork and beef producers have struggled to find markets for their products. Delivery, pricing and profits are just some of the obstacles. A start-up grant in 2009 for marketing/ operational support to FIRSTHAND FOODS, a Durham-based company, ensures 40+ producers receive a premium price for their meat. The company partners with two NC meat processors to provide cuts that their restaurant and retail customers want on their menus. Firsthand features over 50 different pork and beef products. Utilizing social media, great customer service and their own "Sausage Wagon" the company will reach sales of \$1 million in 2013!

WNC REGIONAL LIVESTOCK CENTER



With its Haywood County grand opening in Spring 2011, the WNC Regional Livestock Center has hosted weekly sales through its auction arena. By utilizing both live auctions and a nationwide video auction system, the center has proven to be a critical partner



for WNC livestock producers. An average of over 300 cattle are sold each Monday. The center provides ample meeting space and also serves as a sales



and exhibition arena for goat and sheep producers. Results show the facility is addressing the sales and auction needs of WNC's livestock producers by putting more money into the pockets of family farmers.

Jerry Roberts of Cherry Lane Farm in Weaverville believes this center "has been a godsend." I had been sending my animals down I-40 into Tennessee," says Roberts. "Now I reduce travel time by going to the WNC Livestock Market and save money on fuel.

THE RESULTS SO FAR....

- -5 new full-time and over 13 part-time positions; total payroll around \$200,000.
- -Over 31,000 head of livestock have been sold since opening.
- -\$2 million back "into pockets" of family farms by reducing transportation costs.
- -Potential for 500 new part-time jobs at the farm level projected in five years.
- -Over \$21 million in gross sales since its opening.

George Lenze of Everett Farms in Transylvania County didn't believe he would use the WNC Livestock Center much with markets available nearby in SC. However, he has sold 150 stocker calves this year alone through the preconditioning market and sales floor. Lenze reports that "exceptional management in bringing buyers to the farmer" also helps farmers obtain prices a few cents higher per pound than at other sales locations.



Over three years, WNC Communities received grant support from the NCTTFC totaling \$1,375,000. This project, serving over 3,000 livestock producers in Western North Carolina, is one of the largest investments that the Commission has made in WNC. Funds were used for permitting, facility design, site preparation, construction, equipment, and marketing.

NC FARMLAN

NC FOUNDATION FOR SOIL & WATER CONSERVATION



Stabilizing crop soil, preventing erosion, establishing grass waterways...these were just some of the "Best Management Practices" accomplished by the NC Foundation for Soil & Water Conservation over the last three years. Current and former tobacco farmers applied for cost-share funds to improve waterways or convert cropland to pasture or for hay. After their application was approved and the project completed, farmers received 75% of their projects total cost in grant cost-share funds. A key result was a major reduction in soil erosion and nutrient depletion. It is estimated that over 5,400 tons of soil will be saved/year with a combined savings of over 30,000 pounds/year of nitrogen and phosphorus nutrients!





The NC Foundation for Soil & Water Conservation received a \$300,000 grant during the NC Tobacco Trust Fund Commission's 2010 grant cycle. 65 grant projects utilized \$275,000 of these funds for Best Management Practices. The projects not only reduced implementation costs for farmers, but also raised awareness on how critical soil/nutrient erosion is to the future of crop and pastureland in the agricultural community.

MARKETS, ARENAS & MORE!



Over the last few years, numerous structures that serve the agricultural community have been supported by NCTTFC grant funds. Whether it's new farmers markets, a renovated train depot that now offers fresh produce every weekend, livestock facilities or open-air structures for events, the positive impact for consumers and farmers is statewide. Here are just a few examples of how the NCTTFC has been a part of these successful projects.



Duplin Livestock Facility – Opened 2013. A \$200,000 grant leveraged with other funders helped build this new structure located on the Duplin Ag Center grounds. It enables livestock producers to take advantage of better cattle pricing through truckload sales. Producers in several counties have been served. Other regional meetings/events also utilize the facility. Within six months, over 2,000 cattle valued at \$1 million were sold!

Madison County Fairgrounds Arena — Opened 2013. A \$150,000 grant constructed this new building that is being used for community events. Located on the fairgrounds, it is the only building of its type in the area and has hosted numerous livestock and other ag-related community seminars, classes and educational events.



Cape Fear Farmers Market — Opened 2012. A \$350,000 grant leveraged with over \$1 million in other grant/loan funding enabled the Town of Elizabethtown to build a downtown "show-piece." This former grocery store underwent an extensive renovation to become a yearround market for area farmers. A successful bakery and butcher shop help draw hundreds of customers a day to the market too.

Other upcoming facility projects that are utilizing NCTTFC funds include: The **Vance County Regional Farmers Market** set to open in late 2013, the all-new **Yadkin County Agricultural Center** which will open in 2015, the **Market at Rotary Square** in downtown Concord, set for 2014 and the **Diesel Mechanic Training School** located at James Sprunt Community College in Kenansville which will train local residents to fill much-needed positions with major agribusinesses in the region.

PROJECT IMPACTS



The results of NC Tobacco Trust Fund Commission Grants are on-going. However the impacts of these programs over the last four years are affecting many farmers, citizens and industries across the state.

- Over 3,100 Jobs Created
- Over 37,000 Jobs Sustained (farmers, employees, industry)
 - Over 2,200 Workers Re-Employed
 - 15,304 Former Tobacco Quota Holders Assisted*
 - Nearly 12,600 Worker Skills Upgraded
- Nearly 82,000 Received Increased Educational Training (through schooling, ag-related seminars, online tools and more)
 - Over \$1.4 million in New Income
 - Nearly 30,000 Current/Former Tobacco Farmers Assisted*
 - 1 Million Acres of Farmland Impacted
 - 5 Million People Served or Impacted (farmers and consumers)
 - Over \$47 million leveraged

*Due to the multitude of opportunities available, it is reasonable to assume that current/former tobacco farmers and former quota holders have benefitted more than once from NCTTFC funded projects. Figures for all impacts are based on data collected from project managers through quarterly and final reports from 2008 through July 1, 2013. Actual numbers are most likely higher since some projects are more far-reaching and can not be precisely measured.
