#### Internal Service Funds

• Internal Service Funds are defined in §143 C-1-3 (a) 7

"Accounts for any activity that provides goods or services to other funds, departments, or agencies of the primary government and its component units, or to other governments, on a cost-reimbursement basis. Internal service funds should be used only if the reporting government is the predominant participant in the activity. Otherwise, the activity should be reported as an enterprise fund."

- State agencies pay Internal Service Funds (such as Temporary Solutions or Motor Fleet Management) for services through monthly billing invoices paid with appropriated funds or budgeted receipts
- The net of receipts over expenditures result in Internal Service Funds' accumulated cash balance

### FY 2013/2014 Plan

- \$27M now available to purchase vehicles
  - 1,330 vehicles
  - 788 (59%) could go to DPS
  - Delivery/deployment within 4-5 months
- Delivery contingencies
  - Flexibility to substitute vehicles per availability
  - Manufacturer's capabilities



FY 10-11 expenditures include \$44 million legislatively mandated transfer to General Fund




## Replacement Vehicle Purchase History

## Projected April 2014 Fund Balance

Transfer of Lapsed Salaries from DPS	\$5.0M
Purchase Impalas (277) and EM vehicles (8) – round 2	(\$5.3M)
Ending Fund Balance at April 2014	\$10.0M
Operating Fund Balance Required (4 months)	\$10.0M



## New Vehicles for Public Safety

- Department of Public Safety has vehicle needs beyond those being replaced by DOA through its replacement schedule.
- Need for new vehicles predominantly driven by the reallocation of lower level probation/parole officers to field officers which require a 1:1 ratio of officer to vehicle, and the 2013 legislative funding of new probation/parole officer positions.
- Public Safety requested and OSBM authorized transfer of \$5,067,161 in lapsed salaries to Motor Fleet for purchase of 277 vehicles for probation/parole officers. These vehicles have not been purchased, as this potential expenditure will result in a deviation for the Motor Fleet fund.
