Clean Water Management Trust Fund 2014 Annual Report

Introduction

The Department of Environment and Natural Resources and the staff and Board of Trustees of the Clean Water Management Trust Fund (CWMTF) would like to thank the members of the General Assembly of North Carolina for your continuing strong support for investments in clean water and hereby presents our annual report to the General Assembly and the public pursuant to GS 113A-257.

Background

The 1996 General Assembly created the Clean Water Management Trust Fund (Chapter 113A Article 18 (GS 113A-251 et seq.)), "to clean up pollution in the State's surface waters and to protect, preserve and conserve those waters that are not yet polluted." As originally created, the CWMTF was to "use innovative and non-regulatory approaches to help finance projects that specifically address water pollution problems and focus on upgrading surface waters, eliminating pollution, and protecting, preserving and conserving unpolluted surface waters, including enhancement or development of drinking water supplies" and "to build a network of riparian buffers and greenways for environmental, educational, and recreational benefit."

Until July 2013, the CWMTF was an independent, non-regulatory agency housed for administrative-only purposes in the Department of Environment and Natural Resources (DENR). A 21-member board of trustees established criteria, allocated funds, reviewed applications, and approved grants through three principal committees: infrastructure wastewater, restoration/stormwater/greenways and land/conservation easement acquisition. Local governments, state agencies, and nonprofit conservation organizations, such as land trusts, were eligible applicants. As a grant making agency, funds were allocated to address and correct pollution problems and to protect unpolluted waters that are identified by eligible grant applicants.

Through 2014, the program – via appropriations from the General Assembly – has partnered with local communities and organizations to contribute nearly \$1B to the protection and restoration of the state's water. Further, the fund has leveraged approximately one and a half times as much money (\$1,500,000,000) to support those efforts to protect, restore and enhance surface water quality.

2014 Annual Report Clean Water Management Trust Fund November 25, 2014 Page 2 of 7 Today, CWMTF staff manages more than \$46 million encumbered in about 175 existing grant contracts. Staff work to ensure due diligence for monitoring grant requirements and expenditure of funds, while at the same time assisting the grantees successfully through the process by making the process transparent, clearly communicating the process and expectations, and providing meetings as needed and resources to guide them through project implementation.

The water quality grants this non-regulatory program provides help meet infrastructure needs of municipalities, increase recreational opportunities, and enhance quality of life in this state, all critical components for economic development. CWMTF protects more than the state's natural resources. The grants this program provides support North Carolina's major economies of agriculture, military, tourism, fisheries and forest products.

2014 Summary

Compared to the significant changes to the CWMTF made in the previous year, 2014 has been a relatively routine period. In February 2014, the offices and staff of the CWMTF were physically moved and integrated into NC DENR offices in the Nature Research Center on Jones St. in downtown Raleigh.

<u>Staffing:</u> Bryan Gossage, formerly Deputy Secretary with the NC Department of Commerce, has served as Executive Director since November 2013. The CWMTF is positioned as one of four sections within the Office of Land and Water Stewardship; for which Bryan Gossage also serves as Director. The division reports directly to the Office of the Secretary. The CWMTF saw attrition in the positions of deputy director and budget director. Instead of refilling those positions, the duties and responsibilities were spread out to other DENR sections and staff, thus creating a savings to the taxpayer without diminished service. One position – Administrative Assistant, was rehired upon the retirement of the former employee. A second position, vacant since May 2013, will be filled by the end of the current calendar year. All CWMTF personnel remain exempt from the North Carolina Human Resources Act. For additional information, see Attachment #1 – Organizational Chart.



Financial Administration

The appropriation to Clean Water Management Trust Fund (CWMTF) for FY 14/15 was \$14,157,000. Of that, up to \$1,250,000 may be used for the administration/operations of the Fund and up to \$750,000 may be used toward the inventory of natural areas by the Natural Heritage Program. In addition, \$300,000 shall be used toward the Jordan Lake Water Quality Improvement Demonstration Project, and another \$500,000 was directed from the FY14/15 Budget bill to be allocated for lake systems with a nutrient management strategy.



At the end of the 2013 calendar year, \$8,613,415 in funds transferred from the Natural Heritage Fund to CWMTF were applied to previously received applications to the Natural Heritage Trust Fund as outlined in Session Law 2013-360. The remaining amount of \$9,318,665 was awarded to the 2013 CWMTF grant applications as part of the 2013 cycle.

For fiscal year 2013-14, CWMTF received 105 grant applications totaling \$56,576,428. By utilizing grant prior-cycle contract under-runs (reversions), license plate revenues and annual appropriations, 41 grants were awarded totaling \$13,684,882. A request for proposal will be


