For the monies collected under this fund during October 1, 2003 through January 30, 2004, as itemized in the above table, AOC's plans to spend the funds in these major areas:

- Replacement and acquisition of computer equipment including hardware and software; and
- Receipt supported personnel for eight positions previously approved by the legislature. The annual cost of these eight positions is approximately \$240,000 on a semi-annual basis.
