Cost Increase for the SBI Crime Laboratory DNA/Database Basement Renovation Project

I am writing to report the increase of project costs associated with the SBI Crime Laboratory's DNA database renovation project and to satisfy the statutory Governmental Operations reporting requirement. As you may recall, during the past legislative session, the Department of Justice reported to the General Assembly the increasing backlog of DNA evidence and the need for additional resources and facilities to analyze this evidence in a more timely manner. The Department was authorized by the General Assembly to utilize "up to \$516,000 to expand the physical capacity of the Molecular Genetics Section and purchase equipment." Regrettably, when the department made its request, it underestimated the actual cost for this renovation project.

Because it is in the best interest of the State to have DNA evidence analyzed in a timely manner and because the actual cost of this project has been determined to be \$1,281,300, I have authorized the increase in project cost as outlined below. As you can see, the source of funds in addition to the authorized appropriation includes Surplus Property and Drug Tax receipts as well as \$587,017 from the legislatively authorized Repair and Renovation Fund.
