RE: Status Report on the Statewide Automated Fingerprint Identification System (SAFIS) Replacement Project

Dear Members:

Pursuant to Section 15.9.(c) of Session Law 2005-276, the Department of Justice (DOJ) submits this report to the Subcommittee for Justice and Public Safety of the Joint Legislative Commission on Governmental Operations to further update the committee on the status of the Statewide Automated Fingerprint Identification System (SAFIS) replacement project. The following information supplements the data provided in the last status report to the committee in November 2005.

Since this time, DOJ has developed and posted a Request for Proposal (RFP) and created the evaluation process to review submitted proposals. On February 23, 2006, a total of ten proposals were received from seven vendors in response to the RFP issued by DOJ. SAFIS replacement proposals were received from Cogent Systems, Motorola, and NEC Solutions (America), Inc. for core SAFIS operating system replacement. Seven vendors responded to the Master Purchasing Agreements portion of the RFP for latent workstations and livescan devices: Cogent Systems, Cross Match, DataWorks Plus, Identix, IdentiPro, Motorola, and NEC Solutions (America), Inc.

Preliminary assessments of proposals by the SAFIS evaluation teams indicate that costs for the SAFIS replacement are less than preliminary estimates provided in the November 2005 report. This competitive bidding process has attracted multiple vendors which have provided lower overall cost proposals when compared to a sole source or single vendor approach. Both lease financing and cash purchase options are currently being explored from all vendors.

The composition of the SAFIS evaluation teams is attached for your review. Teams include staff from DOJ, the Department of Correction, and the Mecklenburg County Sheriff's Office. Discussions and negotiations with vendors are in process and

recommendations are expected to be finalized on or about April 18, 2006. The timeline associated with the evaluation process along with a diagram of the evaluation process is included for review.

The Department of Justice awaits the Committee's guidance regarding future reporting on this subject. Discussions between legislative fiscal staff and DOJ have highlighted confidentiality requirements associated with this procurement, as they relate to Statewide IT Procurement statutes, policies and rules. The Department of Justice is fully committed to consulting with the legislature on a timely basis and in a manner that adheres to all applicable guidelines.

UPDATED SAFIS PROJECT TIMELINE


Phase 1 – Planning & RFP (07/05 - 04/06)

- 1) Procure an Automated Fingerprint Identification System (AFIS) subject matter expert
- 2) Planning, requirements, and documentation development
- 3) Prepare a Joint Status Report to be presented by November 1, 2005
- 4) Create the SAFIS Replacement RFP
- 5) Review vendor submitted proposals
- 6) Prepare and present recommendation for SAFIS Replacement by April 18, 2006

Phase 2 and 3 – Implementation & Deployment 1 & 2 (04/06 - 12/08)*

- 1) Replace existing SAFIS central processing systems
- 2) Implement SBI SAFIS Business Continuity system
- 3) Replace existing SBI remote latent search stations
- 4) Implement data conversion interface
- 5) Replace remaining latent search stations
- 6) Deploy new remote Live Scan devices
- 7) Replace existing remote Live Scan devices
- * Phase 2 and Phase 3 are subject to vendor contract negotiations, final review and approval by ITS, and final appropriations granted by the General Assembly
