For the monies collected under this fund during January 1, 2006 through July 31, 2006, as itemized in the above table, AOC plans to spend the funds in these major areas:

- Replacement and acquisition of computer equipment including hardware, software, and information technology services; and
- Receipt supported personnel for two positions previously approved by the legislature. The annual cost of the two positions is approximately \$70,614.70 on a semi-annual basis.
