Dear Senator Basnight and Speaker Hackney:

Pursuant to Section 15.3 of the Current Operations and Capital Improvements Appropriations Act of 2007, the State Highway Patrol reports its intent to use \$11,260 in Federal Seizure funds for the Law Enforcement Executive Development Program (LEED). These funds will help support a partnership between North Carolina State University and the North Carolina State Highway Patrol to send twenty members of the Patrol Command Staff to a series of four online training courses. These courses will be instructed by professors at North Carolina State University.

The first course "Beginning with the End in Mind": Use of the Organizational Culture Inventory (OCI) will be instructed by Dr. Jim Horner and will take twenty-four hours to complete. The second course, Practical Ethics for Law Enforcement Managers, will be instructed by Dr. Jim Brunet and will take twelve hours to complete. The third course, Legal Issues In Employment will be instructed by Dr. Ike Avery and will take twenty hours to complete. The fourth and final course, titled Intergovernmental Issues In Budgeting will be instructed by Dr. Charlie Coe and will take sixteen hours to complete.
