








## U.S. Renter Profile







#### 2018 Distribution of Ownership Types





# COVID-19 Economic Impact

#### Percent Change in Employment\*

In **North Carolina**, as of **August 10 2021**, employment rates among workers in the bottom wage quartile **decreased** by **23.7%** compared to January 2020 (not seasonally adjusted).


## Impact on Renters

• In January 2021, 1 in 5 adult renters were behind on their rent.

• As of October 2021, 1 in 7 adult renters were still behind on their rent.

## Rent Hardship Below January 2021 Peak, Yet Still Widespread

## Impact on Landlords

- A survey in August 2020 found that 35.4% of small landlords were using money from savings or emergency funds in response to the pandemic.
- In 2019, 3% of landlords were taking steps to sell their rental properties.
- In 2021, 13% of landlords were taking steps to sell their rental properties.
- In May of 2021, 28% of landlords reported deferring maintenance on at least one rental unit during the pandemic.

#### August 2020

Governor Cooper announced \$94 million in funding from CDBG-CV and CRF for a statewide rent and/or utility assistance program.



#### November 2020

Applications for the HOPE Program closed.

NCORR opened applications for the Housing Opportunities and Prevention of Eviction Program.

## HOPE 2.0

- On May 17, 2021, NCORR opened applications for the second phase of the HOPE Program.
- The HOPE Program serves 88 counties in N.C.
- Funded through the U.S. Department of Treasury Emergency Rental Assistance Program.



# HOPE 2.0 Accomplishments

- According to NCORR, rent and utilities are paid within 14-20 days of application.
- HOPE had awarded 72% of ERA 1 funding by September 30, 2021.
- HOPE ranks 6<sup>th</sup> in the nation for spending of federal ERA money and 3<sup>rd</sup> in the nation for households assisted.


# Research Question 1

- HOPE 2.0 pays out \$2,971,096.20 and 1,180 assistance awards daily.
- As of November 10, 2021, HOPE 2.0 had obligated \$450,649,320.62 for 173,984 households.
- As of November 9, 2021, HOPE 2.0 paid out \$374,358,121.16 for 148,699 households.




# Denied Applications

# U.S. Treasury Guidance

- "ERA grantees must comply with the requirements outlined in their ERA Award Terms, including the relevant ERA statute, all other applicable federal statutes, regulations, executive orders, and Treasury's guidance (FAQs, reporting guidance, etc.)." U.S. Treasury ERAP Website
- Discouraged Practices for ERAP:
  - Establishing eligibility requirements beyond those required by statute or Treasury's FAQs.
  - Creating barriers to the program.



## Landlord Application

#### **Federal Law**

"If a landlord or owner of a residential dwelling submits an application for assistance from a payment made under this section on behalf of a renter of such dwelling..."

-P.L. 116-260

#### **NC HOPE Program**

"Landlords cannot apply for the HOPE Program, but they can refer distressed tenants to the program."

"Landlords are critical beneficiaries and stakeholders of the ERA program."

## Utility-Only Application

#### **Federal Guidance**

"A grantee is not required to provide assistance with respect to rent in order to provide assistance with respect to utility or energy costs."

-ERA FAQ 19, U.S. Treasury

#### **NC HOPE Program**

"Utility-only applications will not be accepted in this phase of the HOPE Program."

## Housing Stability Services

#### **Federal Guidance**

Rental assistance can cover hotel costs for eligible households that are temporarily displaced from a permanent residence.

-ERA FAQ 26, U.S. Treasury

#### **NC HOPE Program**

The HOPE Program does not cover hotel costs.

# Housing Stability Services

"Expends funds on housing stability services provided by community-based and nonprofit organizations to keep people housed and meet essential household needs."

-U.S. Treasury ERAP Strongly Encouraged Best Practices and Policies



#### Months of Assistance

#### **Federal Law**

Eligible households may receive up to 12 months of assistance plus an additional 3 months if necessary to ensure housing stability for an eligible household. This can include up to 12 months of rental arrears.

-P.L. 116-260

#### **NC HOPE Program**

From May 17<sup>th</sup> – October 1<sup>st</sup>, 2021, the HOPE Program only covered 12 months of assistance and up to 9 months in rental arrears.

On October 1<sup>st</sup>, increased total months of assistance to 15 months and up to 12 months in rental arrears.



#### Late Fees

#### **Federal Guidance**

Allows for funds to cover, "reasonable accrued late fees."

-ERA FAQ 7, U.S. Treasury

#### **NC HOPE Program**

"[Landlord] agrees to waive any late fees, penalties or charges (outside of rent) incurred between April 1, 2020, and 60 days from the [time assistance ends]."

## Rent and Utility Awards

#### S.L. 2021 - 25

"[NCORR] shall provide awards to recipients...based upon the actual amount of monthly rent owed by the tenant pursuant to the rental agreement or the actual amount of utility costs owed by the recipient and shall not be subject to any allowable average or formula-based calculation."

#### **NC HOPE Program**

May 17<sup>th</sup> – July 31<sup>st</sup>, 2021, "Pays the rent an applicant owes up to the fair market rent of the 2-bedroom unit for that county."

Covers back-owed utilities up to a maximum amount.

- Electricity: up to \$510
- Natural gas and propane: up to \$135
- Water: up to \$105
- Wastewater: up to \$120



## Rent and Utility Awards

#### S.L. 2021 - 25

"[NCORR] shall provide awards to recipients...based upon the actual amount of monthly rent owed by the tenant pursuant to the rental agreement or the actual amount of utility costs owed by the recipient and shall not be subject to any allowable average or formula-based calculation."

#### **NC HOPE Program**

"Pays the rent an applicant owes up to a cap equal to 130% of the 2-bedroom unit fair market rent cap for that county."

Covers back-owed utilities up to a maximum amount.

- Electricity: up to \$1,020
- Natural gas and propane: up to \$270
- Water: up to \$210
- Wastewater: up to \$240



## Comparison to Local Programs

Requirements	N.C. HOPE Program	Local ERA Programs
Landlord Application	X	12 out of 12
Utility-Only Application	*In-Process*	12 out of 12
Cover Hotel Costs	×	10 out of 12
Late Fees	X	10 out of 12
Pay Full Rent & Utilities	X	11 out of 12



#### Recommendations

• NCORR eliminate artificial barriers and eligibility requirements of the HOPE Program that go beyond what is required by federal statute and U.S. Treasury guidance.
