Re: Alarm System Licensing Board, Chapter 74D

Dear Senator Hartsell and Representative Jordan:

I am writing in my role as the current president of the North Carolina Electronic Security Association (NCESA) which is a trade association made up of Alarm dealers, installers and monitoring companies. First, we wish to express our appreciation for allowing representatives of our Association to speak to the Administrative Procedure Oversight Committee regarding our opposition to the repeal of Chapter 74D of the North Carolina General Statutes. We are perplexed as to how the Alarm Systems Licensing Board was inserted into the proposed legislation since the Program Evaluation Study did not include the Alarm System Licensing Board (ASLB) and it was not discussed in the committee or subcommittee.

Our membership and leadership are united in our support of the ASLB and feel that the Board provides valuable protections to the general public to establish standards and enforce those standards for those entering our citizens' homes. Our industry exists to protect not only people's homes and businesses, but also their lives and the lives of their family.

The Board also safeguards the information about how to avoid the alarms that are installed or other ways to get around the protections that many of our citizens have in their homes. This information is not only known by the installers of the systems, but also all those who work in the business who could access those records. It is important to remember that we not only install alarms in people's homes, but also in schools, hospitals, churches, and courthouses.

We spoke to several legislators on the committee who feel the inclusion of the Alarm Systems Licensing Board would be a mistake and agree with the comments made at the end of the meeting that this is not the licensing board that should be repealed in our efforts to lessen regulation. We understand that further study will be done regarding the repealing and combining of licensing boards, and we respectfully request that if the ASLB is still being considered that we be permitted to speak to the Committee about our concerns and provide information about the viewpoint of the industry that is regulated.
