- 11) **The substance of any anticipated change in rules adopted by the occupational licensing board or the substance of any anticipated adoption of new rules by the occupational licensing board. –** The Board has approved several rule changes which will be considered by the Rules Review Commission. These changes are being made to allow 100% supervision over web conferencing, and 100% online CE training. The rule changes also update clinical terms.
