Year Ended June 30, 2021**

This section of the Board's financial report represents Management's analysis of the Board's financial performance during the year ending June 30, 2021. Please read it in conjunction with the financial statements which follow this section.

Financial Highlights

During the year ended June 30, 2021, the Board's net position increased by \$204,036, or 16%, due to the Board's operating revenues exceeding its operating expenses.

During the year ended June 30, 2021, the operating revenues of the Board increased by \$38,664, or 5%, due primarily to an increase in written test fees and registration fees.

During the year ended June 30, 2021, the operating expenses of the Board increased by \$20,043 or 3%, due primarily to an increase in criminal background checks, evaluation expenses, and professional fees.

Overview of the Financial Statements

This financial report consists of two sections: Management's Discussion and Analysis and the Financial Statements. The Board has no other supplementary information required by Governmental Accounting Standards Board (GASB) Statement No. 34. The Financial Statements also include notes to the financial statements that provide detail of the information included in the financial statements.

Basic Financial Statements

The financial statements of the Board report information about the Board using accounting methods similar to those used by private sector companies.

The Statement of Net Position presents the current and long-term portions, if any, of assets and liabilities separately.

The Statement of Revenues, Expenses, and Changes in Fund Net Position presents information on how the Board's net position changed as a result of its operations.

The Statement of Cash Flows presents information on how the Board's cash changed as a result of its financial activities.

In 2021, the Board approved new bylaws to reflect its new appointed nine member composition. The new bylaws are similar to the previous bylaws but allow for one year terms of officers to be elected at the first annual meeting of the Board.

In response to the COVID-19 pandemic, the Board continued to meet virtually over teleconference platforms and in-person, which allowed board operations to continue more or less seamlessly.

In April 2021, the Board voted to approve Administrative Rules that would allow 100% online continuing education and supervision.

1. NATURE OF ACTIVITIES

North Carolina Addictions Specialist Professional Practice Board (the Board) is an independent state agency. It is an occupational licensing board and is authorized by Chapter 90 of the North Carolina General Statutes. The Board is composed of 25 members, in which some are appointed by the Governor and the North Carolina General Assembly. Effective July 1, 2020, the Board's structure was modified to a nine-member body all appointed by the Governor and the North Carolina General Assembly. It is a nonmajor enterprise fund of the primary government of the State of North Carolina and is reported as such in the State's Comprehensive Annual Financial Report (CAFR).

The Board is established to maintain minimum standards for services provided by addiction specialist professionals.

The Board's operations are financed with self-generated revenues from fees charged to licensees.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Reporting Entity

The concept underlying the definition of the financial reporting entity is that elected officials are accountable to their constituents for their actions. As required by accounting principles generally accepted in the United States of America (GAAP), the financial reporting entity includes both the primary government and all of its component units. An organization other than a primary government serves as a nucleus for a reporting entity when it issues separate financial statements. The accompanying financial statements present all funds and activities for which the Board is responsible.

For financial reporting purposes, the Board is a nonmajor enterprise fund of the primary government of the State of North Carolina and is reported as such in the State's Comprehensive Annual Financial Report (CAFR). These financial statements for the Board are separate and apart from those of the State of North Carolina and do not present the financial position of the State nor changes in the State's financial position and cash flows.

Basis of Presentation

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America. The Governmental Accounting Standards Board (GASB) is the accepted standard setting body for establishing governmental accounting principles and reporting standards.

All activities of the Board are accounted for within a single proprietary (enterprise) fund. Proprietary funds are used to account for operations that are financed and operated in a manner similar to private business enterprises where the intent of the governing body is that the cost of providing goods or services to the general public on a continuing basis be financed or recovered primarily through user charges.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Accordingly, actual results could differ from those estimates.

Investments

The Board is authorized to invest idle funds in accordance with North Carolina General Statutes. This classification consists of mutual funds, common and preferred stocks, and corporate bonds held by the Board for investment. Investments are stated at fair value.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Basis of Accounting

The basic financial statements of the Board are prepared using the economic resource measurement focus and the accrual basis of accounting. The economic resource measurement focus measures all assets that are available to the entity, not only cash or soon to be assets. Both long-term assets and long-term liabilities are measured and depreciation is recorded as a cost of operations. Under the accrual basis of accounting, revenues are recognized when earned, and expenses are recorded when a liability has been incurred, regardless of the timing of cash flows.

The Board classifies its revenues as operating and non-operating in the accompanying Statement of Revenues, Expenses, and Changes in Net Position. Operating revenues and expenses generally result from providing services that are necessary to the Board's principal ongoing operations. Operating revenues consist primarily of license fees and include activities that have characteristics of exchange transactions. Operating expenses are all expense transactions incurred other than those related to capital and noncapital financing or investing activities as defined by GASB Statement No. 9, *Reporting Cash Flows of Proprietary and Nonexpendable Trust Funds and Governmental Entities That Use Proprietary Fund Accounting*. Non-operating revenues and expenses consist of those revenues and expenses that are related to investing, capital, and non-capital financing activities; and are classified as non-operating in the financial statements.

Cash

This classification includes undeposited receipts, petty cash, and checking accounts.

Revenue Recognition

The Board's license fees are assessed and collected every two years, which begins with each respective licensee's license inception date, and ends on each respective licensee's subsequent second-year anniversary date. License renewal fees are recognized as revenue in the period received and are not deferred and recognized as revenue over the periods to which they relate. This revenue recognition method reasonably reflects the income of the Board.

3. DEPOSITS

At June 30, 2021, the Board's deposits had a carrying amount of \$374,028 and a bank balance of \$374,746, which was covered by federal depository insurance to the extent of the \$250,000 per depositor FDIC limit.

4. RISK MANAGEMENT

The Board is exposed to various risks of loss related to torts; theft of, damage to, and the destruction of assets; errors and omissions; and natural disasters. These exposures to loss are handled by participation in state-administered risk programs and self-retention of certain risks. The Board protects itself from exposure to loss through the purchase of commercial insurance coverage.

5. CONTINGENCIES

The Board is involved in occasional disciplinary hearings throughout the year which arise in the ordinary course of its operations. In the opinion of management of the Board, the results of such actions during the year under audit do not materially affect the Board's operations, changes in financial position or cash flows for the year herein ended.

The COVID-19 pandemic has created economic uncertainties which may continue to impact the Board's operations and net position. The extent of the impact of COVID-19 on the Board's operational and financial performance will depend on certain developments including the duration and spread of the outbreak. The related financial impact cannot be reasonably estimated at this time.

6. NET POSITION

The net position of the Board is classified as follows:

Net investment in capital assets – This component of net position consists of capital assets, net of accumulated depreciation. As of June 30, 2021, the Board had no investment in capital assets.

Restricted net position – expendable – This component of net position consists of net position which the Board is legally or contractually obligated to spend in accordance with restrictions imposed by external parties. As of June 30, 2021, the Board had no restricted net position – expendable.

Unrestricted net position – This component of net position consists of the net position that does not meet the definition of restricted net position or net investment in capital assets.

7. INVESTMENTS

The Board is subject to the following risks:

Credit risk – Credit risk is the risk that an issuer or counterparty to an investment will not fulfill its obligations. Investments of the Board are subject to the statutory requirements of North Carolina General Statutes, however the Board's present policy for managing credit risk is to limit its investments to mutual funds, common and preferred stocks, and corporate bonds.

The Securities Investor Protection Corporation (SIPC) is a nonprofit member corporation funded by its member securities broker-dealers. The SIPC insures against the loss or theft of securities as well as the failure or insolvency of the brokerage firm. At June 30, 2021, the Board owned investments that exceeded the SIPC limit of \$500,000 by \$554,871.

Interest rate risk – Interest rate risk is the risk the Board may face should interest rate variances affect the fair value of investments. As a means of limiting its exposure to fair value losses arising from market fluctuations and interest rate variances, the Board limits its investments to mutual funds, common and preferred stocks, and corporate bonds.

8. CONTRACTUAL MANAGEMENT SERVICES

The Board does not have any employees. The Board has an annual contract with a company located in Raleigh, North Carolina to provide administrative services. The contract includes all services related to the process of the license application, license renewal, testing, and various other duties. The Board also reimburses the management company for miscellaneous office supplies and expenses. The amount paid under the contract during the year ended June 30, 2021, was \$424,000.

9. FAIR VALUE MEASUREMENT

Fair value, as defined under U.S. GAAP, is an exit price representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. U. S. GAAP establishes a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value. These tiers include:

Level 1: Observable inputs such as quoted prices in active markets.

Level 2: Inputs other than quoted prices in active markets that are either directly or indirectly observable.

Level 3: Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Board's assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

The following table sets forth by level, within the fair value hierarchy, the Board's financial assets accounted for at fair value on a recurring basis as of June 30, 2021:
