The Board still hopes to address with the General Assembly the 20 year exemption for all licensees, teacher exam for natural hair care specialist, set hour requirements for teachers to 500 hours and require only one teacher exam, remove the requirement for shops to submit a list of employees or a booth renters and request some fee changes which have not been increased in over 30 years.
