(7b) The number of disciplinary actions taken against licensees, or other actions taken against non-licensees, including injunctive relief:
• In fiscal year 2011-2012, one matter was turned over to a local district attorney's office. This person was accused of fraudulently using the credentials Registered Dietitian and a false social-security number. This person was charged with attempting to obtain property through false pretenses. On March 14, 2013 this person pled guilty to these charges, and was sentenced to eleven to fourteen months imprisonment. This sentence was suspended, however, on the condition that this person serve thirty-six months on supervised probation. The judge also required that this person surrender any professional license this person may possess and that this person must not misrepresent this person's credentials, professional status or training to

(1a) The total number of licensees supervised by the Board:

any perspective employer.

In April of 2014 the NCBDN received another complaint regarding this same person which, upon investigation, revealed this person had stolen the LDN license of two different licensees, and was applying for jobs using their licensees. This matter was once again turned over to the local prosecutor to take action if warranted.

- One cease and desist letter was sent to an unlicensed person who was advertising herself as a licensed dietitian/nutritionist and advertising nutrition care services.

    this point it would be premature to provide any specific language. If an anticipated amendment
    request becomes more concrete, the Board will be happy to supplement this report.

## 21 NCAC 17.0404 DECLARATORY RULINGS

- (a) The issuance of a declaratory ruling by the Board is governed by G.S. 150B-4.
- (b) A request for a declaratory ruling shall be in writing and addressed to the Board. The request shall contain the following information:
  - (1) The name and address of the person requesting the ruling;
  - (2) The statute or rule to which the request relates;
  - (3) A concise statement of the manner in which the person has been, or may be aggrieved by the statute or rule; and
  - (4) A statement as to whether a hearing is desired, and if desired, the reason therefore.
- (c) The Board shall refuse to issue a declaratory ruling under the following circumstances:
  - (1) When the Board has already made a controlling decision on substantially similar facts in a contested case.
  - (2) When the facts underlying the request for a ruling on a rule were specifically considered at the time of the adoption of the rule in question; or

(3) When the subject matter of the request is involved in pending litigation in North Carolina.

## 21 NCAC 17.0405 PETITIONS FOR ADOPTION, AMENDMENT OR REPEAL OF RULES

- (d) The procedure for petitioning the Board to adopt, amend, or repeal a rule and for the Board's response is governed by G.S. 150B-20.
- (e) Rule-making petitions shall be sent to the Board. No special form is required, but the petitioner shall state his or her name and address. The petition shall include:
  - (5) A draft of any proposed rule or amendment to a rule;
  - (6) The reasons for the proposal;
  - (7) The effect of the proposal on existing rules or decisions:
  - (8) Any data supporting the proposed rule change;
  - (9) Practices likely to be affected by the proposed rule change; and
  - (10) Persons likely to be affected by the proposed rule change.
- (f) The Board, based on a study of the facts stated in the petition, whether the public interest will be better served by granting or denying the petition, and any other relevant information, shall make a decision as to whether to grant or deny the petition.

## 21 NCAC 17.0406 RULE MAKING NOTICE

Persons or agencies desiring to receive individual notice of the Board's rule making shall file a written request with the Board furnishing their name, mailing address, and electronic mailing address, if applicable.
