- The Board issued two consent orders. One of them resulted in the licensee's license being suspended for forty days, with the licensee on probation, and the forty day license suspension stayed for so long as the licensee complied with the consent order, G.S. Chapter 90, Article 25, and the Board's Administrative Rules. The other, resulted in the licensee's license being suspended for thirty-six months, with the licensee on probation, and the thirty-six month license suspension stayed for so long as the licensee complies with the consent order, G.S. Chapter 90, Article 25, and the Board's Administrative Rules.

- The Board turned over two complaints received against the same non-licensed person to a local District Attorney noting that the Respondent is currently on probation for actions involving past violation of the Dietetics/Nutrition Practice Act.
- One person withdrew her application for licensure in order to avoid discipline. This person was previously licensed by this Board, and the Board viewed the withdrawal in order to avoid discipline as voluntary surrender of her license.

(8) The number of licenses suspended or revoked:

- The Board issued two consent orders. One of them resulted in the licensee's license being suspended for forty days, with the licensee on probation, and the forty day license suspension stayed for so long as the licensee complied with the consent order, G.S. Chapter 90, Article 25, and the Board's Administrative Rules. The other, resulted in the licensee's license being suspended for thirty-six months, with the licensee on probation, and the thirty-six month license suspension stayed for so long as the licensee complies with the consent order, G.S. Chapter 90, Article 25, and the Board's Administrative Rules.
- One person withdrew her application for licensure in order to avoid discipline. This person was previously licensed by this Board, and the Board viewed the withdrawal in order to avoid discipline as voluntary surrender of her license.

- House Bill 796, which would amend and modernize the NC Dietetics/Nutrition Practice Act, passed through the House this past 2015 session, but currently sits in the Committee on Rules and Operations of the Senate. The NCBDN is fully supportive of this Bill, and is hopeful that it will be taken up in the Spring 2016 session.

Although no specific language has been devised, it is anticipated, that should HB 796 become law, many rules will need to be amended and/or new rules adopted in accordance with the revised legislation.
