2018-2019 North Carolina Board of Recreational Therapy Licensure (NCBRTL) Report During 2018-2019 NCBRTL has increased our online presence with the majority of applications, renewals and maintenance applications were completed and paid online; the majority of complaints/misconduct incidents were also submitted on line.

A Records Manager was hired to separate financial duties, maintain hard files and receive mailed items. Executive Director moved from Durham Location but files remained as well as post office mailing address in Durham.

Two new Board members were appointed, Cari Sipe Owens, LRT, employed with Carolina Meadows, Chapel Hill, Dr. Russ Greenfield, employed with Novant, Dr. Judith Kinney, UNCG was re-appointed. The Practicing LRTA Member's term ends June 30, 2019.

Rules: NCBRTL completed the ten-year Periodic Review with Rules Review successfully with no changes. NCBRTL anticipates a few updates to Rules in Fall 2019

NCBRTL issued new 147 licenses to applicants

Out of State applicants increased slightly this year.

NCBRTL eased the application process by removing all deadlines for new applicants. New license applications are processed and issued licenses as packets are received complete. New licenses and numbers are assigned online the day of approval. On average, NCBRTL approved 12 license per month; the larger months being, May (19), October (19) due to completion of internships and exam offering dates. January (18), August (18) and June (17) being the next lower months. The least received in April, March and November.

Compliance and Ethics Training continues to assist licensees in understanding the law, Rules and requirements. NCBRTL continues to have fewer compliance issues and disciplinary actions due to these issues. It was offered four times this year. This included a special request by one hospital to have their entire staff attend therefore it was offered in-house. Outside participants were welcome. It was offered for the first time through webinar services at the August session. It was well received especially those licenses out of state. NCBRTL will set deadline for accepting webinar registrations for credit to postmark two weeks following the session.

Disciplinary Actions take in 2018-2019

Compliance Issues:

12 Missed Maintenance, they were placed on Probation for the amount of time they practiced with expired license, required to attend Compliance and Ethics Training, issued reinstated license. Reinstated after completion of application and missing requirement (Maintenance or Renewal)

Issued (3) Notifications to individuals reportedly practicing or using credential prior to being licensed

Issued three (3) Letters of Education about NC RT License law to agencies advertising for RTs without indicating state licensure requirement.

Contacted 5 agencies by phone to discuss position postings that as stated would allow for violations of the state law. All agencies responded by changing their postings or explained they advertised out of a central office nationwide but were aware of state laws.

Misconduct:

One license was Revoked for repeated offences involving patients and inappropriate behavior by the therapist and one incident of physical harm to patient.

Two licenses Suspended for practicing without a license.

One Licensee was placed on Probation and restricted from Internship supervision for one year for resigning without prior notice, leaving a student without supervision during an internship.

Unsubstantiated Report investigated.

One Complaint against a LRT by coworker filed but was unsubstantiated by Agency Supervisor. No action taken

Future Goals and Plans

NCBRTL reinitiated the Internship Supervisor Training Task Force in May 2017. NCBRTL plans to complete these training modules for Recreational Therapy Internship agencies to assist in the development of more consistent internship programs and manual development across the state.

NCBRTL is developing an update of the website to include additional option for online payments, ability to upload required documents and ease of use. Anticipate completion by end of the summer or early fall.
