Dear Committee Co-Chairs:

Pursuant to Session Law 2018-69 titled "An Act to Assist the Criminal Law Recodification Working Group," the NC Social Work Certification and Licensing Board ("Board") is providing you with information regarding all crimes defined by the Board. The Board's practice act can be found in Chapter 90B of the North Carolina General Statutes, specifically §§90B-11 through 90B-12.

The only reference to criminal conduct in the Board's practice act is found at N.C.G.S. §90B-12 as follows:

**§ 90B-12. Violation a misdemeanor.**

Any person violating any provision of this Chapter is guilty of a Class 2 misdemeanor. (1983, c. 495, s. 1; 1993, c. 539, s. 654; 1994, Ex. Sess., c. 24, s. 14(c).)
