

## BURKE COUNTY CODE OF ORDINANCES

(All references herein are to the Burke County Code of Ordinances, published 2018)

Chapter 1 – General	<b>§1-6(a) General:</b> Failure to comply with any provision of this Code, or any ordinance of the County to which no specific penalty is affixed.
Chapter 6 – Animals	<b>§6-11(b),(c), and (d) General/Interference with Enforcement:</b> Prohibits obstruction or interference with animal control officers, release of animals in custody of animal control, and reporting false information. <b>§6-131(b) Remedies:</b> Violation of any provision of this Chapter. Imposes specific penalties for dangerous animals and animal cruelty.
Chapter 10 –Building and Building Regulations	<b>§10-28 Housing Code:</b> Violation of any provision of this Article. Imposes specific penalties for failure to comply with administrator’s order. <b>§10-29 Alternative Remedies:</b> Can abate nuisances by criminal process.
Chapter 14 – Businesses	<b>§14-28 General:</b> Failure to obtain license, or otherwise violate, this Article (massage parlors). <b>§14-137 Adult Establishments:</b> Violation of any provision of this Article.
Chapter 20 – Civil Emergencies	<b>§20-8 General:</b> Violation of any provision of this Chapter, or plans issued pursuant to this Chapter, or obstruct or delay any member of an emergency management organization.
Chapter 22 – Emergency Services	<b>§22-1(c) General:</b> Prohibits misuse of 911 system, or to falsely report a nonexistent emergency. <b>§22-26 Ambulances:</b> Prohibits operating an ambulance without a County franchise. <b>§22-56 Emergency Rescue Services:</b> Prohibits operating a rescue service unit without a County franchise.
Chapter 26 – Environment	<b>§26-212 Abandoned Vehicles/Abandoned Mobile Homes/Recycle Center//Fats, Oils and Greases:</b> Violation of any provision of these Articles. County’s costs to remove these are recoverable.

**§26-282 Noise:** Prohibits exceedingly loud noises and certain designated noises between 11:00pm and 7:00 am.

Chapter 30-Fire Prevention  
and Protection

**§30-28 Fire Prevention Code:** Violation of any provision of this Chapter.

Chapter 34 – Floods

**§34-12 General:** Violation of any provision of this Chapter, or of conditions given for variances or exceptions.

**§34-48 Administration:** Failure to comply with an order to take corrective action.

Chapter 42 – Mass  
Gatherings

**§42-3 General:** Violation of any provision of this Chapter, for gatherings of 2000 or more people for more than 24 hours, or failure to obtain a permit for such a gathering.

Chapter 50 – Parks  
and Recreation

**§50-123 Use of Parks and Recreation Facilities:** Prohibits violation of any regulation governing the use of a County park or recreational area

Chapter 62 –  
Subdivisions

**§62-232 Legal Provisions:** Prohibits subdividing land except in accordance with this Chapter, or selling land pursuant to an unregistered plat or survey.

**§1803 Violations:** Violation of any provision of this Ordinance, or failure to perform any act required hereunder, or the performance of any act forbidden hereunder.

Legal Provisions

**§1300 Penalties for Violation:** Violation of any provision of this Ordinance.
