The following Report outlines Hertford County Ordinances that are punishable as criminal offenses pursuant to G.S. 14-4(a), and is submitted in response to Senate Bill 584 and House Bill 379, as of the date set forth below:


Ordinance Punishable by G.S. 14-4(a)	Description of Conduct Subject to Criminal Punishment under the Ordinance
1. Ordinance Prohibiting the Hunting for and Taking of Game from Public Roads, Streets, and Highways in Hertford County Enacted 12/2/1980	Hunting or discharge of firearms from, on, across or over the roadway or right-of-way of a public road
2. Ordinance Prohibiting Fishing from Designated Bridges in Hertford County Enacted 4/19/1982	Fishing from four designated bridges on highways over rivers or creeks
3. Hertford County Subdivision Ordinance Enacted 12/15/1986	Violating comprehensive regulations regarding subdivision of land; including excluded lots, minor and major subdivisions, plat requirements, improvements required including roadways, and approval process
4. Removal and Disposal of Abandoned or Junked Motor Vehicle Ordinance Enacted 5/1/1989 As Amended 11/5/1990	Abandoning or allowing any partially dismantled, nonoperating, junked, or discarded motor vehicle to be abandoned on property under one's control
5. Mobile Manufactured Home Park and Travel Trailer/RV Park Ordinance Enacted 5/17/1993	Violating specified regulations regarding mobile home parks and travel trailer parks, including allowable locations of such parks, lot sizes, and required services
6. Solid Waste, Recycling, Collection and Disposal Ordinance Enacted 11/20/1995	Violating specified regulations regarding the storage, transportation, use, and disposal of solid wastes, including illegal dumping and littering
7. Noise Control Ordinance Enacted 6/17/1996	Violation of maximum permitted decibel levels of outlined activities in outlined areas of county

8. Ordinance Levying Tax on Gross Receipts from Retail Short-Term Lease or Rental of Motor Vehicles Enacted 6/19/2000	Failure to report and pay a one and one-half percent (1.50%) tax on gross receipts from short-term motor vehicle rentals
9. Animal Control Ordinance Enacted 8/2/2010	Violation of specified regulations by owners of domestic animals, including restraint requirements, nuisances, and vicious animals; interference with County Animal Control Officer
10. Hertford County Zoning Ordinance Enacted 12/15/1986 As Amended 7/1/2015	Violating comprehensive regulations regarding permitted, conditional, and prohibited uses allowed on lands in Hertford County, including setting forth zoning districts throughout the county, excluding lands within municipal corporations and their ETJ's; outline of duties of Planning Board and Zoning Board of Adjustment
11. Ordinance Regulating the Provision of Ambulance Services and Granting of Franchises to Ambulance Service Providers in Hertford County Enacted 8/19/2002 As Amended 6/19/2017	Violation of specified regulations prohibiting certain defined ambulance services within the county without obtaining a County Franchise that is granted only under certain specified conditions
12. Fire Protection and Prevention Ordinance Enacted 1/7/2019	Violation of Comprehensive regulations regarding fire hazards, fire safety, building code requirements, inspections, repairs; interference with County Fire Marshall or designees
