The Unified Development Ordinance consists of the Randolph County Zoning Ordinance, the Randolph County Subdivision Ordinance, the Watershed Protection Ordinance, and the Randolph County Flood Damage Prevention Ordinance. Chapter Two, Zoning; Article XIII, Administrative and Legal Provisions; Section 9, Remedies; Enforcement Action provides: Enforcement may be by any remedy authorized by common law or statute, including but not limited to injunctive relief, civil penalties (up to \$500) and criminal penalties uner NCGS 14-4 with a maximum fine of \$500 per violation with each day of continued violation constituting a separate and distinct offense for purposes of criminal prosecution. Chapter Two, Zoning; Article XV, Abandoned, Nuisance and Junked Motor Vehicles, Sections 22 and 23 provide: Fines and civil and criminal penalties shall be in accordance with Chapter Two, Zoning: Article XIII, Administrative and Legal Provisions, Section 9 but any fines assessed in this section shall be considered a lien against the motor vehicle owner's property or the property on which the motor vehicle is located until such fine is paid in full. Chapter Two, Zoning: Article XVI. Litter Ordinance: Sections VIII and IX reference the civil and criminal penalties for violation that are referenced in Chapter Two. Article XIII. Sections 8 and 9 but provides that as outlined in G.S. 153A-132.1, a person in violation of this ordinance may be punished by a fine not exceeding \$50.00 or imprisoned not exceeding 30 days, or both and that each day or portion thereof of violation shall constitute a separate offense. Chapter Three, Subdivisions; Article IV, Legal Provisions; Section 13, Enforcement provides that a violation is a Class 1 misdemeanor. It also provides that the county may institute any appropriate action or proceedings to prevent the unlawful subdivision of land, to restrain, correct or abate the violation or to prevent any illegal act or conduct. Chapter IV. Watershed Protection Ordinance; Article I, Authority and General Regulations; Section 6, Compliance and Code Enforcement provides for civil penalties of not less than \$500 per day for each day of violation for as long as the violation occurs. It provides that any person who violates the ordinance negligently is guilty of a class 2 misdemeanor, which may include a fine of \$500 per day adn that any person who knowlingly violates the ordinance is guilty of a Class C felony which may include a fine of not less than \$500 per day of violation. Chapter V, Flood Damage Prevention Ordinance: Article III. General Provisions; Section H, Penalties for Violation provides that it may be enforced in accordance with Chapter Two, Article XIII, Section 9 which sets out both criminal and civl penalties for violation as outlined above.
