*The following table sets forth code sections, violations of which impose a criminal penalty. This listing excludes civil penalties as well as provisions imposing only civil (not criminal) fines and penalties. Violation of numerous code sections triggers a default application of the code's general penalty.*

**NOTE re GENERAL PENALTY in County Code**

County code § 1-11(c) establishes that a code violation is a **misdemeanor** offense with a **criminal penalty**, *unless otherwise specified*, **punishable by a fine not more than \$500**. No imprisonment is provided with the general penalty.
