As to criminal penalties, section 7-1.1 provides that violations of Chapter 7 are misdemeanors subject to penalties under G.S § 14-4. Due to conflicting penalty sections in other articles of the chapter, it appears that the word "chapter" in this section was intended to be "article".

² As to criminal penalties, section 7-10 provides that violations of article I and IA of the chapter are misdemeanors subject to a fine of \$500.00 and up to 30 days incarceration. The listed sections 7-2 through 7-6.1 are thus subject to two conflicting penalties. For purposes of this list, it is assumed that 7-10 was not intended to cover article I, but only article IA.

³ Article II includes the town fire code and various divisions regarding sprinkler systems. Section 7-1-1 provides that violations of the fire code are misdemeanors punishable under G.S. § 143-138. Some of the sprinkler system related sections have different and conflicting penalties as listed.

NOTES RE TOWN'S GENERAL PENALTY SECTION

Town Code § 1-7 provides: "Whenever in this Code or in any ordinance of the city any act is prohibited or is made or declared to be unlawful or an offense or a misdemeanor or whenever in such Code or ordinance the doing of any act is required or the failure to do such act is declared to be unlawful, where no specific penalty is provided therefor, the violation of any such provision of this Code or other ordinances shall be punished by a fine not exceeding \$50.00 or by imprisonment for a term not exceeding 30 days."

- G.S. § 160A-175(b) provides: "Unless the Council shall otherwise provide, violation of a city ordinance is a misdemeanor or infraction as provided by G.S. 14-4. An ordinance may provide by express statement that the maximum fine, term of incarceration, or infraction penalty to be imposed for a violation is some amount of money or number of days less than the maximum imposed by G.S. 14-4.
- G.S. § 14-4 provides, in pertinent part: "Any person [who] shall violate an ordinance ... shall be guilty of a Class 3 misdemeanor and shall be fined not more than \$500.00. No fine shall exceed \$50.00 unless the ordinance expressly states that the maximum fine is greater than \$50.00."
- G.S. § 14-3 provides that the maximum punishment for a Class 3 misdemeanor is a fine of up to \$500.00 and incarceration of up to 30 days.
