List of Ordinances punishable as provided by GS 14-4(a).

Chapter 92 § 92.15-92.56	Control of Solid Waste	Unlawful violate a series of ordinances related to the storage and dumping of solid waste; including abandoned and junked vehicles
Chapter 93 § 93.01	Interference with Firefighters; False Alarms	Unlawful to interfere with firefighters; unlawful to willingly make a false alarm.
Chapter 93 § 93.02	Interference with Fire Department Vehicle	Unlawful ride on fire equipment without permission; unlawful to impede fire equipment.
Chapter 93 § 93.03	Congregating at Fires	Unlawful to congregate at a fire in a manner that interferes with operations of fire personnel.
Chapter 93 § 93.04	Obstructing or interfering with fire hydrants	
Chapter 93 § 93.05	Open Burning	Unlawful to burn outside except small fires in commercially designed fire pit/grill/outdoor fireplace.
Chapter 93 § 93.06	Metal Containers Required for Gasoline or Kerosene	Unlawful to sell, store, dispense without a metal container
Chapter 93. § 93.08	Grilling	Unlawful to have open-flame cooking devices near combustible balconies or construction except at 1-2 family residences.
Chapter 93 § 93.09	Knox Box Required	Commercial buildings or gated communities must have Knox Box installed for for rapid entry by Fire Department.

Chapter 95 § 95.01-95.03	Noises	Noises that are sufficiently loud to frighten or pose a danger prohibited if louder or longer than is necessary for the performance of a lawful function;
Chapter 96 § 96..03	Juvenile Protection - Offenses	Unlawful for juveniles to be in a public place after restricted hours; unlawful for parents to knowingly let them out.
Chapter 110.01	Operation of Public Enterprise Without a Franchise	Unlawful to operate a public enterprise without obtaining franchise from the Town.
Chapter 111 § 111.01 et.seq.	Motor Vehicles Carrying Persons for Hire	Unlawful to violate ordinances regulating the operation, equipment; reporting; and determination of fares
Chapter 112 § 112.01-112.14	Solicitation	Unlawful to violate ordinances regulating the solicitation at residences during times when such activity is most intrusive and disruptive.
Chapter 113 § 113.01-113.10	Massage and Bodywork Therapy Regulations	Unlawful to operate a business without a permit; unlawful to violate health and safety ordinances.
Chapter 114 § § 114.04(A), 114.07, 114.10(D), 114.11(E), 114.14(C), 114.15, 114.16(C) and (D), 114.17(B), and 114.18(B) and (C).	Sexually Oriented Businesses	Unlawful to violate Ordinances related to the operation of sexually oriented businesses.
Chapter 115 § 115.01-115.03	Motorized Vendors of Ice Cream Products	Unlawful to sell ice cream/frozen products without license/approval from health department.
Chapter 116 § 116.01-08	Street Vendors	Unlawful to violate ordinances regulated the sale of food and other
