| <ul style="list-style-type: none">• General Penalty for violating any provision of the Code of Ordinances that has unnamed penalty (except for parking of vehicles).• Class 3 Misdemeanor with a max fine of \$50.00 and/or no more than 30 days imprisonment. See Code Section 10.99 |

Chapter 36. Town Policies

| <ul style="list-style-type: none">• Violating any general provisions in this chapter without specific penalty (Class 3 Misdemeanor – See Chapter 10)• Violating restrictions on access to areas that are clearly posted as restricted or private (Misdemeanor with max fine of \$500.00 and/or a max of 30 days imprisonment).• Being ordered to disperse as a member of an assembly (Class 3 Misdemeanor – See Chapter 10).• Possession of weapons on public property including parks, town-owned buildings, and their appurtenant premises (Misdemeanor with fine of \$500.00 and/or six months of imprisonment).• Class 3 Misdemeanor with a max fine of \$50.00 and/or no more than 30 days imprisonment. See Code Section: 36.99 (a-d) |

| <ul style="list-style-type: none">• Violation of any provisions involving Water and Sewer delivery (Civil Penalty of \$100.00 with additional fees of \$100.00 for the failure to pay the original penalty).• See Code Section: 51.85 J |

Chapter 52. Sewer Use Regulations

| <ul style="list-style-type: none">• Damaging of sewer systems or discharge of harmful substances will result in a notice of violation. If not addressed within the time posted, they shall be fined (Civil Penalty of \$200.00).• Expense, loss, or damage done towards sewage systems (Civil Penalty with amount determined by damage).• See Code Section: 52.99 (a-b) |

Chapter 70. General Provisions (Traffic Code)

| <ul style="list-style-type: none">• Violating any ordinance involving the operation or parking of vehicles (Infraction and a penalty with a max fine of \$50.00).• See Code Section: 70.99 |

Chapter 72. Stopping, Standing, and Parking

- Penalties violating parking ordinances, for which no specific penalty is provided. Must be paid within 48 hours from issuance of the citation (\$5.00 for each violation, warrant is issued if fine is not paid within 48 hours).
- Parking in a handicap parking space without proper paperwork or handicap permit (Infraction and fine between \$50.00 and \$100.00).
- See Code Section: 72.99 (a-b)

Chapter 91. Animals

- Violating provisions on animal cruelty, vaccination of animals, bird sanctuaries, and vicious dogs (Notice to owner of animal, \$50.00 civil penalty, additional fines for failure to pay penalties, Class 3 Misdemeanor from Chapter 10 may also be applicable).
- See Code Section 91.99 (a-h)

Chapter 92. Cemeteries

- Violation of any other general regulations involving the Town cemetery. Including use of tents, landscaping, floral regulations, cemetery conduct, and disturbance of fixtures (Class 3 Misdemeanor – See Chapter 10).
- Inappropriate conduct within Town cemetery. May include making loud noises, discharge of any firearms, or commit indecent acts (Fine of \$10.00 and/or 30 days or less of imprisonment).
- See Code Section: 92.99 (a-b)

Chapter 97. Streets and Sidewalks

- Violation of any general provisions without specific penalty in this chapter (Class 3 Misdemeanor – See Chapter 10).
- Obstructing sidewalks with intention to sell goods (Fine of \$5.00 for each day the sales table/event is obstructing the sidewalk).
- The construction of benches and chairs on sidewalks. As well as the operation of bootblacks on the sidewalk (Fine of at most \$10.00 or imprisonment for no more than 30 days).
- Burning of trash on the streets (First offence=warning letter; second offence=\$25.00 fine; third offence=\$50.00 fine; fourth offence=\$100.00 fine).
- See Code Section: 97.99 (a-d)

Chapter 112. Alcoholic Beverages

- The sale and purchase of beer and wine between 1:00 am on Sunday and 7:00 am on Monday morning (Class 3 Misdemeanor – See Chapter 10).
- The sale of liquor in Town limits (Class 3 Misdemeanor – See Chapter 10).
- See Code Section: 112.99

Chapter 150. Building Regulations
<ul style="list-style-type: none">• Violation of any provision in this chapter without a specified penalty (Class 3 Misdemeanor – See Chapter 10).• Failure to obtain Town permit to install, alter, or restore any insulation or other materials or energy utilization equipment designed or intended to meet the state building code (Fee for permit).• See Code Section: 150.999 (a-b)
