

**Ordinance Reporting to North Carolina General Assembly
Under Session Law 2018-69
City of Marion**

<u>City Code Section Number</u>	<u>Description of Conduct Subject to Criminal Punishment in Ordinance</u>
3-2	Requires current rabies vaccination for dogs and cats in City.
3-4	Requires dogs to be kept under restraint at all times when not on owner's property and to not be at large.
3-4.1	Prohibits dogs or cats deemed dangerous or potentially dangerous from being fastened, chained or tied on any property in the City. Sets standards for the tethering of animals in the City.
3-4.3 - 3-5	Sets requirements for dangerous or potentially dangerous animals, based on attacking or biting a person or another animal.
3-6.1	Prohibits tampering with animal cages set by the City.
3-8	Prohibits dogs that habitually or repeatedly bark in such a manner or to such extent to create a public nuisance.
3-8.1	Prohibits cruel treatment of animals. No person shall molest, torture, torment, deprive of necessary sustenance, cruelly beat, needlessly mutilate or kill, wound, injure, poison or abandon subject to condition detrimental to its health or general welfare any animal. No person shall keep an animal under unsanitary or inhumane conditions and fail to provide proper food and water daily, shelter from the weather, reasonably clean quarters and proper medical attention for sick, diseased and injured animals. Defines what constitutes adequate shelter.
3-8.2	Prohibits the owner of any animal to allow or permit said animal from damaging the property of anyone other than its owner.
3-10	Prohibits interference with City animal control officer in performance of their duties.
3-12	Prohibits turkeys, geese, ducks, chickens, or other domestic fowl to run at large upon any land in the city.
3-13	Prohibits any person to permit any cattle, sheep or other animals to graze, or tie such animal up, on any vacant lot or within fifty feet of any dwelling or street within the city.

- 3-14 Prohibits any person to hitch any horse or other animal to any of the trees, lampposts, electric lights, power, telephone or telegraph poles, mailboxes, wires or hydrant on any of the streets, sidewalks, squares or parks in the city.
- 3-15 Prohibits any person to keep a hog within the corporate limits of the city.
- 3-16 Prohibits any person to permit their horse, mule, donkey, hog, sheep, goat, or cattle of any kind, to run at large in the streets, sidewalks, parks, squares or cemeteries of the city. Prohibits any person to allow such animals to graze or feed in public areas in the city.
- 3-17 Sets standards for stables and places where cattle, horses, chickens, geese or other animals are kept. Prohibits any person to erect any cow, horse, mule, sheep or goat stable or any coop or pen for the keeping of any chickens, geese, turkeys, ducks, or any other gallinaceous birds, within one hundred feet of any street or dwelling in the city.
- 3-18 Makes it unlawful to trap, hunt, shoot, or attempt to shoot or molest in any manner any bird or wild fowl or to rob bird nests, except for situations creating a public nuisance.
- 4-1.7 Establishes that all buildings or structures shall comply with the North Carolina Building Code, the North Carolina Residential Code, the North Carolina Plumbing Code, the North Carolina State Mechanical Code, the North Carolina Electrical Code, the North Carolina Accessibility Code and the North Carolina Fuel Gas Code, that manufactured housing shall comply with national and state codes for manufactured housing, that all buildings or structures except for single family homes and townhomes and duplexes shall comply with the North Carolina Fire Prevention Code, that buildings and structures shall comply with the North Carolina Energy Code, that alterations, repairs, replacement and that rehabilitation or change of occupancy of existing buildings shall comply with the North Carolina Existing Building Code,
- 4-2.2 Requires all holders of permits to notify the inspection department and the appropriate inspector at each of various stages of construction so that approval may be given before work is continued. These stages include a foundation inspection, a framing inspection, a fireproofing inspection and a final inspection. Prohibits any new building or part thereof, no addition or enlargement of any existing building or no existing building after

being altered or moved to be occupied, and no change of occupancy to be made in any existing building or part thereof, until the inspection department has issued a certificate of occupancy.

- 4-2.5 Prohibits alteration, repair, or construction of any building or structure until a zoning permit has first been issued by the appropriate official charged with enforcement of the zoning ordinance.
- 4-3.1 Prohibits any person from commencing or proceeding with the construction, reconstruction, alteration, repair, removal, or demolition of any building or other structure, or any part thereof, without securing necessary permits.
- 4-4.1.4-4.2.9 Sets minimum housing requirement for all buildings used for human habitation, with standards set out in the ordinance for fitness for dwellings and dwelling units, room sizes, structural condition, safe and sanitary maintenance, plumbing, heating and electrical systems, control of insects and rodents and fire protection and safety.
- 4-4.3.1 Prohibits unsafe conditions in dwelling units or structures, as defined in the ordinance, including conditions such as no operating heating facilities, no working water supply, no working hot water supply, no electricity, lack of functioning sanitary facilities, the presence of raw sewage or open sewers and the presence of unsafe structural conditions and other conditions.
- 4.5-28 Prohibits any person from operating or maintaining an adult establishment without an adult establishment license from the city or after such license has been revoked or suspended by the city or has expired. Prohibits any entertainer to knowingly perform any work, service or entertainment directly related to the operation of an unlicensed adult establishment within the city. Prohibits any person to work as an entertainer at an adult establishment without first obtaining a license to do so from the city, or to work as an entertainer at an adult establishment after such person's license to do so has been revoked or suspended by the city or has expired.
- 4.5-30 Prohibits person under 21 on the premises of any adult establishment, to operate an adult establishment business or to be an entertainer at such business and prohibits people from being in a state of nudity or to perform specified sexual activities in such a business. Sets additional standards for the conduct of owners, operators, managers, employees and customers.

4.5-31	Requires adult establishments and entertainers to post licenses.
4.5-36	Sets locational restrictions on sexually oriented businesses in various zoning districts and within (1,500) feet of churches, schools, libraries, parks, child care facilities, other sexually oriented businesses, etc.
4.5-39	Prohibits escort agencies from employing people under 21 or to serve as an escort for people under 21.
4.5-40	Prohibits nude model studios from employing any person under 21 and sets regulations on such studios.
4-5-41	Establishes regulations on the exhibition of sexually explicit films, videos, and live performances.
4-5.42-4.5-43	Prohibits sexually oriented businesses to allow the merchandise or activities of the establishment to be visible from a point outside the establishment and establishes additional regulations on such businesses.
4-5.44	Establishes regulations for massage parlors.
4-5.45	Establishes hours of operation for sexually oriented businesses.
5-1	Prohibits any person from disinterring the remains of any human body, without first having obtained written permission from the city clerk and following procedures outlined in State law.
5-2	Sets requirements for length and depth of graves.
5-3	Prohibits a grave from being reopened for the interment of an additional body, except in accordance with the City Code and State law.
5-5	Prohibits persons from entering any City cemetery at any time between sunset and sunrise for any purpose without written consent from the city manager.
5-6	Prohibits any persons from damaging, disturbing or defacing graves, grave markers, ornamentation, etc., except with permission of City. Prohibits trespassing in City cemeteries or breaking or stealing flowers from graves.
5-7	Prohibits sale of merchandise in any City cemetery.

5-8	Prohibits any person from using a City cemetery as a playground.
5-10	Prohibits any person from damaging or interfering with the walks, decoration or general arrangement of a City cemetery, without permission from City.
5-11	Prohibits any person from driving any vehicles over or parking any vehicle on any walks of a City cemetery.
5-12	Establishes general rules for the interment of bodies, cremated remains in a City cemetery.
6-26-6-27	Provides for Mayor to issue a proclamation of a state of emergency and for a curfew and regulations to be in place in the City.
7-10	Requires an owner or occupant of a building to comply with orders of Fire Chief to abate fire hazards.
7-12	Requires citizens to obey orders of Fire Department in assisting in extinguishing fires and protecting property.
7-13-7-14	Prohibits any person from interfering with the activities of the Fire Department, firefighters or fire apparatus during a fire.
7-15	Prohibits any person other than a firefighter from riding in or climbing on a fire truck without permission of the Fire Department.
7-16	Prohibits any person from interfering with fire alarm apparatus.
7-17	Prohibits any person to willingly give or aid and abet in a false fire alarm.
7-18-7-19	Prohibits any driver from passing a fire truck while such fire truck is answering a fire alarm or from driving over a fire hose.
7-36	Requires compliance of owners of applicable buildings with the North Carolina Fire Prevention Code.
7-39	Establishes a primary fire district in which the storage of flammable liquids and other explosives is prohibited.
7-56-7-61	Establishes regulations and permit requirements for blasting and pyrotechnics in the City. Prohibits possession, use or sale or pyrotechnics, except as approved by the City and allowed by State law.

8-29	Establishes requirement for floodplain development permit prior to commencement of any development activities within special flood hazard areas.
8-30	Prohibits any structure or land in the City from being located, extended, converted, altered, or developed in any way without full compliance with City floodplain regulations and other applicable regulations.
8-52	Establishes floodplain permit requirements in City for applicable structures and properties.
8-54	Requires owners of buildings or properties in applicable floodplain areas of the City to obey orders and take corrective action, as directed by the City floodplain administrator.
8-76-8-81	Establishes standards for development in floodplains and floodways.
9-1	Prohibits any person to violate County Board of Health regulations or to interfere with health officers in the discharge of their duties.
9-4	Prohibits any person from urinating or depositing human waste on any street, lot or premises except in an approved sanitary facility or any vendor of any kind from leaving leave any refuse on the streets or on the lots of the city. Requires owners of animals to remove dead animals from properties in City.
9-5	Prohibits the butchering of cattle, hogs or sheep in the City.
9-26-9-33	Establishes regulations for residential garbage and dry refuse in the City.
9-34	Establishes regulations for collection of dumpsters for businesses and prohibits piling garbage or trash around dumpsters.
9-36	Requires property owners to remove building and construction waste within 10 days of the completion of construction work.
9-37	Prohibits any person to litter in the City, to blow any trash, grass clippings or other materials onto any public sidewalk or street.
9-39	Prohibits burning of solid waste in the City without a permit issued by the Fire Chief.

- 9-40 Prohibits any person to use, maintain, or operate an open dump in the City.
- 9-41 Requires all hazardous waste to be collected and disposed of in accordance with State law.
- 9-42 Requires owners to remove and properly dispose of dead animals in the City.
- 9-43 Prohibits any person from collecting any garbage or refuse, for a fee, in the City, without a permit from the City.
- 9-44 Prohibits any person from scavenging, sorting, picking through or removing refuse, trash, yard wastes or recyclables stored in any dumpster or bin or set out for collection, except with the permission of the resident or business setting out such items for collection
- 9-63 Prohibits abandoned vehicles, as defined in the ordinance, to be left on streets or public properties in the City.
- 9-64 Prohibits nuisance vehicles, as defined in the ordinance, to be left on properties in the City.
- 9-65 Prohibits junked or inoperable motor vehicles, as defined in the ordinance, to be left on properties in the City.
- 9-104 Prohibits any person from engaging in activities producing unreasonably loud and raucous noises and as tending to constitute noise disturbances when conducted or permitted in an unreasonable manner and creating a noise disturbance on neighboring premises. The section lists activities that constitute a noise violation.
- 9-121 Prohibits any person from the use of property in the City or any act or omission affecting the condition or use of property which creates a public nuisance and threatens the safety of citizens or adversely affects the general health, happiness, security and welfare of others. The section lists conditions constituting a public nuisance, such as overgrowth or weeds and grass, conditions creating breeding grounds for mosquitoes or rodents, the accumulation of garbage, trash or refuse, etc.
- 9-124.3 Prohibits any person from acts, omissions or conditions creating a public nuisance, other than those listed in Section 9-121, as defined

or regulated by the City Council by ordinance after a public hearing.

- 9-126 Prohibits any person from allowing conditions that obstruct sight visibility from streets or driveways in the City.
- 9-128 Prohibits any person from placing a portable toilet in the City without a permit from the City and screening said portable toilet from public view to the greatest possible extent.
- 10-76-10-91 Establishes permit requirements and regulations for operation of game rooms, pool rooms and similar businesses in the City.
- 10-112-10-126 Prohibits any person from engaging in peddling or soliciting on listed streets in the City or without a permit in the City, with exceptions for charitable solicitations.
- 10-151-10-152 Establishes permit requirements and regulations for operation of pawnbroker businesses in the City.
- 10-171-10-178 Establishes permit requirements and regulations for itinerant merchant sales in the City.
- 11-1 Prohibits the brandishing of firearms in a threatening manner on the streets, sidewalks, alleys or other public property within the City.
- 11-2 Prohibits any person from being disorderly in any street, alley, or public place.
- 11-3 Prohibits any person from exposing their genitals or buttocks in any business or public place and in the presence of any other person, or who aids or abets in any such act, or who procures another to perform such act.
- 11-4 Prohibits any person from displaying on any street or alley, or in any store, shop or public place, any vulgar or obscene pictures, marks, words, or representations of any kind.
- 11-5 Prohibits any person from knowingly selling, renting or using any house to be used as a house of prostitution. Prohibits any person from soliciting any man or woman for sexual intercourse on any of the streets or public places in the City.
- 11-6 Prohibits any person from begging, panhandling or conducting any type of performance for donations in any public street, alley, right-

of-way or sidewalk in the city or on any property owned or leased by the City, with an exception for performances conducted in conjunction with City-sponsored or approved events on public streets or sidewalks or on property owned or leased by the City, with the approval of the event organizer.

- 11-7 Prohibits any person from shooting or hurling any stone, rock, shot or other hard substance by means of a slingshot, bean shooter, air rifle, shot shooter, pop gun, bow or other similar contrivance, provided that archery shooting may be practiced in such places as may be set aside and approved by the City.
- 11-8 Prohibits the discharge of any pistol, gun or other firearm, fireworks or other pyrotechnics in the City Limits, with exceptions for self-defense, law enforcement officers in the discharge of their duties or at historical, ceremonial or commemorative functions with the approval of the Police Chief.
- 11-9 Prohibits sleeping in stairways, being on private premises without consent, assembling in such numbers as to interfere with the full and free use and passage of public traffic on sidewalks, streets, bridges, alleys, or other public places, parking in a business parking lot after business hours, when signs are posted in a conspicuous place prohibiting such parking after business hours or skating or skateboarding on any private property or parking lot, when signs are posted in a conspicuous place prohibiting such activities.
- 11-10 Prohibits any person from inciting or causing any dogs, or other animals, or any chickens to fight.
- 11-11 Prohibits any person, without authority from the police department or fire department, to carry or use any whistles, bells, horns or sirens, similar in appearance or sound to the whistles, horns or sirens used by the police department or fire department.
- 11-12 Prohibits any person from defacing any public property in the City, or from willfully, or negligently, injure, or interfere with, any valve, valve box, meter, meter box, storm or sanitary sewer, manhole cover, storm sewer catch basin cover, fire hydrant, police or fire alarm box, traffic signal or any other property used in the city's water, sewer, police or fire alarm systems.
- 11-13 Prohibits any person from posting any bill, poster, placard or sign of any type on any pole, post or tree on any city-owned property including parking lots, street and alley rights-of-way.

- 11-14 Prohibits any person from throwing or placing any written or printed notices, posters, or pamphlets of any kind upon any public street or alley or to place such materials under the windshield wipers of vehicles or on any type vehicle.
- 11-15 Prohibits any person from carrying, except when on their own premises, or to carry or use, any bowie knife, dirk, dagger, razor or knife, with a blade of over three inches in length, anywhere within the City, with exceptions for law enforcement officers and military personnel when in discharge of their official duties.
- 11-16 Prohibits persons from carrying concealed weapons in specified City properties and buildings. Prohibits persons from carrying concealed weapons, except for legally carried concealed weapons under State law, in specified City recreational facilities.
- 11-17 Prohibits the consumption of alcoholic beverages on properties owned or controlled by the City or upon any public vehicular areas, with exceptions for establishments with an on-premises ABC permit under State law, or in other specified areas, with exceptions for permitted sidewalk cafes and in approved areas in conjunction with City approved or sponsored festivals and events.
- 11-18 Prohibits tobacco use in all buildings or structures owned or leased by the city, in any vehicle owned or leased by the city, within a specified radius of any building or structure owned or leased by the city, within any park or greenway owned or leased by the city and in other specified areas on public property.
- 11-19 Prohibits any person from loitering in specified public places for the purpose of engaging in drug-related activity, as long as certain listed conditions are in place.
- 12-1 Prohibits any person from being on the Community Building tennis or basketball courts between the hours of 11:00 p.m. and 6:00 a.m. local time.
- 12-2 Prohibits any person from entering any city owned or maintained park facility other than the community building tennis courts or basketball courts at any time between sunset and sunrise for any purpose without written consent from the City Manager.
- 12-3 Prohibits registered sex offenders from entering parks or recreational facilities.

12-26-12-28	Establishes regulations for the use of City tennis courts.
12-51	Establishes regulations for City sponsored or approved festival and events, including prohibiting activities that affect public safety and regulating alcoholic beverages at such events.
12-66	Requires person to wear designated protective equipment while engaging in any hazardous recreational activity, namely skate parks, within a designated area and to comply with all rules and regulations applicable to designated areas.
14-5.1	Requires all signs located within the City to be maintained in good condition and appearance by the owners of such signs.
15-1	Prohibits any person from damaging City streets.
15-2	Prohibits any person from moving a house across streets or sidewalks in the City without a permit from the Police Chief and a bond to cover damage done to streets and sidewalks.
15-3	Prohibits any person from injuring, tampering with, removing or defacing any bridge, culvert, ditch and drain, sign, sign post, street light, traffic signal, bulletin board or other municipal property upon the streets and sidewalks except employees of the City in performance of their duties.
15-4	Requires owners of buildings in the City to post address numbers on the front of the house or building.
15-5	Prohibits any person, firm or corporation from installing any storm drainage pipe on any public property, street or street right-of-way within the City without first having received a written permit issued by the public works director.
15-49	Requires refilling and repairs or excavations done on any part of any street, sidewalk, alley or other public place of the City, in accordance with the standards and specifications issued by the public works director.
15-50	Prohibits any person to do any excavation of any kind which may create or cause a dangerous condition in or near any street, alley, sidewalk or public place of the City without placing and maintaining proper guard rails and signal lights or other warnings at, in or around such dangerous condition, sufficient to warn the public of such excavation or work, and to protect all persons using reasonable care from injuries on account of such excavation.

- 15-69 Prohibits any person to cut or damage any tree located on City property without the permission of the public works director or to dig up or injure any tree or to tack or post any advertisement upon trees located on City property.
- 15-70 Prohibits any person to construct a driveway across any public sidewalk, walkway or parkway or into any street or cut any curb for such purpose without first having obtained a permit from the City.
- 15-86 Prohibits any person to throw or deposit upon any street or sidewalk, or upon any private property, except with written permission of the owner or occupant of such private property, any trash, refuse, garbage, building material, cans, bottles, broken glass, paper, or any type of litter.
- 15-87 Prohibits any person while a driver or a passenger in a vehicle to throw or deposit litter upon any street or other public place within the city or upon private property.
- 15-89 Requires every owner, lessee, tenant, occupant or person in charge of any commercial establishment or premises which maintains any paved or unpaved areas for the use of the public, and which parking or access areas abut or lie within ten (10) feet of any public street or other public way to keep and maintain such areas clean and free from trash, litter, rubbish and any materials liable to be blown, deposited or cast upon such street or other public way.
- 15-90 Requires trash receptacles to be provided in all parking or access areas.
- 15-92 Prohibits any act, neglect or omission or any condition caused or allowed to continue, which creates or results in causing a condition in or upon any public street, sidewalk or storm drain which requires special cleaning or repair of such street, sidewalk or storm drain, including spilling or depositing dirt, mud, debris, construction or waste materials on streets or sidewalks.
- 15-133 Prohibits all persons from assembling or collecting and standing so as to obstruct any sidewalk or street.
- 15-134 Prohibits any person from placing or displaying any goods, wares or merchandise of any kind upon any of the sidewalks of the city, except in the central business district, as allowed by the City Code and by permit.

- 15-135 Prohibits any person from placing objects such as brick, stone, wood or other substances to obstruct the free passage of persons and vehicles on any of the alley ways, streets or other routes of the City and prohibits the placing on or in any of the streets, sidewalks or alley ways of the city any boxes, crates, casks, or barrels of any description, or any other obstruction of any kind, with exceptions for construction activity.
- 15-137 Prohibits any person from erecting over any sidewalk or street any part of a building except marquees and signs which are approved by the building inspector or awnings, balconies or porches meeting certain standards.
- 15-138 Prohibits persons selling newspapers and other commodities from selling such items within 50 feet of any street intersection or entering a street while selling such items and prohibits motorists from stopping in the street to purchase any items.
- 15-139 Prohibits signs or banners from being hung, suspended or placed across any streets in the City, with exceptions for Christmas decorations approved by the City.
- 15-143-15-152 Prohibits any person from operating a sidewalk cafe without a permit from the City and meeting requirements listed in the ordinance.
- 15-157 Prohibits any person from organizing, conducting or participating in any parade, picket line, or group demonstration in or upon any street, sidewalk, alley, or other public place within the City unless a permit has been issued by the City.
- 15-160 Prohibits any person from hampering, obstructing, impeding or interfering with any parade, picket line, or group demonstration conducted under authority of a permit issued by the City.
- 15-161 Sets requirements for picket lines and picketing, limiting such demonstrations to sidewalks and prohibiting them on streets, along with other requirements to allow for free access to streets and sidewalks.
- 15-162 Prohibits people taking part in a parade, picket line or group demonstration from carrying any weapons or keeping any dog, whether leashed or unleashed, with exceptions for funeral processions and law enforcement officers.

16-1.6-16-9.4	Establishes standards and regulations for the subdivision of property in the City.
16-10.1	Establishes penalties for subdividing property in the City that has not been properly approved under the City's Subdivision Ordinance.
17-3-17-61	Establishes regulations on the operation of taxicabs in the City, such as requirements for taxicab owners to obtain a permit from the City, to meet standards set by the ordinance and for drivers to undergo a background check and be permitted by the Police Department.
17.5-56	Prohibits any person, corporation, partnership or other entity from erecting, replacing or modifying any communication tower without first obtaining a permit from the City.
18-5	Prohibits persons from willfully failing or refusing to comply with any lawful order or direction of a police officer or fire department official.
18-6	Prohibits any person upon roller skates, or riding on any coaster, skateboard, toy vehicle, or similar device, to go upon any roadway except while crossing a street on a crosswalk, with exceptions for approved play streets.
18-28-18-31	Requires obedience to traffic signs, signals, markers or devices, unless otherwise directed by a police officer or when an exception is granted to the driver of an authorized emergency vehicle under State law and the City Code.
18-32	Prohibits displaying on or in view of any highway or street any unauthorized sign, signal, marking, or device which purports to be or is in imitation of or resembles an official traffic control device, sign or signal, or which attempts to direct the movement of traffic, or which hides from view or interferes with the effectiveness of any official traffic control device, sign or signal. Prohibits commercial advertising on traffic signs or signals.
18-33	Prohibits any person to alter, deface, injure, knock down, or remove any official traffic control device, sign or signal or any inscription, shield, or insignia.
18-34	Establishes traffic restrictions on designated play streets.
18-35	Requires drivers to stay within marked lanes, except when lawfully passing another vehicle or making a legal turning movement.

18-36	Establishes posted zones of quiet, in which drivers shall not sound the horn or any other warning device, except in an emergency.
18-37	Establishes school zones, where posted.
18-38-18-39	Requires drivers to obey various posted signs, including yield signs and fire lanes.
18-56-18-61	Regulates various movements of motorists, cyclists and pedestrians, requiring drivers to yield to pedestrians and other vehicles when entering a roadway from an alleyway or driveway, to leave intersections clear, for cyclists, skateboarders, skaters, etc. not to cling to vehicles moving upon any roadway, prohibiting any person other than drivers of emergency service vehicles responding to emergency calls to drive through a funeral procession, prohibiting backing into a roadway or across a crosswalk in an unsafe manner, to drive within or across any sidewalk area or across curbs except at a permitted permanent or temporary driveway.
18-62-18-63	Regulates driving in a funeral procession, requiring drivers to turn on headlights and to drive as close to the right edge of the road and to follow the vehicle ahead as close as is practical and safe.
18-64	Regulates operation of motorcycles to require driver and passenger to only ride on a permanent and regular seat or another seat firmly attached to the motorcycle.
18-65-18-72	Prohibits various acts by motorists or pedestrians, including driving a vehicle onto or from any controlled-access roadway except at such entrances and exits as are established by public authority, operating any automobile or truck with the cut-out open or without it being properly muffled so as to prevent unnecessary noise, prohibiting the spinning of wheels or squealing of tires. Other prohibited acts include boarding or exiting a vehicle in motion, riding on any public conveyance or vehicle not designated or intended for the use of passengers, except for employees in the normal discharge of their duties, entering, jumping on or riding any automobile or other vehicle, without the consent of the owner or driver, allowing a body part to protrude beyond the limits of a vehicle in motion, except to give such signals as are by law required, hanging on to any vehicle or permitting more than three people in the front or driver's seat of a vehicle.

18-74	Prohibits a railroad employee to block any of the street crossings of the city by stopping their train, cars, or engine across any street for more than five consecutive minutes.
18-75	Establishes truck routes and sets weight limits on trucks on non-truck routes.
18-76	Prohibits use of motorcycles, trailbikes and other off-the-road vehicles on roads, except as allowed by state law and only if legally licensed and inspected, restricts use of such vehicles to property owned or controlled by the operator or where permission has been given and requires mufflers on said vehicles.
18-91-18-144	Requires drivers to obey posted speed limits, to make turns in accordance with posted signs, traffic markings and State law, to use turn signals, to not make u-turns except in a safe manner and not if signs prohibit such a movement, to obey one-way turn signs and to obey stop signs.
18-161-18-169	Establishes regulations for pedestrians, including obeying traffic control signals, requiring drivers to yield the right of way to pedestrians in crosswalks or when lawfully crossing the street at a signal, defining when pedestrians must yield the right-of-way, prohibiting hitchhiking, prohibiting persons from obstructing traffic by sitting or lying upon a street or sidewalk and other safety regulations.
18-186-18-196	Establishes regulations for bicycles, such as applying traffic laws to bicycles, requiring persons riding on bicycles to be on permanent and regular seats and for bicycles not to carry more than the designed number of persons, requiring bicycles to ride as near the right edge of the roadway as possible, to use paths where provided, to be operated at a reasonable speed, to yield the right-of-way to pedestrians or motorists when approaching a sidewalk or entering a roadway, to keep at least one hand on the handlebars, to prohibit bicycles on sidewalks in certain areas and to establish requirements for safety equipment.
18-197-18-199.2	Sets regulations for skateboards, roller skates and roller blades, including restricting them to designated play streets, prohibiting them on certain sidewalks, in City parking lots and on all City property.
19-3	Prohibits any person to prune, treat, or remove any street tree or park tree within the City without receiving a permit from the City.

19-4	Prohibits any person from pruning, treating, or removing street or park trees within the City for a fee without receiving a license from the City, with exceptions provided for utility and government employees.
19-52	Prohibits the topping of any street tree, park tree, or other tree on City property, as defined in the section.
20-3	Requires restaurants and places where food is prepared, excluding residential units, to have a grease tank, as defined by the section, and to pump it out in specified intervals.
20-23	Prohibits any person from turning a water meter on or off, other than authorized City personnel.
20-38	Prohibits any person to turn water service on at any premises, when such service has been turned off by the city for unpaid water and/or sewer bills.
20-39	Prohibits any person from occupying any building unless such building is connected with City water and sewer, provided connection is possible within a distance of 300 feet.
20-40-20-41	Prohibits any person to remove, tamper with, or in any way meddle with any water meter box, rim cover or any part of such water meter box, to park any vehicle or place any item on top of any water meter box.
20-46	Prohibits any person, other than a City employee or volunteer or other authorized persons to take water from any public hydrant, plug, street washer, drain cock, hose pipe or fountain, unless such person receives approval from the City and pays applicable charges.
20-58	Prohibits any person, firm, or corporation to connect any well or auxiliary water supply to the City's public water system.
20-83-20-127	Prohibits the illegal discharge of wastewater to the City's wastewater system in conflict with the City's Sewer Use Ordinance and Federal and State regulations.
21-1-21-351	Provides for the zoning of the City and regulation of development in the City, as established in the ordinance, including the definition of terms used in the ordinance, the establishment of zoning districts, the application of regulations, general provisions, nonconforming uses, off-street parking and loading standards,

gasoline service or filling station standards, sign regulations, landscape standards, auto-related business standards, temporary uses and structures, accessory uses, campground standards, use requirements by district, overlay districts (Historic District and watershed area), dimensional requirements, exceptions and modifications and administration and enforcement.
