## § 10.99 GENERAL PENALTY.

- (A) Unless otherwise provided herein, each violation of this code or any other town ordinance shall constitute a misdemeanor as provided by G.S. § 14-4, except as otherwise provided by statute, and violations of such provisions of any town ordinance shall be punished by fine or imprisonment as provided by law. Each day any violation of any town ordinance shall constitute a separate offense, except as may be specifically provided.
- (B) Violations of this code or any town ordinance shall constitute either a misdemeanor or, at the election of the town, shall subject the offender to a civil penalty upon the issuance of a citation for said violation as hereinafter provided. The civil penalty, if not paid to the town within 15 days of the issuance of a citation, may be recovered by the town in a civil action in the nature of debt. Unless otherwise provided by a specific provision of this code or any town ordinance, said civil penalties shall be in the amount of \$50 for each violation and each day any single violation continues shall be a separate violation.
