## Ordinances Enacted by the Board of Alderman of the Town of Vanceboro Punishable Pursuant to G. S. § 14-4(a)

Section G – Trash & Garbage. Provides the penalty for the violation of, or failure to comply with the provisions and requirements of *Chapter 56. Solid Waste Management (Section 56-16 A and B)*, the purpose of which is to regulate the placement of trash, refuse, and garbage within municipal limits. The penalty for any person in violation of NCGS§14-4, shall be guilty of a Class 3 misdemeanor and shall be fined fifty dollars (\$50). Each day's violation will be listed as a separate offense.

Section H – Property Maintenance. Provides that the Town may proceed in a criminal action, as provided by NCGS§14-4. *Chapter 12. Environment. Section 21-31. Procedures under this article not exclusive:* Provides the penalty to any other remedies that may now or hereafter exist under law for the abatement of public nuisances.

Section I – Miscellaneous. Chapter 32. Curfew for Juveniles. Section 32-8. Penalty: Provides the penalty punishment for any guardian of such minor breaking curfew shall be guilty of a misdemeanor as defined by G.S. Section 14-4(a).

Section K – State of Emergency. Section K-9. Penalty for violence. Provides the penalty for any person violating any prohibition or restriction imposed by a proclamation authorized by this ordinance. They shall be guilty of a misdemeanor punishable upon conviction by a fine or imprisonment.

Section K – State of Emergency. Section K12. An ordinance regulating the storage of firearms and ammunition by dealers applicable during a state of emergency Subsection 3. Penalty for violation: Provides the penalty for any person failing to comply with any requirement of this ordinance shall be guilty of a misdemeanor punishable by a fine not exceeding \$500 or imprisonment not exceeding 30 days.

Section K – State of Emergency. Section K13. An ordinance to permit dispersal of assemblies during an emergency Subsection 3. Penalty for failure to disperse: Provides the penalty to any member of an assembly ordered to disperse by a police officer acting under authority of this ordinance shall be guilty of a misdemeanor if he fails to comply with the order and shall be punishable upon conviction by a fine or imprisonment.
