**DIVISION 2. SPEED LIMITS†****Sec. 22-46. Authority.**

The speed limits fixed by this division are pursuant to authority contained in G.S. 20-141 and upon the basis of engineering and traffic investigations to determine a safe and reasonable speed limit.

**Sec. 22-47. Applicability of state traffic laws.**

The state traffic laws regulating the speed of vehicles shall be applicable upon all streets within the town except as are otherwise provided for or modified by this division. Specifically, this division is not attempting to regulate or establish speed limits on those streets that are being maintained by the state department of transportation.

**Sec. 22-48. Town streets.**

When properly signposted, the speed limits on all streets, roads or highways within the corporate limits of the town shall be 35 miles per hour.

**Sec. 22-49. Signs.**

The town is hereby responsible for erecting appropriate signs in or around the corporate limits giving notice of the speed limits prescribed in this division.

**Sec. 22-50. Enforcement.**

The provisions of this division shall be enforced by the county sheriff's department or any other properly authorized law enforcement agencies.

**Sec. 22-51. Penalty.**

Any person convicted of violating any portion of this section shall be guilty of a misdemeanor and shall be punished as provided in section 1-6.

**Sec. 22-52. Exceptions.**

These speed limits shall not apply to authorized emergency vehicles when the vehicles are responding to an emergency and are operating in accordance with appropriate warning devices and at a reasonable speed in accordance with applicable state law relating to operation of emergency vehicles upon public streets, roads or highways.

**Sec. 22-53. Speed limits enacted.**

Based upon an engineering and traffic investigation pursuant to authority granted by G.S. 20-141(f), the following speed limit modifications are enacted on the following described portions of state highway system streets:

<i>Speed Limit</i>	<i>Description</i>
55	US 158 (Reidsville Road) from the corporate limits of Walkertown, a point approximately 0.24 mile east of SR 2566 (Esther Lane), eastward to the corporate limits at NC 66 (Old Hollow Road).
55	US 311 (New Walkertown Road) from the western corporate limits of Walkertown, a point approximately 0.72 mile north of the north intersection of Newhampton Road (NS) to a point 0.35 mile south of NC 66.
45	US 331 (New Walkertown Road) from a point 0.35 mile south of NC 66 to a point 0.10 mile north of NC 66.

(a) The use of McGee Road by through trucks shall be and is hereby prohibited. This prohibition pertains to trucks with three or more axles; provided, however, such prohibition shall not apply to trucks where the driver's ultimate destination is a property located on McGee Road.



## DIVISION 3. TRUCK TRAFFIC

**Sec. 22-81. Through trucks—McGee Road.**

(a) The use of McGee Road by through trucks shall be and is hereby prohibited. This prohibition pertains to trucks with three or more axles; provided, however, such prohibition shall not apply to trucks where the driver's ultimate destination is a property located on McGee Road.

(b) The limitation set forth in subsection (a) of this section will be enforceable and a penalty of not more than \$50.00 imposed upon violators.

(c) Traffic control signs and a violation penalty will be placed by the town at the entrances to McGee Road.

**Sec. 22-82. Through trucks—Salem Road and Amarillo Lane.**

(a) Salem Road and Amarillo Lane are closed to through-truck traffic. This prohibition pertains to trucks with three or more axles.

(b) The limitation set forth in subsection (a) of this section will be enforceable and a penalty of not more than \$50.00 imposed upon violators.

(c) Traffic control signs and a violation penalty will be placed by the town manager at the entrances to Salem Road and Amarillo Lane.

**Sec. 22-83. Heavy trucks—Morris Street.**

(a) The use of Morris Street (south of Old Hollow Road) by heavy trucks shall be and is hereby prohibited; this prohibition pertains to trucks with three or more axles.

(b) This limitation will be enforceable and a penalty of not more than \$50.00 imposed upon violators.

(c) Traffic control signs and violation penalty will be placed at the entrances to Morris Street (south of Old Hollow Road) by the Town of Walkertown.

**Sec. 22-84. Heavy trucks—Sullivantown Road.**

(a) The use of Sullivantown Road (from Main Street to Depot Street) by heavy-trucks shall be and is hereby prohibited; this prohibition pertains to trucks with three or more axles.

(b) This limitation will be enforceable and a penalty of not more than \$50.00 imposed upon violators.

(c) Traffic control signs will be placed at the entrances to Sullivantown Road (from Main Street to Depot Street) by the Town of Walkertown.

**DIVISION 4. IMPEDING OF TRAFFIC BY PEDESTRIANS**

**Sec. 22-90. Impeding traffic unlawful; exceptions.**

It shall be unlawful for any pedestrian to impede the normal flow of traffic on any street or highway within the town by any act, except in the event of accident or emergency.

**Sec. 22-91. Standing, sitting or loitering in streets or highways to solicit or accept contributions from occupants of vehicles unlawful.**

It shall be unlawful for any person to stand, sit or loiter in any street or highway, including the shoulders or median strip, but excluding sidewalks, and to stop or attempt to stop any vehicle for the purpose of soliciting or accepting contributions from the occupants of any vehicle or for the purpose of distributing merchandise or services to the occupants of any vehicle. It also shall be unlawful for any person to stand, sit or loiter in any street or highway, including the shoulders or median strip, but excluding sidewalks, and to solicit or accept contributions from the occupants of any stopped vehicle or to distribute merchandise or services to the occupants of any stopped vehicle.

The provisions of this division may be enforced by the county sheriffs department or any other properly authorized law enforcement agencies, pursuant to G.S. 160A-175.

**Sec. 14-1. Discharge of firearm.**

(a) It shall be unlawful for any person to fire or discharge any gun, pistol or other firearm within the town limits; provided, however, this section shall not apply to any duly sworn law officer in the discharge of his duty or to any person exercising a legal right to defend his person or property or to military personnel in the lawful discharge of their duties. Further, this section shall not apply to any person participating in a turkey shoot or other firearm-related activity which has been issued a written license for such turkey shoot or firearm-related activity from the town.

(b) The town manager or the town clerk shall be and are hereby authorized to issue a written license to any person (not prohibited by any state law from engaging in such activity) for the purpose of conducting a turkey shoot or other firearm-related activity. The license shall cost the applicant \$1.00 and shall be issued for a period not to exceed 30 days and shall be under such terms and conditions determined by the town manager or the town clerk.

**Sec. 14-2. Unauthorized persons on school property.**

(a) *Restrictions.* No person shall enter or remain on the property or premises of the Winston-Salem/Forsyth County Schools between the hours of 9:00 p.m. and 7:00 a.m.

(b) *Exceptions.* This section shall not be construed to prohibit a person's presence on school property when:

- (1) The person is an employee of the Winston-Salem/Forsyth County Schools and engaged in the performance of his duties.
- (2) The person is a student of the Winston-Salem/Forsyth County Schools and engaged in authorized extracurricular activities or providing transportation for such activities.
- (3) The person has leased the property for a specified event by contract with the Winston-Salem/Forsyth County Schools.
- (4) The person is attending an authorized extracurricular event (e.g., board meeting, sporting event, theatrical play, etc.) or an event sponsored by a person who has leased the property.

(c) *Violations; penalties.* If any person shall violate this section, he shall be guilty of a class 3 misdemeanor and shall be punished as set forth in section 1-6.
