
One NC Small Business Program

 In 2005, General Assembly created the One NC Small Business Program – Office of Science and Technology at the Department of Commerce

§ 143B 437.81. North Carolina SBIR/STTR Matching Funds Program.

- (a)Program. There is established the North Carolina SBIR/STTR Matching Funds Program to be administered by the North Carolina Board of Science and Technology. In order to <u>foster job creation and</u> <u>economic development in the State</u>, the Board may provide grants to eligible businesses to match funds received by a business as a SBIR or STTR Phase I award and to encourage businesses to apply for Phase II awards.
- STTR program must partner with universities; SBIR may (and often do) partner

U.S. Activity in Innovation Economy is Falling; **Global Competition is Increasing**




NC's Ranks in the Middle of the Pack in the Innovation Economy

One NC Small Business Program: Overview

- General Assembly showed foresight and innovation when it created the program in 2005 legislative session (§ 143B-437. 80-81)
- NC is among a handful of innovative states creating such a program
- SC and KY copied NC's program in the next year
- Goal is to <u>help NC small businesses commercialize their innovative</u> technologies and grow through two mechanisms:
 - <u>Assists</u> NC businesses with a portion of their application expenses to federal SBIR/STTR programs
 - <u>Matches</u> federal SBIR/STTR grants awarded to NC small businesses and encourages collaboration with universities
- Federal Small Business Innovation Research (SBIR) and Small Business Technology Transfer (STTR) programs are the single biggest source of early-stage funding for small businesses (\$1.8 billion) – larger than private sources

One NC Small Business Program: Appropriations

* In FY 2006, \$78,100 was funded from the 2007 appropriation

** The reimbursement program was not operational in FY 2006 and 2007

•NC has been good stewards of state resources used to leverage federal funding

One NC Small Business Program: Benefits

- Small businesses need funding during their formative stage (fertilizing the seeds)
- Federal SBIR/STTR funds aren't sufficient; One NC Program attracts and leverages more federal funding (feds consider state matching funds)
- One NC Small Business funds cover expenses that federal SBIR/STTR funds cannot cover (e.g., consultants, patent costs)
- One NC Small Business award recipients are more likely to successfully commercialize their technologies and stay in NC
- One NC Small Business award recipients create jobs and hire NC workers
- One NC Small Business award recipients collaborate with NC universities and nonprofits
- One NC Small Businesses award recipients generate critical innovations for making NC a leader in the global economy



One NC Small Business Program: Impact on a Company -- Morphormics

Morphormics', a spinout of UNC-CH, provides <u>cancer treatment diagnosis</u> and other medical applications



"Morphormics is a poster child for the matching funds program. Because of the program, we were able to work with a consultant who ultimately became our CEO. He immediately got to work and secured \$1.5 million in equity funding plus a minimum order worth the same amount of money. We are off and running and we would not have been able to do so without the help of the matching funds program."

NC General Fund Dollars Have Been Responsible For:

- Advancing biotechnology, nanotechnology, computer software, defense & medical technologies, pharmaceuticals, textiles, etc.
- Generating company and university collaborations
- **\$29 million** in external company investment (3 to 1 return on investment employment opportunities)
- **\$28 million** generated in follow-on federal SBIR/STTR funds (3 to 1 return on investment employment opportunities)
- Hundreds of patents, technology licenses, and products and services

 employment opportunities
- Supporting grants to small companies -- fewer than10 employees
- More than 100 new private sector jobs created more to come
- These impacts **will multiply greatly** as the grants become fully utilized to grow new companies and enhance existing companies
