Calculating Class Rank and GPA

Context and the Problem:

- North Carolina Statue G.S. 116-11 (10a) states that "the grade point average and class rank shall be calculated by a standard method to be devised by institutions of higher education."
- The current procedure has been in place since 1995-96 and weights AP and IB courses with 6 quality points, honors and other college courses with 5 quality points, and standard courses with 4.
- In practice what does this mean?

Example 1

Jane and John are enrolled in the same classes except Jane has decided to take band as an additional elective. She is being recruited for a band scholarship and wants to improve her chances by enrolling in band every semester to hone her skills. Because band is only worth 4 quality points, her possible maximum GPA is less than John's. If both students made A's in all of their courses, Jane's GPA would be lower.

Example 2

- A high school student takes an AP/IB course and earns a D. This student's high school GPA reflects B level performance.
- An early college high school student takes a college course and earns a D.
 This student's high school GPA reflects C level performance.

Three Major Concerns (Expressed by Students, Parents, and Others)

- Makes little sense to give more quality points to AP/IB courses which seek to emulate college-level work than to actual college courses.
- Current weighting system discourages students from sampling more broadly across the curriculum, particularly in areas like band or art where honor's sections or AP courses are not typically available.
- Grade inflation.

What Have We Done?

- Appointed a working group of community college and university admissions experts, including DPI representatives.
- Group consulted with key stakeholder groups and reviewed practices of other states.
- Submitted report and recommendations to Dr. Morrisey and I in November.
- Report currently circulating to all constituents, with feedback due January 24.
- In general, working group has two major recommendations:
 - 1) weight AP/IB/other college courses the equally, and
 - 2) reduce the weights to bring more in line with practices in other states

Next Steps

- Review Feedback from Campuses
- The Three Governing Boards will Consider the Recommendations in Spring 2014.
- Following consideration of these recommendation and agreement on how to proceed,
 - The Department of Public Instruction will present necessary policy changes to the State Board of Education for its approval
 - The State Board of Education will determine a specific implementation date so as to assure current high school students are not negatively impacted by the changes
