GENERAL PROGRAM DESCRIPTION

Background

The 1971 General Assembly of North Carolina created the State Contractual Scholarship Fund (SCSF) to provide financial assistance to needy North Carolina residents attending eligible independent colleges and universities in North Carolina. The University of North Carolina General Administration administered the program until July of 1993 when the General Assembly transferred responsibility to the North Carolina State Education Assistance Authority (NCSEAA). The program provides grants to eligible undergraduates (known as 'Eligible Students') enrolled at an approved Institution. The 2006 NC General Assembly expanded eligibility to students with bachelor's degrees seeking initial licensure in teaching or nursing (known as 'Licensure Students').

SCSF recipients are selected by the Institution on the basis of financial need, using uniform needs analysis procedures consistent with the Institution's financial aid policies and the SCSF eligibility criteria. Individual awards vary according to but may not exceed the financial need of eligible students.

An appropriation of \$44,058,375 was made by the General Assembly for the 2009-2010 academic year. Net expenditures totaled \$44,318,168 in 2009-2010. The General Assembly set the 2010-2011 initial appropriation at \$45,896,963 with \$1,350 as the per full-time equivalent (FTE) award amount for North Carolina undergraduate students attending approved Institutions.

Administration

The Rules Governing the State Contractual Scholarship Fund, (SCSF Rules) adopted on March 18, 1994¹ by the Board of Directors of NCSEAA govern the operation of the program. SCSF

Rules establish the program's definitions, terms of participation, eligibility, procedures, method of payment, refund policy, residence requirements,² and rules. To participate in the program an Institution must enter into an "Agreement Concerning Payment of State Funds to North Carolina Private Educational Institutions To Provide Scholarship Awards to Needy North Carolina Students" as defined by statute³. This Agreement was executed jointly by the chief executive officer of each Institution and of NCSEAA in 1999 and sets forth the responsibilities of all parties. This Agreement is in force until terminated via provisions within the Agreement. Each Institution designates an official (known as the SCSF Authorized Official) to administer the program and liaise with NCSEAA on behalf of the Institution.

SCSF Award Eligibility

To qualify for a SCSF award, an Eligible Student must:

- 1. be a resident of NC for the purposes of tuition payment under the terms and conditions of the *Residence Manual* of the University of North Carolina;
- 2. be an undergraduate seeking either a first associate or bachelor's degree and be enrolled full- or part-time at an Institution;
- 3. be certified to NCSEAA by an eligible Institution as eligible and enrolled;
- 4. have financial need as determined by the Institution and be eligible under Federal Methodology (FM) needs analysis;
- 5. not be enrolled in a program of study the objective of which is the attainment of a degree in theology, divinity, or religious education or in any other program of study that is designed by the institution primarily for career preparation in a religious vocation.

Is accredited by the Southern Association of Colleges and Schools under the standards of the College Delegate Assembly of the Association or by the New England Association of Schools and Colleges through its Commission on Institutions of Higher Education. b. Awards a postsecondary degree as defined in G. S. 116-5. c. Is not a seminary, Bible school, Bible college or similar religious institution." [G.S. 116-22(1)]

To qualify for a SCSF award, a Licensure Student must:

- 1. be a resident of NC for the purposes of tuition payment under the terms and conditions of the *Residence Manual* of the University of North Carolina;
- 2. have a bachelor's degree and be enrolled full-time or part-time in an eligible Institution in a program intended to result in licensure as a teacher or a nurse;
- 3. be certified to NCSEAA by an eligible Institution as eligible and enrolled;
- 4. have financial need as determined by the Institution and be eligible under Federal Methodology (FM) needs analysis;
- 5. not be enrolled in a program of study the objective of which is the attainment of a degree in theology, divinity, or religious education or in any other program of study that is designed by the institution primarily for career preparation in a religious vocation.

Eligibility for an award is determined by the SCSF Authorized Official of the Institution. SCSF recipients must be notified in writing of the amount of the scholarship and the source of the scholarship (i.e. the NC General Assembly).

Grant Amounts and Conditions

The SCSF annual appropriation is allocated proportionally to Institutions according to each Institution's share of total NC undergraduates enrolled at all Institutions as of October 1 of that year. SCSF funds are allocated to institutions based on each school's full-time equivalent (FTE)⁴ enrollment of SCSF-eligible students as of October 1. While there is no maximum per student SCSF award, Institutions have agreed through the North Carolina Independent Colleges and Universities (NCICU) that no individual student's award should exceed the in-state per student appropriation for the University of North Carolina system for the prior academic year when combined with the student's North Carolina Legislative Tuition Grant (LTG).

⁴ Full-time equivalent (FTE) is the unit measuring institutional enrollment based on a credit hour range classification of students enrolled, i.e.: (1) greater than or equal to 12 credit hours is 1 FTE student; (2) greater than or equal to 9 but less than 12 hours is 3/4 FTE student; (3) greater than or equal to 6 but less than 9 hours is 1/2 FTE student; (4) greater than 0 but less than 6 hours is 1/4 FTE student.

When funds are insufficient to provide the maximum allocation for which each Institution is eligible, a pro rata share of available funds is divided among the Institutions. Proportional distribution and pro rata determinations require that no funds be released prior to receipt of enrollment data from all Institutions.

THE 2009-2010 PROGRAM

Establishing the Maximum Award

NCSEAA received FTE reports from Institutions that totaled 33,099.50 FTE. NCSEAA determined that the appropriation was insufficient for full payment of \$1,350 per FTE student to the Institutions, and the award amount was prorated to \$1,331. In May, based on returned funds received during the year, a supplemental allotment of \$17 per FTE was disbursed to Institutions for a pro rata total of \$1,348 per FTE.

Disbursements to the Institutions

Each October, Institutions submit to NCSEAA (1) the SCSF Enrollment Data Certificate Form and (2) an electronic file of all eligible NC students counted in the SCSF FTE. NCSEAA calculates the funds for which each Institution is eligible: a maximum of \$1,350 (or a lesser prorated amount if insufficient appropriations) times the Institution's FTE as of October 1. Disbursement is usually made only once a year. When awards have been prorated, a supplemental disbursement is made if additional funds are later available.

Upon receipt of SCSF funds from NCSEAA, the institution deposits the funds into a separate account titled "State Contractual Scholarship Fund." Payments to SCSF recipients are made by debit against that account and credited to the individual student accounts at the Institution. The average SCSF award per student at the 37 Institutions was \$2,584.

Institutional Refunds to NCSEAA

When an Institution discovers that a grant was made to an ineligible student, monies are returned to the Institution's SCSF account to award another eligible student. After June 30 each year, the Institution submits electronic rosters detailing SCSF awards expended. Funds not expended as of June 30 must be returned to NCSEAA.

Private Colleges and Universities with Off-Campus Sites

Sixteen private institutions with off-campus instructional sites disbursed a combined total of \$2,857,341 to 2,679 recipients at off-campus sites. The off-campus site students constituted 16% of the 17,151 students awarded at all private institutions and 28% of the overall SCSF-recipients at the 16 institutions with off-campus sites. In 2009-2010, these students received 6% of the total SCSF funds awarded at all of the private colleges and universities, and 13% of the SCSF funds awarded at the 16 institutions with off-campus sites.
