SUBJECT: Report on Nursing

Background:

The Committee receives an annual report on Nursing that provides data on enrollment, degrees completed, and performance on the NCLEX examination which is the entry exam for being able to practice as a Registered Nurse.

Jurisdictional Authority:

The Board requires an annual report on the performance of nursing programs to determine if they are meeting Board policy on required performance levels.

Issues Involved:

One program, NCA&T State University has been put on warning by the NC Board of Nursing based on their performance in 2010.

The Chancellor at FSU voluntarily suspended admission to the Nursing Program at FSU in 2009 due to the performance of the graduates on the NCLEX. The two subsequent classes that have been taught out achieved NCLEX percentage passing scores of 88% and 100%. Chancellor Anderson seeks to restart the program with class sizes in the range of 25-30 students. He has sought Board of Nursing approval for restarting the program in 2011. As indicated in Chancellor Anderson's attached letter, he also seeks University of North Carolina endorsement for restarting the program.

Recommended Action: Since the Chancellor voluntary suspended admission, the Nursing Program at FSU still exists and does not need to be approved again. However, the President wants to consult with the committee about endorsing the restarting of the Nursing Program at FSU.

Nursing Enrollment and Degrees Conferred Report

UNC Board of Governors' Policy and Annual Reporting Requirements

In May 1990, the University of North Carolina Board of Governors adopted the following policy and performance standards for UNC nursing programs:

A requirement that the President will consider, jointly with the Chancellor, an evaluation of the leadership, faculty, admissions policies and the curriculum of any program whose graduates do not achieve for two consecutive years an annual passing rate of 85% for first-time writers, and, a requirement that the President will ask the Board to initiate program termination procedures for any program having a first-time passing rate of less than 75% for two consecutive years.

This report on enrollment and passing rates for licensure for the UNC nursing programs is prepared annually in accord with this Board policy. The UNC nursing students who took the NCLEX-RN exam for the first time in 2010 passed at an average rate of 90%. The state-wide passing rate was 88%. Five UNC campuses had passing rates at or above 90% (ECU, FSU, UNC-CH, UNCP, and WCU) and the same five were at or above 95%. FSU had the highest pass rate at 100 followed closely by WCU at 98% and ECU which had a rate of 97%. ECU produced the most students who were successful on the NCLEX, 260, followed by UNC-CH with 209.

All campuses are in compliance with the Board of Governors' standard. NCA&T which is at 61% was at 88% the previous year.

NC Board of Nursing Standards

The Board of Nursing has revised its standard for NCLEX passing rates for Nursing Programs. Previously the standard had been at 75%. If a program fell below that rate it was put on warning and was required to prepare and file with the Board of Nursing a plan to address the factors in the program that needed to be improved to bring the passing rate to the required level.

The Board of Nursing has adopted a new standard that requires NCLEX passing rates for first-time writers be at 95% of the national pass rate or greater based on a rolling three-year average. The Board is in the process of implementing this plan. For 2010, the requirement was 95% of the national pass rate or greater, using a three-year average pass rate for calendar years 2008, 2009, and 2010. That standard for 2010 first time writers is 83%.

In the case of FSU, the Chancellor suspended new enrollment in the Nursing Program in 2009 so it is not being measured by the Board of Nursing. However, the class graduating in 2010 had a 100% pass rate. FSU is in discussion with General Administration and the Board of Nursing about potentially restarting the program in 2011 with a small entering class. President Ross is prepared, subject to consultation with the Educational Planning Committee, to endorse FSU's request to the Board of Nursing to restart their Nursing Program with beginning classes in the 25-30 range.

While NCA&T's nursing program had progressed in recent years, for 2010 it had a passing rate of 61%. As indicated, the Board of Nursing uses a three-year rolling average. In the case of NCA&T that average was 80% which is below the Board of Nursing standard of 83%. This has resulted in the Board of Nursing placing the Nursing Program at NCA&T on warning status until 2011 data is available. In the meantime the program must provide a report to the Board of Nursing that includes a self-assessment and a corrective action plan by March 11, 2011. That report will also be provided to General Administration.

Nursing Programs

The Board of Governors approved a new program in Nursing at ASU for 2010. It starting up in the summer of 2010 bringing the total number of pre-licensure programs in the system to 12. (FSU has suspended new admissions to its program but graduated a senior class for 2010.) According to the North Carolina Board of Nursing, the total number of students taking the NCLEX exam in 2010 from UNC programs was 1,099.

UNC Nursing Enrollment

Following a statewide taskforce on nursing, the Board of Governors formed a Board Committee to review the recommendations of the task force and make recommendations for expanding the production of nursing graduates at various levels. Key among those recommendations was to set in motion the doubling of the number of pre-licensure nurses produced by UNC, the expansion of the Master of Nursing in Nursing Education to provide faculty for community colleges so they can expand their programs to produce more nurses, increase the level of education of nurses with an expansion of RN to BSN programs, and expansion of the production of doctorates in nursing to replenish the faculty ranks at UNC and where needed in the community colleges.

Since 2004, undergraduate enrollment in nursing programs has grown from 2,571 to 3,218, an increase of 25%; masters-level enrollment has grown from 924 to 1,544 or an increase of 67%; doctoral enrollment has grown from 66 to 116, an increase of 76%.

UNC Nursing Degrees Conferred

Overall all degree production has been on a definite upswing. At all levels, UNC institutions produced 1,178 nursing graduates in 2002-03, the base year for nursing expansion. That number increased to 2,231 in 2009-10, which was an increase of 89% over the base year. Prelicensures nursing production has grown to 1,112 from 686 in the base year an increase of 62%. RN to BSN programs which increase the educational level of nurses has grown from 290 in the base year to 683 in 2009-10 an increase of 136%. Masters programs in nursing provide advance practice nurses and nursing faculty. There the growth has been quite incredible from 195 in the base year to 401 in 2009-10 an increase of 106%. The economic climate may slow these increases, but UNC campuses have responded to the Nursing Task Force's call to increase nursing production by 25% by going well beyond that. UNC programs are prepared to expand further to meet the need for nursing graduates at all levels in NC.

Expanding Nursing Education in UNC

The North Carolina Institute of Medicine issued its report on Nursing, *Task Force on the North Carolina Nursing Workforce Report* in May 2004. The Board established a Committee on the Future of Nursing which made its report to the Board in November 2004. Both reports document the need for increasing the number of nurses in North Carolina and increasing the educational level of nurses. UNC campuses are well along in their enrollment expansion to achieve the ambitious goals approved by the Board of Governors to increase the production of nurses at every level.
