FORWARD

Pursuant to *Session Law 2007-323 SECTION 7.28.(d)*, we offer this School Connectivity Initiative (SCI) Report. In this report we provide an update on SCI activities beginning January 1, 2010 and ending January 1, 2011. The core provision for the SCI is specified as follows:

SECTION 7.28.(b) As recommended in the Joint Report on Information Technology, February 2007, the State Board of Education shall contract with an entity that has the capacity of serving as the administrator of the School Connectivity Initiative and has demonstrated success in providing network services to education institutions in the State. The funds appropriated in this act shall be used to implement a plan approved by the State Board of Education to enhance the technology infrastructure for public schools that supports teaching and learning in the classrooms. The plan shall include the following components:

- (1) A business plan with timelines, clearly defined outcomes and an operational model including a governance structure, personnel, e-Rate reimbursement, support services to LEA's and schools and budget;*
- (2) Assurances for a fair and open bidding and contracting process;*
- (3) Technology assessment site survey template;*
- (4) Documentation of how the technology will be used to enhance teaching in learning;*
- (5) Documentation of how existing State-invested funds for technology are maximized to implement the school connectivity initiative;*
- (6) The number, location and schedule of sites to be served in 2007-2008 and in 2008-2009; and*
- (7) Assurances that local school administrative units will upgrade internal networks in schools, provide technology tools, and support for teachers and students to use technology to improve teaching and learning.*

EXECUTIVE SUMMARY

The NC State Board of Education approved the School Connectivity Initiative *Implementation and Operating Plan* on Thursday, August 2, 2007. The SCI program was managed through the NC ITS Enterprise Project Management Office supervising projects that gained initial EPMO approval in September 2007. Within the SCI program were five individual projects addressing **Connectivity, Core Services, Collaboration, Organization, and Funding**. All five projects were completed in 2009 and produced the following deliverables:

- All 115 Local Education Agencies (LEAs) connected to MCNC's North Carolina Research and Education Network (NCREN)
- Establishment of Client Network Engineering Services for LEAs
- Establishment of E-Rate Filing Assistance Bureau
- Development of a Technology Master Plan
- Development of Governance and Funding Plans

The budget for FY2010 was \$20,824,415 and \$4,140,889 in FY2009 carry-over, totaling \$24,965,304. Expenses were \$18,390,616.36.

The FY2011 budget saw a \$1,000,000 reduction to recurring funds and a \$3,000,000 one time reduction. Thus the budget for FY2011 was \$17,886,226 and \$3,649,752 in FY2010 carry-over, totaling \$21,535,978. Expenses are in line with projections as of the date of this report.

For 2011, the School Connectivity Initiative plans to achieve the following goals:

- Work with MCNC, ITS, and LEAs to identify fiscally self-sustaining network-centric products and services such as content filtering, managed firewall, and directory services.
- Continue to proactively upgrade LEA bandwidth as demand trends upward.
- Further leverage Federal E-Rate dollars.
- Further assist LEAs in developing 2012 – 2014 strategic technology plans to support Future Ready, Ready Set Go, Race to the Top, and 1 to 1 program initiatives.
- Increase NCREN and E-Rate participation by, and support for, Charter Schools.
- Further assist LEAs in reducing the number of remaining schools not connected via fiber.
- Increase LEA Internet 2 participation.
- Further assist LEAs in deploying and maintaining wireless infrastructure.
- Continue to encourage creativity, innovation and collaboration (e.g. CeCTO).

PERFORMANCE OVERVIEW

The School Connectivity Initiative (SCI) has five areas of focus: **Connectivity, Support Services, Collaboration, Organization, and Funding.**

In 2010, the Initiative upgraded several of the 115 LEA NCREN connections based on usage, connected 14 Charter Schools to the NCREN network, witnessed a record 87% utilization of committed Funding Year 2008 E-Rate federal funds, observed a record \$70M in E-Rate federal funds committed in Funding Year 2009, assisted in a record \$96M in E-rate funds requested for Funding Year 2010, deciphered significant E-Rate rule changes and educated applicants in preparation for Funding Year 2011, provided network-related technical assistance to 80 plus LEAs and Charter Schools via expanded regional network assistance, and enabled 33 LEA participants to graduate from the highly successful Certified Educational Chief Technology Officer program.

1. ESTABLISH A SHARED EDUCATION BACKBONE THAT PROVIDES FOR K-12 CONNECTIVITY

- All 115 LEAs remain connected to NCREN, while 14 charters are now part of the education connectivity backbone.
- The SCI team continued to leverage statewide carrier contracts managed by ITS to accommodate the connection of the LEAs. NC ITS manages contracts with AT&T, Embarq, and Time Warner Cable. In general, AT&T is awarded connectivity business in their footprint, Embarq is awarded business in their footprint, and Time Warner Cable is awarded business in their footprint when it does not overlap with either AT&T or Embarq. For LEAs that do not have access to one of the state contract carriers, the SCI team continued established relationships with:

- To assist with implementation of services, as well as the ongoing need of information sharing, NCREN developed and deployed an initial online measurement and monitoring resource for K12 connectivity accessible at <http://tools.ncren.net/k12/>. A collaborative information portal for the K12 community has also been established and is available at <http://edspace.mcnc.org>. In addition a new K-12 forum was established at <https://www.mcnc.org/forums>.
- The SCI program also invested \$145,479 during 2010 to advance connectivity in specific LEAs and regions. These one-time distributions were aligned with the *School Connectivity Implementation and Operating Plan* approved by the NC State Board of Education in August 2007. In general, one-time distributions support investments in 3 categories: (1) service provider installation charges for (typically fiber-based) E-rate eligible services; (2) fiber builds to connect schools in areas where no comprehensive fiber services exist; (3) network infrastructure investments that support other state school technology programs (e.g., wireless support for 1to1 laptop pilots and deployments).
- The NCREN network performance has averaged 99.97% uptime across all LEA connections with very low latency, which continues to exceed expectations. LEA Technology Directors continue to communicate to SCI staff how impressed they have been with the NCREN staff in response times to network incidents as well as answering their questions.

2. PROVIDE AN OPT-IN **SERVICES** MODEL THAT INCLUDES A COMPREHENSIVE SET OF CORE SERVICES SUPPORTING RELIABLE, HIGH-BANDWIDTH CONNECTIVITY INCLUDING CENTRAL E-RATE AND ENGINEERING SERVICES AS WELL AS VALUE-ADDED NETWORK SERVICES OFFERED TO IMPROVE OPERATIONAL EFFICIENCY WITHIN AND AMONG LEAs.

- The E-rate Support Service is a function of the NC DPI Technology and Information Service area. In FY2010 the SCI team provided comprehensive training and support services to LEA's and charters via two regional E-rate specialists. The SCI team continues to hear positive feedback from LEAs and charters regarding the benefits of this service. We have also retained E-rate Central, a nationally recognized leader in E-rate consulting and services, to support our E-rate Support Service functions and act as a subject level expert under the management of the DPI Connectivity Services Manager/State E-rate Coordinator.
- With assistance from E-rate Central, the E-rate Support Service is exploring opportunities to leverage new FCC E-rate rules to expand centralized services and federal funding.

- The Network Consulting Service continued to assist public schools with technical engineering and consultation services. In 2011, a renewed statement of work for the Network Consulting Service is expected in the NC ITS-MCNC master agreement, *Client Network Engineering and Support Services*.
- In 2010, the two NC DPI Connectivity Services Network Analysts regionalized to further assist public schools with technical planning and consultation and to work closely with the support team represented by the statement of work with MCNC. LEAs support requests continue to trend upward for this service.
- NC DPI Connectivity Services continued to provide an expanded list of on demand and proactive services to LEAs and charters in 2010. In fact, demand for proactive services for LEAs and Charter Schools increased significantly in the latter half of the year with North Carolina's award of Race to the Top.

3. IMPLEMENT A COMMUNITY-DRIVEN **COLLABORATION** MODEL

In FY2010 the SCI team continued implementation of the SCI plan, including providing support for Cloud and other RttT initiatives. The SCI implementation requires collaboration with LEA and charter leadership teams, with service providers, and with policy makers. As such, the SCI team attended regional and state gatherings of technology directors, technicians, instructional technologists, superintendents, and legislators. During these gatherings SCI team members presented status reports, collected input, and collaborated on Cloud and RttT planning and marketing.

In addition to our participation in stakeholder gatherings around NC, the team built and maintains an information website that shares general project information, presentations, memoranda, information packets, and frequently asked questions.

4. DEVELOP AN EFFECTIVE AND EFFICIENT OPERATING ORGANIZATION

- The SCI team has developed a set of recommendations related to effective and efficient organization and governance. In short, the NC DPI Connectivity Manager serves as the advocate for the LEAs and charters, the business officer for the SCI budget, and the policy interface to oversight groups. The DPI Connectivity Manager is accountable to the NC State Board of Education and acts as agent of the SBE in providing required annual reporting to legislative oversight groups.
- With only few team members, the SCI team must continually seek maximum operational and service level efficiency through innovation and collaboration. The SCI team has leveraged cloud based application services to maximize communications and operations and has been able to share best practices with LEAs and charters.

5. SUSTAIN THE OPERATION LEVERAGING MYRIAD **FUNDING** RESOURCES INCLUDING STATE, FEDERAL, LOCAL, AND PRIVATE SECTOR.

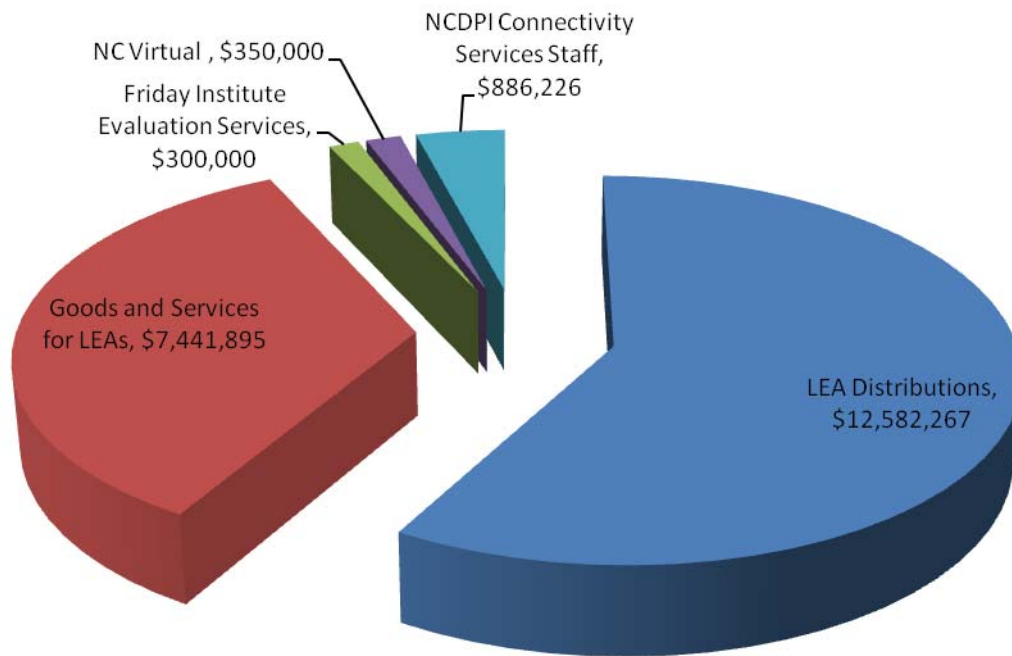
- The NC DPI provided FY2011 connectivity distributions to LEAs and Charter Schools in October and November 2010 respectively. As reference, the NC DPI provided FY2010 connectivity distributions to LEAs and Charter Schools in November 2009 and January 2010 respectively. The SCI team verified allotment amounts for all LEAs and Charter Schools and provided the DPI finance office with amounts based on a process vetted by the LEA community. The SCI team collected updated SCI MOU packets as part of the FY2011 distribution process. The MOU packet included:
 - An MOU defining the appropriate use and distribution terms to provide the “assurances” specified in the special provisions of SL2007-323 Section 7.28.(b) and 7.28.(c).
 - A letter of agency (LOA) allowing the state to file consortium E-rate documents
 - Instructions to provide contract and invoice materials for verification purposes
- In addition to the annual LEA and Charter School connectivity distributions, which help offset local costs, NC DPI bears the cost for a telecommunications circuit from each LEA to the MCNC Regional Connect (via AT&T, Embarq, Time Warner, etc.), a proportionate amount of costs associated with monitoring and maintenance of NCREN backbone components (e.g. routers, backbone circuits, etc.), Internet Access and support, as well as customer premise equipment (i.e. router) for each LEA and Charter School. In addition, NC DPI connectivity funds provide LEAs and Charter Schools with access to MCNC’s advanced client network engineering services (e.g. wired and wireless network assessments, risk analysis, etc.) and training. Currently NCDPI partners with NC ITS to apply for E-rate discounts on the telecommunications circuit charges. NCDPI is currently working in conjunction with E-rate Central, a nationally recognized E-rate Compliance Firm, to leverage new FCC rules regarding state networks, in order to increase the proportion of these goods and services receiving discounts.
- The NC DPI Connectivity Services and Instructional Technology Division (leveraging Title IID SEA), along with MCNC and the UNC School of Government, sponsor the highly successful Certified educational Chief Technology Officer’s program. This program graduated 33 LEA technology directors and their superintendents last year. This training program, the only one of its kind in the nation, helps ensure utmost utilization of North Carolina’s one of a kind network. In 2011 24 more LEAs and 3 Charter Schools will participate.
- The E-rate support service assisted many LEAs and Charter Schools with E-rate filing and audit processes, including a handful of successful appeals and averted denials or commitment adjustments. As mentioned previously, in Funding Year 2010, North Carolina applicants applied for a record \$96 million dollars in E-rate discounts for Telecommunications, Internet Access, Internal Connections, and Basic Maintenance of Internal Connections.

Total North Carolina Funding For Years Considered Still In Progress – January 1, 2011

The Universal Service Administrative Company (USAC) released Funding Year 2010 Waves 28-32¹ Funding Commitment Decision Letters (FCDLs) during the month of December. These waves included over \$4.4 million in funding commitments for approved Priority 1 (Telecommunications Services and Internet Access) and Priority 2 (Internal Connections and Basic Maintenance of Internal Connections) requests for North Carolina public schools.² A total of (1598) Priority 1 and (364) Priority 2 requests were filed by North Carolina applicants in Funding Year 2010. Thus far (1314) Priority 1 and (118) Priority 2 requests have been funded, (66) Priority 1 and (4) Priority 2 requests have been denied, and (218) Priority 1 and (242) Priority 2 requests remain pending.

The Universal Service Administrative Company (USAC) released Funding Year 2009 Waves 75-77 Funding Commitment Decision Letters (FCDLs) during the month of December. These waves did not include any funding commitments for North Carolina public schools.

Funding Year 2008 disbursements now represent 87% of committed funds. This matches the previous utilization high-water mark set way back in Funding Year 2000.

On December 15, 2010 the FCC Wireline Competition Bureau (WCB) issued additional information listing the effective dates for each of the proposals adopted in the September 28, 2010 Sixth Report and Order. Many of the proposed rule changes go into effect January 3, 2011, exactly 30 days after publication in the Federal Register. In addition, the WCB included a list of frequently asked questions clarifying a subset of applicant and service provider inquiries stemming from the publication of the Sixth Report and Order.³

One clarification in particular was timely for the subset of Public Charter Schools in North Carolina that choose not to submit a Technology Plan to the state. According to the FAQ, *"...the Commission will not enforce state technology plan requirements, but encourages applicants to meet all local requirements associated [with] the technology planning process to ensure the best use of E-rate funds."* Sans this clarification USAC may have denied Priority 1 funding to those public charter schools without a state approved technology plan.

Last, but not least, approximately 90 applications were submitted or postmarked prior to the December 20th deadline for the FCC's EDU2011 pilot program on wireless Internet access services for off-campus student use. Three North Carolina school districts hurdled into the "shovel-ready" competition including Onslow County, Lee County, and Thomasville City.⁴

Since the inception of the E-rate Program North Carolina applicants have utilized \$473,433,613.53 in total Priority 1 and Priority 2 requests.
