## **REPORT ON 2014 SUMMER FTE**

In accordance with Senate Bill 402, Section 10.4(c) of S.L. 2013-360, the North Carolina Community College System hereby submits its report on the 2014 summer enrollment funding to the Joint Legislative Education Oversight Committee.

Section 10.4(b) of S.L. 2013-360 amended G.S. 115D-5 adding language to authorize enrollment funding for "technical education, health care, developmental education, and STEM-related courses... including the summer term". The newly authorized enrollment funding resulted in 8,721 FTE for the 2014 summer semester. Eighty-eight percent (88%) of this enrollment occurred in technical education, health care, and STEM-related courses (Tier 1A/Tier 1B courses). FTE in developmental courses represented 12% of this enrollment. A summary of the FTE distribution among the fifty-eight colleges is attached. To provide a sense of context, community colleges served 182,464 FTE students in curriculum programs during the 2013-14 regular academic year.
