



NC Community College System Office Report on Activities of the Liaisons

Submitted to the Office of State Budget & Management, the Joint Legislative Commission on Governmental Operations, the Joint Legislative Education Oversight Committee, and the House and Senate Appropriations Committees

April 1, 2015

BACKGROUND

Section 4.1 of S.L. 2014-18, NC Economic Development Partnership Modifications, requires the North Carolina Community College System Office to designate at least one representative from a community college or the Community College System Office to serve as a liaison in each Collaboration for Prosperity Zone for the community college system, the community colleges in the zone, and other educational agencies and schools within the zone. Section 4.3(b)(2) requires the North Carolina Community College System Office to report to OSBM and the General Assembly on the activities of the liaisons, specifically any activities undertaken that resulted in enhanced collaboration and coordination with other governmental agencies, improved planning on use of educational resources, and improved administrative efficiencies.
