#### **Background**

The Licensure Section of the Department of Public Instruction (DPI) is responsible for examining credentials and issuing professional educator's licenses that qualify individuals to seek employment as teachers, administrators and other special service personnel in North Carolina public schools on behalf of the State Board of Education. The following information is provided to meet the reporting requirement of Session Law 2015-241, Section 8.40, reprinted below:

By October 15, 2016, DPI shall report to JLEOC regarding the operation of the educator licensure processing system, including implementation of the electronic processing of applications. The report shall include at least the following information:

- (1) The estimated processing time from receipt of application to issuance of a license in each category of licensure, including initial licensure, lateral entry licensure, renewal of a license through the automated electronic system, renewal of a license manually, out-of-state licensure reciprocity, and advanced degrees. The report shall include comparative data related to the processing of licenses in each licensure category prior to August 1, 2015.
- (2) The schedule of licensure fees and services, including any changes in the prior year made to the fee amounts or services for which fees are charged.
- (3) Any backlog of the processing of applications existing at the time of the report, including the categories of licensure experiencing such backlog.
- (4) Data for the following from the prior year:
  - a. Number of applications received and transactions completed.
  - b. Number of newly licensed educators.
  - c. Number of licensure renewals.
  - d. Demographic information regarding currently licensed educators.
  - e. Number of licenses issued by area of licensure and type of license.
  - f. Number of initial licenses for the following:
    - 1. Graduates of educator preparation programs.
    - 2. Lateral entry.
    - 3. International educators.
    - Out-of-state educators seeking reciprocity.

#### Transitioning to the new Licensure Automated System

On August 1, 2015, DPI launched a new Licensure Automated System, a software as a service platform operated by MicroPact, Inc., to facilitate the processing of educator licenses in North Carolina. The system enhanced the existing process in many ways, particularly by automating the collection of licensure artifacts and providing end-users with enhanced visibility into the status of their licensure submissions.

The applications processed through the new licensure system can be identified and accurately timed through the system. Data on applications processed in the prior licensure system were not able to be tracked in a manner that could generate accurate processing times as required in legislation. As such, we estimated the old processing times by taking a sample of applications and manually calculating the days between submission and completion.

During the transition to the new system, local education agencies, charter schools, and other applicants continued to submit manual applications. The volume of the non-automated applications significantly impacted processing times. To establish an accurate processing time baseline, we have reported below the times used applications processed from July 1, 2016 to September 30, 2016.

The chart below outlines the changes in application processing for the data contained in this report.

#### **Licensure Application Processing**

#### Prior to August 1, 2015 (manual)

- Application is received by Licensure. Payments are manually summarized and deposited.
- 2) Application is manually scanned into system.
- 3) Application is manually labeled as pending licensure specialist review.
- 4) Specialist Review Process:
  - a) Is application complete?
     No. Applicant notified. New information is submitted. New information is scanned into system and manually matched to application. Application returns to pending specialist review.
- 5) If complete, the application is approved and license is printed
- 6) License mailed to applicant

Note: all numbers referenced in this report are based on samples of applications received. The old licensure system had no reporting matrix to enable accurate estimates of processing times.

## After August 1, 2015 (automated)

- 1) Applicant opens an online application. Once opened, the application is counted in new system.
- 2) Application moves through statuses in the system as needed\*:
  - a) Pending Educator Applicant has not finalized and submitted the application.
  - b) Pending Payment Applicant has submitted; but, the application fee has not been paid.
  - Pending IHE (Institute of Higher Education) Application requires action/recommendation from an approved North Carolina degree granting institution
  - d) Not Recommended by IHE Applicant has not completed the requirements of the degree granting institution and cannot be recommended for licensure.
  - LEA Review Application requires approval or documentation from the hiring entity.
  - f) Pending Legal Applicant identified that they have a legal issue on application and application is forwarded to NC State Board of Education legal team for review.
  - g) Pending DPI Application is ready for review by a licensure specialist. All numbers in this report reflect applications in this status that have been submitted to DPI for review.
- Once the application has completed all the required checks and reviews, the license is formatted and immediately available for the applicant to download.

<sup>\*</sup>Note: applications can move between statuses based on findings during review by a licensure specialist.

<sup>\*\*</sup>Note: The out-of-state applications are submitted by individuals without the assistance of LEAs or colleges and universities and are frequently submitted without all of the required documentation to issue the license upon a single review. As such, the Licensure Section of DPI is frequently having to hold the incomplete application until the additional documentation can be obtained from another state agency or out-of-state college or university. The time it takes the applicant to gather the documentation can vary and be quite lengthy.

## Licensure Backlog

Total number of applications in the Licensure System as of October 7, 2016, was 13,692. Of those applications, 6,319 were in the queue to be reviewed and approved by a licensure specialist.
