## Report to the Joint Legislative Education Oversight Committee NC Works Career Coach Program – G.S. 115D-21.5(d)(2)

### **Overview**

G.S. 115D-21.5(d)(2) authorizes the North Carolina Community College System to administer the NCWorks Career Coach Program. This program places community college Career Coaches in high schools to assist students with determining career goals and identifying community college programs that would enable students to achieve these goals.

### **Program Summary**

In September 2015, the General Assembly passed the provision authorizing the North Carolina Community College System to implement the NCWorks Career Coach Program. On October 30, 2015, the State Board of Community Colleges approved the application process for the grant that included an advisory committee with representation from business/industry, the North Carolina Department of Public Instruction, the North Carolina Division of Workforce Solutions, and the North Carolina Community College System Office. As outlined in the legislation, community college boards of trustees and local school administrative units within the service areas of the community colleges were eligible to jointly apply for available NCWorks Career Coach funding. Following a successful 2015-17 implementation, the 2017-2019 grant announcement was disseminated to colleges on July 21, 2016, and the selection process was completed on January 20, 2017. With the adoption of S.L. 2017-57 on June 28, 2017, the State Board of Community Colleges approved the funding of additional Career Coaches on July 21, 2017, permitting the funding of eligible colleges and partners not previously selected.

The 2015-17 granting period implemented 28 Career Coaches hired by 14 community colleges serving students at 22 Local Educational Agencies (LEA). (See Attachment A, Tables 2a & 3a.)

The 2017-19 granting period began with 27 applications (See Attachment A, Table 2b) and 14 community colleges selected (See Attachment A, Tables 3b.1 and 3b.2). With the additional funding, previously unselected but eligible applications were funded resulting in 17 community colleges receiving either initial or additional funds for coaches. Therefore, a total of 28 community colleges hired 55 coaches serving students at 42 LEAs (See Attachment A, Table 1).

Ongoing professional development provided with support of and in consultation with North Carolina workforce partners includes the following topics and opportunities:

- Student Outreach
- Career Advising
- Career Development Facilitator Certification
- Career Pathway Curriculum Development
- Data Collection and Analysis

On January 20, 2017, the State Board approved allocations totaling \$1,000,000 for fiscal years 2017-18 and 2018-19. The funding, at that point, was not sufficient to support all qualified requests. In the 2017 legislative session, the General Assembly increased the appropriation for Career Coaches. The additional 2017-18 and 2018-19 funding allocations will allow the support of 29 additional coaches of the qualified requests. With these additional allocations, a total of 28 colleges will have one or more career coach positions.

### **Program Efforts To Date**

**Students Counseled Annually:** Coaching and career advisement is defined as meeting in a one-on-one session(s) with a career coach, discussing students' career interests, identifying opportunities for deeper exploration and immersion, and developing a guided pathway towards appropriate course selection related to the students' career interests.

Number of students annually counseled (advised) by Career Coaches in 2016-17:

- Total number of students counseled (advised) in 2016-17: 12,149

#### Impact:

Initial impact includes information regarding pathways available to students and the subsequent enrollment in those pathways. The first year of potential impact on enrollment is the 2017-18 academic year. Enrollment and pathway offerings in the 2016-17 academic year will be the established baseline data and information used to assess the impact of the program for future data collection points.

### **Pathway Enrollment:**

#### **Total Pathway Enrollment 2016-17:**

During the 2016-17 academic year, career pathway enrollment for high school (Career Technical Education) totaled 55,521 students; community college (Career & College Promise/Career Technical Education) totaled 3,512 students; and community college (Career & College Promise/College Transfer Program) totaled 3,309 students.

#### **Assessing Pathway Offerings:**

Partnerships will be asked to complete a survey of pathway offerings as compared to the previous year beginning with the 2017-18 academic year. The survey will include requested connection to local workforce needs.

#### Attachment B

### Legislative Authorization: G.S. 115D-21.5(d)(2). NCWorks Career Coach Program

**SECTION 10.14.(a)** Article 2 of Chapter 115D of the General Statutes is amended by adding a new section to read:

§ 115D-21.5. NCWorks Career Coach Program.

- (a) Purpose. There is established the NCWorks Career Coach Program to place community college career coaches in high schools to assist students with determining career goals and identifying community college programs that would enable students to achieve these goals.
- (b) Memorandum of Understanding. The board of trustees of a community college and a local board of education of a local school administrative unit within the service area of the community college shall enter into a memorandum of understanding for the placement of career coaches employed by the board of trustees of the community college in schools within the local school administrative unit. At a minimum, the memorandum of understanding shall include the following:
  - (1) Requirement that the community college provides the following:
    - a. Hiring, training, and supervision of career coaches. The board of trustees may include a local board of education liaison on the hiring committee to participate in the decision making regarding hiring for the coach positions.
    - <u>b.</u> Salary, benefits, and all other expenses related to the employment of the career coach. The coach will be an employee of the board of trustees and will not be an agent or employee of the local board of education.
    - <u>c.</u> Development of pedagogical materials and technologies needed to enhance the advising process.
    - d. Criminal background checks required by the local school administrative unit for employees working directly with students.
    - <u>e.</u> Agreement that, while on any school campus, the career coach will obey all local board of education rules and will be subject to the authority of the school building administration.
  - (2) Requirement that the local school administrative unit provides the following to career coaches:
    - <u>a.</u> Access to student records, as needed to carry out the coach's job responsibilities.
    - <u>b.</u> Office space on site appropriate for student advising.
    - <u>c.</u> Information technology resources, including, but not limited to, Internet access, telephone, and copying.
    - <u>d.</u> Initial school orientation and ongoing integration into the faculty and staff community.
    - <u>e.</u> Promotion of school-wide awareness of coach duties.

- <u>f.</u> Facilitation of coach's access to individual classes and larger assemblies for the purposes of awareness-building.
- (c) Application for NCWorks Career Coach Program Funding. The board of trustees of a community college and a local board of education of a local school administrative unit within the service area of the community college jointly may apply for available funds for NCWorks Career Coach Program funding from the State Board of Community Colleges. The State Board of Community Colleges shall establish a process for award of funds as follows:
  - (1) Advisory committee. Establishment of an advisory committee, which shall include representatives from the NC Community College System, the Department of Public Instruction, the NCWorks initiative located in the Department of Commerce, and at least three representatives of the business community, to review applications and make recommendations for funding awards to the State Board.
  - (2) Application submission requirements. The State Board of Community Colleges shall require at least the following:
    - <u>a.</u> Evidence of a signed memorandum of understanding that meets, at a minimum, the requirements of this section.
    - <u>b.</u> Evidence that the funding request will be matched dollar-fordollar with local funds. Matching funds may come from public or private sources.
  - (3) Awards criteria. The State Board of Community Colleges shall develop criteria for consideration in determining the award of funds that shall include the following:
    - <u>a.</u> Consideration of the workforce needs of business and industry in the region.
    - <u>b.</u> Targeting of resources to enhance ongoing economic activity within the community college service area and surrounding counties.
    - <u>c.</u> Geographic diversity of awards.
- (d) Annual Report.
  - (1) The board of trustees of a community college that employs one or more career coaches shall report annually to the State Board of Community Colleges on implementation and outcomes of the program, including the following information:
    - <u>a.</u> Number of career coaches employed.
    - <u>b.</u> Number of local school administrative units served and names of schools in which career coaches are placed.
    - <u>c.</u> Number of students annually counselled by career coaches.
    - <u>d.</u> Impact of career coaches on student choices, as determined by a valid measure selected by the State Board of Community Colleges.

- (2) The State Board of Community Colleges shall report annually no later than October 1 to the Joint Legislative Education Oversight Committee on the following:
  - <u>a.</u> A compilation of the information reported by the board of trustees of community colleges, as provided in subdivision (1) of this subsection.
  - <u>b.</u> Number and names of partnership applicants for NC Works Career Coach Program funding.
  - <u>c.</u> Number, names, and amounts of those awarded NC Works Career Coach Program funding.

**SECTION 10.14.(b)**. The State Board of Community Colleges shall begin accepting applications for available funds for NC Works Career Coach Program funding no later than December 15, 2015, and shall select the initial recipients for the award of funds no later than February 22, 2016.

**SECTION 10.14.(c)** The funds appropriated under this act to the Community Colleges System Office for the 2015-2017 fiscal biennium to match non-State funds to implement the NCWorks Career Coach Program shall only be used for salary and benefits for NCWorks Career Coaches.
